CIRCULAR

Sub: Lodgments of convicts in Semi Open Jail.

In the coordination meeting held on 12.11.2025, it has been brought to the notice of the Competent Authority that Semi Open Jail and Open Jail located in Tihar premises have been declared partially habitable and dangerous respectively by the PWD authorities. Necessary repairs / renovations are currently underway in the open jail premises to make it habitable.

A plethora of Court cases have been filed in the Hon'ble Delhi High Court by the prisoners who were selected for their lodgment in Semi Open Jail but could not be shifted to Semi Open Jail because of aforesaid reasons.

In order to wade through the critical situation following modalities have been worked out:

1. The sanctioned capacity of Semi Open Jail and Open Jail is as under:

- 2. The Open Jail prisoners be immediately shifted to habitable portion of Semi Open Jail building so as to avoid any causalities.
- 3. The 39 convicts selected for their lodgment in Semi Open Jail be immediately shifted to Mandoli premises.
- 4. Superintendent Jail No.14 who is also Incharge of Semi Open Jail, Mandoli premises is directed to make appropriate arrangements for their lodgment/allotment of labour, communication facilities, healthcare facilities etc.
