The promotion is subject to the condition that the Head of the office concerned must ensure that no disciplinary proceedings/criminal proceedings are pending or no penalty is in operation against the promotee officials before relieving them to take up their new assignment on promotion in the light of instructions contained in DOPT O.M. No.22011/4/91-Estt(A) dated 14/09/1992 and other related OMs issued from time to time. The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well. Further, an undertaking in this regard shall also be obtained from the officials concerned by office concerned before relieving to their new assignment on promotion.

Further, the officials promoted may exercise option for fixation of pay in terms of FR 22 I(a)(i) within one month from the date of promotion or appointment as Dy. Superintendent Grade - I. However, the officers who have already been granted financial upgradation under Assured Career Progression Scheme/Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.


