His/her engagement as consultant shall not be considered as a case of re-employment".

13. The engagement of retired Sr. Assistant, Assistant Section Officer and above shall be subject to sound health and subsequent approval of the Competent Authority under GNCTD.

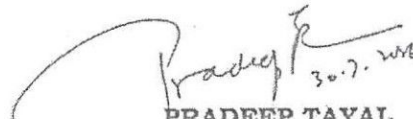

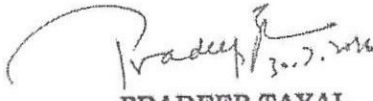
