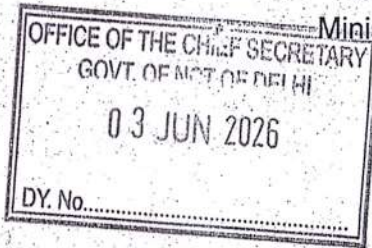

A Vacancy Circular of even no. dated 01.01.2026 was issued seeking application of willing and eligible officers for 02 (two) posts of Deputy Director General (DDG) (in the revised pay matrix level-14 of the CCS(RP) Rules, 2016) on deputation basis in Narcotics Control Bureau (NCB) under the Ministry of Home Affairs. The same was also published in Employment News dated 17-23 Jan 2026. Now, the number of vacancies has increased to 03 (three). Accordingly, it is proposed to seek fresh applications to fill up 03 (three) vacancies of Deputy Director General in NCB on deputation basis.
