The Board met on 14.12.2022 at 05:00 PM to consider the cases for premature release of convicts undergoing Life sentence in pursuance to the meeting notice issued by Dy. Secretary (Home), GNCT of Delhi vide reference No. F.18/102/2003/HG/2022-II/3401-3406 dated 12.12.2022.

A total of 61 numbers of cases of life convicts were placed before the Board (55 fresh cases, 01 deferred case of previous meeting and 05 cases on the directions of Hon'ble Supreme Court/High Court of Delhi).

All the cases placed before the Board were discussed at length and considered in the light of parameters as mentioned in Delhi Prison Rules, 2018. Factors like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed, nature & gravity of crime, perversity and brutality of the offence committed by the convict, whether the convict is casual or habitual offender, his/her antecedents, apprehension expressed by his/her family members, propensity of committing crime again or not, his lodgment, parole/furlough availed and conduct during parole/furlough as well as in Jail, prospects of post release rehabilitation, family responsibilities and socio-economic condition of the convict's family, possibility of the convict returning as a useful member of the society etc., were considered by the Board and accordingly its recommendations were given.

### The Board was informed about the following:-

- (I) That the recommendation of the Board for premature release of the convicts shall be placed before the Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi for consideration and approval.
- (II) Case (s) falling under Section 435 Cr.P.C. is subject to the consultation with Central Government (MHA), Govt. of India (e.g. CBI cases etc.), if any.

(III) That the custody period undergone by the convict i.e. expired portion of sentence in the fresh cases placed before the Board has been computed as on 30.06.2022.

### 01. MOHD. AHAD @ GOPAL S/O MOHD. ASHIQ— AGE-35 YRS.

Mohd. Ahad @ Gopal S/o Mohd. Ashiq is undergoing life imprisonment in case FIR No. 57/2008, U/S 302/34 IPC, P.S. S. P. Badli, Delhi for murder of a person by bullet shot on stopping the thieves.

#### The convict has undergone:

Imprisonment of 14 years, 04 months & 06 days **in actual** and 16 years, 08 months & 09 days **with remission**. He has availed Parole 05 times and Furlough 07 times.

#### **Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also opposed his premature release in the meeting.

#### Recommendation by Social Welfare Department:

The Social Welfare Department, Delhi has not opposed his premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, the Board felt that some more clarification & details are required regarding the status of the co-accused of the convict and therefore it was decided by the Board to **DEFER** the case of convict Mohd. Ahad @ Gopal S/o Mohd. Ashiq for the next meeting.

#### 02. AJEET SINGH S/O SH. BRIJ PAL SINGH — AGE-49 YRS.

Ajeet Singh S/o Sh. Brij Pal Singh is undergoing life imprisonment in case FIR No. 175/2001, U/S 364-A/343/120-B/34 IPC, P.S. New Ashok Nagar, Delhi for kidnapping of a person for ransom.

#### The convict has undergone:

Imprisonment of 14 years & 09 days **in actual** and 17 years, 07 months & 09 days **with remission**. He has availed Interim Bail 02 times, Parole 07 times and Furlough 16 times.

#### **Recommendation by Police:**

The Delhi Police has highly opposed his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also opposed his premature release in the meeting. Hometown Police has not opposed his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has not opposed for premature release of the convict in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, the Board felt that some more clarification & details are required regarding release of the co-accused of the convict in the previous meeting and therefore it was decided by the Board to **DEFER** the case of convict Ajeet Singh S/o Sh. Brij Pal Singh for the next meeting.

#### 03. SUBHASH CHANDER S/O SH. HARI CHAND — AGE-59 YRS.

Subhash Chander S/o Sh. Hari Chand is undergoing life imprisonment in case FIR No. 175/2001, U/S 364-A/307/343/120-B/353/34 IPC & 27 Arms Act, P.S. New Ashok Nagar, Delhi for kidnapping of a person for ransom.

#### The convict has undergone:

Imprisonment of 14 years, 01 month & 16 days **in actual** and 16 years, 09 months & 25 days **with remission**. He has availed Interim Bail 03 times, Parole 07 times and Furlough 09 times. He Jumped Interim Bail w.e.f. 28.06.2011 to 11.02.2013.

#### Recommendation by Police:

The Delhi Police has **highly opposed** his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also **not recommended** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has not opposed for granting premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the manner in which the offence was committed, gravity and perversity of the crime, un-satisfactory jail conduct in view of jumping Interim Bail and 02 cases were registered against the convict during that period, shown non-reformative attitude etc., the Board unanimously **REJECTS** the premature release of convict Subhash Chander S/o Sh. Hari Chand at this stage.

#### 04. ASHISH @ DANGER S/O SH. DESH RAJ — AGE-32 YRS.

Ashish @ Danger S/o Sh. Desh Raj is undergoing life imprisonment in case FIR No. 41/2008, U/S 302/34 IPC, P.S. Chandni Chowk, Delhi for murder of a person by knife blow over past enmity.

#### The convict has undergone:

Imprisonment of 14 years, 03 month & 15 days **in actual** and 17 years, 11 months & 08 days **with remission**. He has availed Parole 06 times and Furlough 16 times.

#### **Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. However, the Deputy Commissioner of Delhi Police (Crime) has stated that in view of the discussions held in the meeting, his premature release may be considered.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has **recommended** the case of convict for premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, convict having no previous criminal history, satisfactory jail conduct during incarceration, no adverse report during parole/furlough availed, showing reformative attitude etc., the Board unanimously **RECOMMENDS** premature release of convict Ashish @ Danger S/o Sh. Desh Raj.

# <u>05. ASHISH NANDWANA S/O LATE SH. ASHOK NANDWANA — AGE-36 YRS.</u>

Ashish Nandwana S/o Late Sh. Ashok Nandwana is undergoing life imprisonment in case FIR No. 190/2008, U/S 302/201/34 IPC, P.S. H. N. Din, Delhi for murder of a lady with stab like injuries.

#### The convict has undergone:

Imprisonment of 14 years, 01 month and 28 days **in actual** and 16 years, 09 months & 25 days **with remission**. He has availed Parole 08 times and Furlough 10 times.

#### **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has not opposed the case of the convict for his premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances under which the crime was committed i.e. murder of a lady with some sharp edge material, the gravity and perversity of the crime, un-satisfactory jail conduct having multiple punishments, shown non reformative attitude etc., the Board unanimously **REJECTS** the premature release of convict Ashish Nandwana S/o Late Sh. Ashok Nandwana at this stage.

#### <u>06. ASHOK @ LALA S/O SH. ANANT RAM — AGE-41 YRS.</u>

Ashok @ Lala S/o Sh. Anant Ram is undergoing life imprisonment in case FIR No. 358/1999, U/S 302 IPC, P.S. Ashok Vihar, Delhi for murder of a person by sharp edged object for taking revenge.

#### The convict has undergone:

Imprisonment of 14 years, 05 months & 01 day **in actual** and 17 years, 11 months & 25 days **with remission**. He has availed Parole 06 times and Furlough 13 times.

#### **Recommendation by Police:**

The Delhi Police has not recommended his premature release in its report. However, the Deputy Commissioner of Delhi Police (Crime) has stated that in view of the discussions held in the meeting, his premature release may be considered.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has **recommended** the premature release of the convict in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, consistent satisfactory jail conduct throughout incarceration, the convict having no previous criminal history, no adverse report during parole/furlough availed, having shown orientation towards reclaiming as a useful member of the society etc., the Board unanimously **RECOMMENDS** premature release of convict Ashok @ Lala S/o Sh. Anant Ram.

#### 07. BHISHAM @ CHINTOO S/O SH. VED PRAKASH— AGE-43 YRS.

After taking into account all the facts and circumstances under which the crime was committed i.e. kidnapping & murder of 08 years old child for ransom, gravity, perversity and heinousness of the crime, un-satisfactory conduct in jail in view of multiple punishments, late surrendered from furlough, possibility of committing such crime again etc., the Board unanimously **REJECTS** premature release of convict Bhajan Singh @ Gulla S/o Sh. Balvinder Singh at this stage.

# 48. GANESH PANDURANG SUTAR S/O SH. PANDURANG SHANKAR SUTAR — AGE-46 YRS.

Ganesh Pandurang Sutar (Ex. CRPF Constable) S/o Sh. Pandurang Shankar Sutar is undergoing life imprisonment in case FIR No. 146/2005, U/S 302 IPC, PS. Tuglak Road, Delhi for murder of his colleague/departmental witness by bullet shot.

#### The convict has undergone:

Imprisonment of 16 years, 10 months and 12 days **in actual** and 20 years, 06 months and 20 days **with remission**. He has never availed I. Bail, Parole or Furlough.

#### **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has stated that in view of the discussions held in the meeting, his premature release may be considered.

# **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case **may be recommended** for premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. throughout satisfactory jail conduct during incarceration, no previous involvement in any other criminal case etc., the Board unanimously **RECOMMENDS** premature release of convict Ganesh Pandurang Sutar S/o Sh. Pandurang Shankar Sutar.

#### 49. MUKESH KUMAR S/O SH. MUNNA LAL— AGE-37 YRS.

Mukesh Kumar S/o Sh. Munna Lal is undergoing life imprisonment in case FIR No. 545/2005, U/S 302/364/376 IPC, P.S. Okhla Ind. Area, Delhi for committed rape and murder of a 03 years minor girl.

# The convict has undergone:

Imprisonment of 17 years and 18 days **in actual** and 20 years, 03 months and 11 days **with remission**. He has availed Parole 05 times and Furlough 10 times.

# **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has **strongly opposed** his premature release in the meeting.

# **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has neither recommended nor opposed his premature release in its report. However, Hometown has **not recommended** his premature release in its report

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, the manner in which the offence was committed i.e. rape and murder of a 03 years minor girl, the gravity, perversity & heinousness of the crime, unsatisfactory jail conduct in view of punishments, shown non-reformative attitude, possibility of committing crime again etc., the Board unanimously **REJECTS** premature release of convict Mukesh Kumar S/o Sh. Munna Lal at this stage.

#### 50. NAVEEN AHUJA S/O SH. ASHOK AHUJA— AGE-47 YRS.

Naveen Ahuja S/o Sh. Ashok Ahuja is undergoing life imprisonment (sentence of Death reduced to life imprisonment, which shall mean the rest of his life in Death sentence No. 04/2010 and Criminal Appeal No. 1435/2010 by the Hon'ble High Court of Delhi on dated 20.11.2012) in case FIR No. 165/2005, U/S 302 IPC & 25/27 A. Acts, P.S. Kapashera, Delhi for murder of his wife & 02 minor children.

#### The convict has undergone:

Imprisonment of 16 years, 11 months & 12 days **in actual** and 20 years and 15 days **with remission**. He has availed parole 10 times and furlough 19 times.

#### **Recommendation by Police:**

The Delhi Police has **strongly opposed** his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case may be recommended for granting premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances and the manner/ nature of crime committed i.e. murder of his wife & 02 minor children, having un-satisfactory conduct in jail in view of punishment, gravity, perversity and heinousness of the crime etc., the Board unanimously **REJECTS** premature release of convict Naveen Ahuja S/o Sh. Ashok Ahuja at this stage.

#### 51. VIJAY KUMAR @ VIJAY S/O SH. RAM JI LAL— AGE-38 YRS.

Vijay Kumar @ Vijay S/o Sh. Ram Ji Lal is undergoing life imprisonment in case FIR No. 56/2002, U/S 302/380/34 IPC, P.S. Keshav Puram, Delhi for murder of 02 persons (truck driver & cleaner).

# The convict has undergone:

Imprisonment of 20 years, 04 months & 06 days **in actual** and 20 years, 04 months and 09 days **with remission**. He has availed parole 09 times and furlough 16 times.

#### **Recommendation by Police:**

The Delhi Police and Hometown Police both have **not recommended** his premature release in their reports. The Deputy Commissioner of Delhi Police (Crime) has also **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case may be recommended for premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances under which the offence was committed particularly the manner of committing double murder i.e. of truck driver & cleaner, gravity and perversity of the crime, objection by Police authorities etc., the Board unanimously **REJECTS** premature release of convict Vijay Kumar @ Vijay S/o Sh. Ram Ji Lal at this stage.

# FRESH CASE COVERED UNDER RULE 1252 OF DELHI PRISON RULES, 2018 (INVESTIGATED BY CBI) (Case No. 52)

#### 52. RAVINDER RANA S/O SH. KANWAR LAL— AGE-40 YRS.

Ravinder Rana S/o Sh. Kanwar Lal (Ex. CISF Personnel) is undergoing life imprisonment in case FIR/CBI No. RC-1(S)/2005/SCU-1, U/S 302/307 IPC & 27 Arms Act, P.S. C.B.I., Delhi for committed murder of his 02 colleagues (CISF personnel) by gun shots.

# The convict has undergone:

Imprisonment of 17 years, 05 months & 10 days **in actual** and 20 years and 03 days **with remission**. He has availed parole 08 times and furlough 09 times.

#### **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case may be recommended for granting premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case under which the crime was committed as the convict being personnel of disciplined paramilitary force had murdered two of his colleagues (CISF personnel) by gun shots while posted at Indian Embassy, Kathmandu, Nepal, in view of gravity, perversity and nature of the crime, objection by Police authorities etc., the Board unanimously **REJECTS** premature release of convict Ravinder Rana S/o Sh. Kanwar Lal at this stage.

# FRESH CASE COVERED UNDER RULE 1253 OF DELHI PRISON RULES, 2018 (Case No. 53)

# 53. SANT RAM @ SADHU RAM S/O SH. BHAGWAN DASS— AGE-48 YRS.

Sant Ram @ Sadhu Ram S/o Sh. Bhagwan Dass is undergoing life imprisonment in case FIR No. 66/2006, U/S 376/506 IPC, P.S. Kanjhawala, Delhi for committing rape with his own Daughter.

#### The convict has undergone:

Imprisonment of 12 years, 04 months and 26 days **in actual** and 14 years, 10 months and 16 days **with remission**. He has availed Furlough 05 times. He jumped furlough w.e.f. 05.08.2017 and was re-arrested on 15.04.2021.

#### **Recommendation by Police:**

The Delhi Police has **highly opposed** his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case **may not be recommended** for premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case as the convict had committed a heinous and perverse crime i.e. rape of his own daughter and gave her threat, un-satisfactory jail conduct, jumped furlough and re-arrested, no positive reformation shown by him etc., the Board unanimously **REJECTS** premature release of convict Sant Ram @ Sadhu Ram S/o Sh. Bhagwan Dass at this stage.

# FRESH CASE COVERED UNDER THE STATE OF HARYANA V/s JAGDISH (Case No. 54)

#### 54. BHAGWATI PRASAD S/O SH. RAM SNEHI— AGE-62 YRS.

Bhagwati Prasad S/o Sh. Ram Snehi is undergoing life imprisonment in case FIR No. 697/1997, U/S 302/498-A/34 IPC, P.S. Nangloi, Delhi for committing murder of his daughter-in-law for demand of dowry.

# The convict has undergone:

Imprisonment of 14 years, 02 months and 19 days **in actual** and 18 years, 01 month and 13 days **with remission**. He has availed Parole 06 times and Furlough 17 times.

#### **Recommendation by Police:**

The Delhi Police has **no objection** his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has stated that in view of the discussions held in the meeting, his premature release **may be considered.** 

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case **may be recommended** for granting premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances i.e. throughout satisfactory jail conduct during incarceration, no adverse report during parole/furlough availed, no previous involvement in any other criminal case, having shown orientation towards reclaiming as a useful member of the society etc. the Board unanimously **RECOMMENDS** premature release of convict Bhagwati Prasad S/o Sh. Ram Snehi.

# (Case No. 55)

#### 55. NAUSHAD S/O MOHD. RAFIQ @ RAFIQUE— AGE-47 YRS.

This case has been put up in compliance to the order dated 01.08.2022 in W.P. (Crl.) No. 1696/2022 and order dated 01.06.2022 in W.P. (CRL.) No. 1310/2022 passed by the Hon'ble High Court of Delhi in the matter of Naushad V/s State (NCT of Delhi), wherein it was directed " the petition be treated by the respondent as a representation before the Sentence Review Board in view of the fact that the petitioner is seriously ill".

Naushad S/o Mohd. Rafiq @ Rafique is undergoing life imprisonment in case FIR No. 136/2006, U/S 302/307/449/34 IPC, P.S. Welcome, Delhi for committing murder of 02 persons on the issue of love marriage. Being double murder, this case falls under rule 1252 of Delhi Prison Rules, 2018 i.e. those requiring 20 years of imprisonment including remission but not less than 14 years of actual imprisonment

#### The convict has undergone:

Imprisonment of 14 years, 04 months and 09 days **in actual** and 15 years, 08 months and 24 days **with remission**. He has availed I. Bail 03 times, Parole 12 times and Furlough 05 times.

#### **Recommendation by Police:**

The Delhi Police has strongly opposed/not recommended his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also opposed his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that this case may be recommended for granting premature release in its report.

#### **Conclusion:**

After taking into account all the facts, circumstances of the case and in view of Rule of 1252 of DPR, 2018 that required 20 years with remission, the present case is not eligible. However, in view of the direction of the Hon'ble Court a detailed discussion about convict's illness was held in the meeting and it is ordered to ascertain the latest medical condition of the convict to confirm whether this case falls under the category of "terminally ill". Therefore, the Board decided to **DEFER** the case of convict Naushad S/o Mohd. Rafiq @ Rafique for the next meeting.

# COVERED UNDER RULE 1252 OF DELHI PRISON RULES, 2018 (Case No. 56)

# 56. DEVENDER PAL SINGH BHULLAR S/O LATE SH. BALWANT SINGH — AGE-54 YRS.

# (PRESENTLY IN JUDICIAL CUSTODY AT CENTRAL JAIL AMRITSAR)

Devender Pal Singh Bhullar S/o Late Sh. Balwant Singh is undergoing life imprisonment in case FIR No. 316/1993, U/S 302/307/120-B/34 IPC & 3/4/5 of TADA Act, P.S. Parliament Street, Delhi for Terrorist Activity/murder by explosion in a car parked outside Raisina Road on 11.09.1993, in which 09 persons were killed.

#### The convict has undergone:

Imprisonment of 24 years, 09 months and 17 days in actual as per Commutation Roll dated 10.09.2022 received from Superintendent, Central Jail, Amritsar, Punjab.

#### **Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also opposed his premature release in the meeting. The Commissioner of Police, Amritsar City in its report mentioned that there is no objection to the local Police upon premature release of the convict.

#### **Recommendation by Social Welfare Department:**

As per the report of the District Probation Officer, Amritsar neither the premature release of the convict is recommended nor opposed.

#### **Conclusion:**

A detailed discussion was held with regard to the premature release of the convict in view of longevity of incarceration, his medical condition, report of Commissioner of Police Amritsar, social investigation report of District Probation Officer, Amritsar. The manner and nature of the crime committed by the convict was also discussed at length. After a long discussion, it has been desired by the members that the documents/report/response of Social Welfare Department, Delhi, specific recommendation of the District probation officer, Amritsar and specific clarification on the involvement of cases of the convict in reference to the police verification report dated 17.03.2022 of Special Cell, Delhi, should be called on the next turn of the meeting to consider while deciding the premature release of the convict. Since no consensus could be arrived among the members of the Board with the available documents, hence, it was decided that the case **may be deferred** for the next meeting of the convict Devender Pal Singh Bhullar S/o Late Sh. Balwant Singh.

#### (Case No. 57)

# 57. MOHD. FAROOQ @ GAINDA S/O SH. MOMINUDDIN- AGE 46 YRS.

# (BANGLADESH NATIONAL)

This case has been put up in compliance to the order dated 20.10.2022 in W.P. (Crl.) No. 2476/2022 passed by the Hon'ble High Court of Delhi in the matter of Md. Faruque Alwander @ Farukh @ Genda V/s Govt. of NCT of Delhi and Anr., wherein it was directed "to the respondents with respect to the consideration of the petitioner's prayer for remission and premature release at an early date and dispose it of within 03 months".

Mohd. Farooq @ Gainda S/o Sh. Mominuddin is undergoing life imprisonment in case FIR No. 254/2003, U/S 302/34 IPC, P.S. Seema Puri, Delhi for committing murder of a person (police informer) by shooting with a country made pistol.

# The convict has undergone:

Imprisonment of 17 years, 11 months and 03 days **in actual** and 23 years, 05 months and 04 days **with remission**. He has never availed Interim Bail, Parole or Furlough.

#### **Recommendation by Police:**

The Delhi Police has **not recommended** his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also **opposed** the premature release of the convict in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has stated that this case **may not be recommended** for premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the manner under which the crime was committed, gravity and perversity of the crime, convict having previous criminal history/involvement in other criminal cases, un-satisfactory jail conduct in view of punishment, objection by the police authorities, shown non-reformative attitude etc., the Board **REJECTS** premature release of convict Mohd. Farooq @ Gainda S/o Sh. Mominuddin at this stage.

# (Case No. 58)

# 58. JAHANGIR @ EKKA @ IBRAHIM S/O ABDUL HAKIM — AGE-44 YRS. (BANGLADESH NATIONAL)

This case has been put up in compliance to the order dated 05.05.2022 in W.P. (Crl.) No. 1014/2022 passed by the Hon'ble High Court of Delhi in the matter of Jahangir @ Ikka @ Ibrahim V/s Govt. of NCT of Delhi & Ors., wherein it was directed "that the representation dated 10.03.2021 submitted by the petitioner for his premature release, the Competent Authority shall decide the representation within six weeks from today".

#### Sentence-1:

Jahangir @ Ekka @ Ibrahim S/o Abdul Hakim is undergoing life imprisonment in case FIR No. 254/2003, U/S 302/34 IPC & 25 A. Act, P.S. Seema Puri, Delhi for committing murder of a person (police informer) by shooting with a country made pistol. The convict has undergone imprisonment of 15 years, 08 months and 09 days in actual and 20 years, 05 months and 04 days with remission. He has never availed Interim Bail, Parole or furlough.

#### Sentence-2:

He is also serving life sentence in another case FIR No. 41/2011, U/S 395/397 IPC, P.S. Ashok Vihar, Delhi for committing dacoity on gun point in a house. The convict has undergone imprisonment of 11 years, 06 months & 17 days **in actual** and 15 years and 03 months and 22 days **with remission**.

**Note:** The Hon'ble High Court of Delhi in W.P.(Crl.) No.1400/2016 vide order dated 09.08.2016 observed that "the  $2^{nd}$  sentence is to be superimposed upon the  $1^{st}$  but that would not mean that if in one remission or commutation is granted it would enure for both"

#### **Recommendation by Police:**

The Delhi Police has neither recommended nor opposed his premature release in its report. However, the Deputy Commissioner of Delhi Police has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has **not recommended** his premature release in its report.

### **Conclusion:**

After taking into account all the facts and circumstances under which the crime was committed, gravity and perversity of the crime, convict having criminal history and also serving life sentence in another case of robbery, not lost propensity to commit crime again, objection by Police and Social Welfare Department etc., the Board **REJECTS** premature release of convict Jahangir @ Ekka @ Ibrahim S/o Abdul Hakim at this stage.

# (Case No. 59)

### 59. RADHEY SHYAM S/O SH. RAMDIN — AGE-40 YRS.

This case has been put up in compliance to the order dated 27.07.2022 in Criminal Appeal No. 2485/2014 passed by the Hon'ble Supreme Court of India in the matter of Radhey Shyam V/s State of NCT of Delhi, wherein it was observed "that the appellant has already completed 16 years of actual sentence, the District Legal Services Authority and the concerned prison authorities shall render complete assistance to the appellant to prefer an appropriate application seeking commutation/remission..."

Radhey Shyam S/o Sh. Ramdin is undergoing life imprisonment in case FIR No. 34/2006, U/S 302 IPC, P.S. Tilak Nagar, Delhi for committing murder of his wife.

#### The convict has undergone:

Imprisonment of 16 years, 07 months and 22 days **in actual** and 18 years, 11 months and 25 days **with remission**. He has availed Parole 04 times and Furlough 07 times. He jumped Emergency Parole w.e.f. 22.02.2020 and was rearrested on 10.09.2021.

#### **Recommendation by Police:**

The Delhi Police has **highly opposed** for his premature release in its report. The Deputy Commissioner of Delhi Police (Crime) has also **opposed** the premature release of the convict in the meeting. Hometown Police has **not recommended** his premature release in its report.

#### Recommendation by Social Welfare Department:

Report from both the Social Welfare Department, Delhi and Hometown have not been received.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case under which the offence was committed, the gravity and perversity of the crime, unsatisfactory jail conduct in view of jail punishments, jumped emergency parole and re-arrested, shown non-reformative attitude and possibility of committing crime again etc., the Board **REJECTS** premature release of convict Radhey Shyam S/o Sh. Ramdin at this stage.

# (Case No. 60) 60. AMJAD ALI MUGHAL S/O MOHD. ANWAR — AGE-63 YRS. (PAKISTAN NATIONAL)

This case has been put up in compliance to the order dated 31.08.2022 in W.P. (Crl.) No. 1577/2022 passed by the Hon'ble High Court of Delhi in the matter of Amjad Ali Mughal V/s The State (Govt. of NCT) of Delhi, wherein it was directed "let the outcome of SRB meeting to be held in the month of October be placed as Additional Status Report for consideration, next date of hearing in the matter is fixed for 18.01.2023".

Amjad Ali Mughal S/o Sh. Mohd. Anwar is undergoing life imprisonment in case FIR No. 79/1994, U/S 3(1), 3(3), 3(5) & 5 of TADA (P) Act, P.S. Gokul Puri, Delhi for indulging in Terrorist Act and conspiracy, preparing to commit terrorist acts and collect ammunition and explosive substances.

#### The convict has undergone:

Imprisonment of 28 years, 06 months, 03 days **in actual** and 34 years, 11 months and 08 days **with remission**. He has not availed Interim Bail, Parole or Furlough (Being Pakistan National).

# **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has recommended his premature release in its report. Hometown has verified nationality and forwarded for further favourable action (By High Commission of Pakistan, New Delhi).

#### **Conclusion:**

After taking into account all the facts and circumstances of the case under which the offence was committed, a detailed discussion was held among the Board members about the manner i.e. convict had come to India with the mission of killing innocent persons for which he had specialized training in Pakistan about the use of bombs and other killing devices, hence, considering the fact of conspiring and preparing to commit terrorist acts and to collect mass explosives for the purpose being the member of terrorist organization which works for disintegration of India, possibility of committing similar crime again etc., the Board **REJECTS** premature release of Amjad Ali Mughal S/o Sh. Mohd. Anwar at this stage.

# 61. PARVEEN KOLI @ DEEPAK @ PAPPI @ SUNIL S/O SH. AMBA PRASAD— AGE-40 YRS.

Parveen Koli @ Deepak @ Pappi @ Sunil S/o Sh. Amba Prasad is undergoing life imprisonment in case FIR No. 356/2007, U/S 302/120-B/34 IPC, P.S. Hauz Qazi, Delhi for murder of a person by firearm injuries/bullet shots. Convict's Appeal No. 647/2020 is pending before the Hon'ble High Court of Delhi.

#### The convict has undergone:

Imprisonment of 14 years & 06 months in actual and 15 years with remission. He has never availed Interim Bail, Parole or Furlough.

#### **Recommendation by Police:**

The Deputy Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

### **Recommendation by Social Welfare Department:**

Report from Social Welfare Department, Delhi has not been received.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the manner in which the offence was committed, gravity and perversity of the crime, convict's involvement in other criminal cases, un-satisfactory jail conduct in view of multiple punishments, seems that convict has not lost his potential to commit crime again and shown non-reformative aptitude etc., the Board unanimously **REJECTS** premature release of convict Parveen Koli @ Deepak @ Pappi @ Sunil S/o Sh. Amba Prasad at this stage.
