PREMATURE RELEASE OF LIFE CONVICTS IN THE MEETING HELD  
UNDER THE CHAIRMANSHIP OF THE HON'BLE HOME MINISTER OF  
DELHI AT 04:00 PM ON 06.01.16, AT DELHI SECRETARIAT, NEW  
DELHI- 110002.**

A meeting of the **Sentence Reviewing Board** (hereinafter referred to as **Board**) was held on **06<sup>th</sup> of JANUARY 2016** in the Conference room, 7<sup>th</sup> Level "A" Wing, Delhi Secretariat under the **CHAIRMANSHIP OF HON'BLE HOME MINISTER, NCT OF DELHI.**

On **06th of JANUARY 2016 at 4:00 P.M.,** the cases of **ONE HUNDRRED -100 life convicts (34 Fresh, 54 rejected of previous meetings and 12 deferred cases)** in terms of **SRB Guidelines, Hon'ble Supreme Court order dated 02.12.2015 and Hon'ble Supreme Court order dated 22.03.2010 (State of Haryana Vs. Jagdish)** were taken up by the **Sentence Reviewing Board** for recommending premature release on merits. Such premature releases are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi. SRB Guidelines issued by the Government of NCT of Delhi vide Order No.F.18/5/94/HOME (G)/3825 dated 16.07.2004 and other related records were taken into consideration. Cases were discussed in the light of parameters like conduct of the prisoner during confinement in jail and parole/furlough, his/her age, the circumstances under which the

crime was committed, nature & gravity of crime, his/her antecedents, prospects of rehabilitation, family responsibilities etc. Recommendations of Jail, Chief Probation Officer, and Police were also taken into consideration while reviewing each case for premature release.

## FRESH CASES

### 1. ABDUL HAMID @ MILLU S/O ABDUL MAJID---- AGE - 44 Yrs.

The convict is undergoing life imprisonment in case FIR No.50/2001, U/S-302 IPC Police Station- New Seelam Pur, Delhi, for committing murder of one Kasim as he was not returning money borrowed.

The convict has already undergone an actual sentence of 14 years, & 06 days excluding the remission as on 30<sup>th</sup> of November 2015. He has undergone a total period of 16years, 01 months & 01 days including the remission earned by him. He has availed parole 06 times and furlough 02 times, nothing adverse has been reported against him during parole/furlough. He had participated in educational programme held in jail. His work and conduct has been satisfactory in jail.

The convict is presently lodged in **SEMI OPEN JAIL** since 02.01.2015 and pursuing work at **TEA COURT**. His work and conduct has been satisfactory in jail and Semi Open Jail. His three co-accused have been released in the last Board meeting held on 09.10.2015.

The Police report has not been received in spite of multiple messages, thus presumed to be not opposed, but opposed in the meeting. The Chief Probation Officer has recommended the premature release of said convict.

After taking into account the overall facts of the case, the satisfactory work and conduct in jail & recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

### 2. MD. ASLAM @ ASLAM S/O MD ISHLAMUDDIN---- AGE -47 Yrs.

*(This case is taken up before the Sentence Reviewing Board in terms of Hon'ble Supreme Court order dated 22.03.10)*

The convict is undergoing life imprisonment in case FIR No.174/92, U/S- 302/307/397IPC, & 25 Arms Act Police Station Hazrat Nizamuddin , Delhi, for committing murder during robbery.

The convict has already undergone an actual sentence of 14 years, 01 month & 24 days excluding the remission as on 30<sup>th</sup> of November 2015. He has undergone a total period of 16



years, & 09 days including the remission earned by him. He has availed parole 06 times and furlough 06 times. Nothing adverse has been reported against him during parole/furlough. His work and conduct in jail has been satisfactory.

The Police has opposed the premature release of said convict in its report as well as in the meeting as the convict is BC of P.S. Lahori Gate and involved in other cases of 15 police stations. The Chief Probation Officer has recommended the premature release of the convict.

After taking into account the overall facts of the case, non recommendation of police and his involvement in multiple cases, the Board **REJECTS** the premature release of the convict.

**3. AJAY KUMAR @ RAJU S/O GANGA RAM---- AGE – 42 Yrs.**

The convict is undergoing life imprisonment in case FIR No.177/2001, U/S-364-A368/34 IPC, Police Station Khajuri Khas, Delhi, for kidnapping a boy of aged 09 years for ransom.

The convict has already undergone an actual sentence of 14 years, 02 months & 18 days excluding the remission as on 30<sup>th</sup> of November 2015. He has undergone a total period of 17 years & 24 days including the remission earned by him. He has availed parole 04 times and furlough 03 times. Nothing adverse has been reported against her during parole/furlough. He had participated in spiritual courses held in jail. His work and conduct has been satisfactory.

Ld. Addl. Session Judge opposed the premature release in view of nature & gravity of crime. The Delhi Police did not oppose premature release in its report but opposed in the meeting in view of heinous nature of crime committed by him. Home town police has not opposed her premature release. The Chief Probation Officer of Delhi recommended the premature release of convict. The report from Chief Probation Officer of Home Town is not received in spite of multiple messages, thus presume not opposed.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**4. GIRISH CHAND S/O BHAWANI PRASAD----AGE – 54 Yrs.**

The convict is undergoing life imprisonment in case FIR, No.177/2001, U/S-364-A368/34 IPC, Police Station Khajuri Khas, for kidnapping a boy of aged 09 years.

The convict has already undergone an actual sentence of 14 years, 02 month & 10 days excluding the remission as on 30<sup>th</sup> of November 2015. He has undergone a total period of 17years, 02 months & 03 days including the remission earned by him. He has availed parole 06 times. Nothing adverse has been reported against him during parole. He had participated in spiritual courses held in jail.

The Ld. Addl. Session Judge opposed the premature release in view of nature & gravity of offence. The Police report has not been received in spite of multiple messages, thus presumed to be not opposed, but opposed in the meeting in view of heinous nature of crime. The Chief Probation Officer has recommended his case for premature release.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**5. UMA SHANKAR SHANKAR S/O SATYA NARAYAN---- AGE – 46 Yrs.**

The convict is undergoing life imprisonment in case FIR No.325/91, U/s-302/201/34 IPC , Police Station Kotwali, Delhi, for committing murder of one Bhure Lal.

The convict has already undergone an actual sentence of 14 years, 02 month & 14 days excluding the remission as on 30<sup>th</sup> of November 2015. He has undergone a total period of 17 years, 05 months & 10 days including the remission earned by him. He has availed parole 02 times and furlough 12 times. Nothing adverse has been reported against him during parole/furlough.

The convict is presently lodged in **SEMI OPEN JAIL** since 07.05.14 and pursuing work at **TEA COURT** His work and conduct has been satisfactory in jail and Semi Open jail.

The Police has not opposed premature release of the convict in its report but opposed in the meeting in view of gravity of offence. The Chief Probation Officer has recommended his case for premature release.

After taking into account the overall facts of the case, satisfactory work and conduct and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**6. BAL KISHAN S/O KASHMIRI LAL—AGE-51 Yrs.**

The convict is undergoing life imprisonment in case FIR No.117/2001, U/s-302/34 IPC, Police Station Kanjhawala, Delhi, for committing murder, along with his accomplices.

The convict has already undergone an actual sentence of 14 years, 01 month & 25 days excluding the remission as on 30th of November 2015. He has undergone a total period of 17 years, 08 months & 15 days including the remission earned by him. He has availed parole 02 times and furlough 12 times. Nothing adverse has been reported against him during parole/furlough.

The convict is presently lodged in **SEMI OPEN JAIL** since 07.05.14 and pursuing work at **TEA COURT**. His work and conduct has been satisfactory in jail and Semi Open Jail. His co-accused has been released in the last Board meeting held on 09.10.2015.

The Police has opposed premature release in its report as well as in the meeting in view of gravity of offence. The Chief Probation Officer has recommended his case for premature release.

After taking into account the overall facts of the case, recommendations of Probation Officers and satisfactory jail conduct, the Board **RECOMMENDS** the premature release of the convict.

**7. DINESH KUMAR S/O VEER PAL SINGH---- AGE – 36 Yrs.**

The convict is undergoing life imprisonment in case FIR No.361/01, U/S-364-A/120-B IPC, Police Station Kotwali, Delhi, for kidnapping one boy Deepanshu aged 05 years for ransom.

The convict has already undergone an actual sentence of 14 years, 02 month & 09 days excluding the remission as on 30th of November 2015. He has undergone a total period of 17 years, 04 months & 06 days including the remission earned by him. He has availed parole 05 time and furlough 05 times. Nothing adverse has been reported against him during parole/furlough. His work and conduct has been satisfactory in jail. He had participated in spiritual course held in jail.

Ld. Addl. Session Judge opposed premature release in view of nature and gravity of offence. The Delhi Police has opposed premature release of the convict in its report as well as in the meeting in view of nature and gravity of offence, law & order problem and parole jump of his co-accused. The home town police has also opposed the premature release of the convict in view of possibility of indulging in crime. The Chief Probation Officer, Delhi has recommended his



case for premature release. Report from home town Chief Probation officer is awaited in spite of multiple messages, hence presumed not opposed.

After taking into account the overall facts of the case, non recommendations of police, the Board **REJECTS** the premature release of the convict.

**8. KAMAL KISHORE S/O TULSI RAM---- AGE --38 Yrs.**

The convict is undergoing life imprisonment in case FIR No.08/01 U/s-302/201 IPC, Police Station Prasad Nagar, Delhi, for committing murder of his wife due to some domestic disputes.

The convict has already undergone an actual sentence of 14 years, 01 month & 13 day excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 04 months & 13 days including the remission earned by him. He has availed parole 05 times and furlough 06 times. He has surrendered late by 04 days from parole on 02 occasion and 02 days from furlough. His work and conduct has been satisfactory in jail. He has participated in educational and spiritual courses held in jail.

The local Police has opposed premature release of the convict in its report as well as in the meeting in view of law & order problem. The Chief Probation Officer has recommended his case for premature release.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Police and Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**9. LALIT @ BILLU S/O RAM SINGH @ RAN SINGH---- AGE--44**

The convict is undergoing life imprisonment in case FIR No.528/97, U/s-302/323/149/34 IPC, Police Station Patel Nagar, Delhi, for committing murder of one Yogender due to old enmity.

The convict has already undergone an actual sentence of 14 years, 01 months & 29 days excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 02 months & 16 days including the remission earned by him. He has availed parole 05 times and furlough 15 times. Nothing adverse reported against him during parole/furlough. He had participated in educational and spiritual courses held in jail. His work and conduct has been satisfactory. His co-accused(brother) has been released in the last Board meeting held on 09.10.2015.



The local Police has not opposed premature release of the convict in its report but opposed in the meeting in view of gravity of offence. The Chief Probation Officer has recommended his premature release.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Police and Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**10. MD MUKEEM S/O MD ISHAQ----38 YRS.**

The convict is undergoing life imprisonment in case FIR No.864/01, U/s-302 IPC Police Station Sultan Puri, Delhi, for committing murder of one lady Kamla Devi over some property disputes.

The convict has already undergone an actual sentence of 14 years, 02 months & 15 days excluding the remission as on 30th of November 2015. He has undergone a total period of 16 years, 06 months including the remission earned by him. He has availed paroles 04 times and furlough 14 times. Nothing adverse has been reported against him. His conduct has not been satisfactory in jail.

The Police has opposed premature release of the convict in its report as well as in the meeting in view of gravity of offence and being dangerous criminal. The Chief Probation Officer has recommended his premature release

After taking into account the overall facts of the case, recommendations of Chief Probation Officer, satisfactory work and conduct in jail, the Board **RECOMMENDS** the premature release of the convict.

**11. MUNNA KHAN S/O NISSAR KHAN----AGE--37 Yrs.**

The convict is undergoing life imprisonment in case FIR No.94/01, U/s-302 IPC Police Station Trilok Puri, Delhi, for committing murder of his wife over personal disputes.

The convict has already undergone an actual sentence of 14 years, 03 month & 06 days excluding the remission as on 30th of November 2015. He has undergone a total period of 17 years, 10 month & 15 days including the remission earned by him. He has availed parole 05 time and furlough 03 times. Nothing adverse reported against him. He also participated in educational courses held in jail.



He is presently lodged in **SEMI OPEN JAIL** since 23.11.2015 and pursuing work at Safai Punja. His work and conduct has been satisfactory in jail and Semi Open jail.

The Delhi Police opposed premature release of the convict in its report as well as in the meeting in view of gravity of offence. Report from home town police is awaited inspite of multiple messages, thus presumed not opposed. The Chief Probation Officer, Delhi has recommended his premature release. The report from home town Chief Probation Officer is not received inspite of multiple messages, thus presumed not opposed.

After taking into account the overall facts of the case, recommendations of Chief Probation Officer, Delhi and satisfactory work and conduct in jail & Semi Open jail, the Board **RECOMMENDS** the premature release of the convict.

**12. MANISH @ SONU S/O SHEESH PAL ----AGE – 32 Yrs.**

The convict is undergoing life imprisonment in case FIR No.791/01, U/s-302/452 IPC, Police Station Nangloi for committing murder of a lady Kranti over a trivial issue.

The convict has already undergone an actual sentence of 14 years, 02 months & 19 day excluding the remission as on 30th of November 2015. He has undergone a total period of 15 years, 11 months & 01 day including the remission earned by him. He has availed parole 01 time and furlough 09 times. Nothing adverse has been reported against him during parole/furlough. He had participated in educational and spiritual course held in jail.

He is presently lodged in **SEMI OPEN JAIL** since 16.03.2015 and pursuing work at TEA COURT. His work and conduct has been satisfactory in jail as well as in Semi Open Jail.

The police has not opposed premature release of the convict in its report, but opposed in meeting in view of gravity of offence. The Chief Probation Officer has recommended his premature release.

After taking into account the overall facts of the case, satisfactory work and conduct in jail as well as in Semi Open jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**13. MD NAZIM S/O MD. UJER----AGE –36Yrs.**

The convict is undergoing life imprisonment in case FIR No.381/2001, U/s-302IPC, Police Station Sarai Rohilla for murder of a lady Firdosh as he wanted to marry her forcibly.

The convict has already undergone an actual sentence of 14 years, 01 months & 28 day excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 02 months & 07 day including the remission earned by him. He has availed parole 02 times and furlough 03 times. Nothing adverse has been reported against him during parole/furlough. He participated in spiritual courses held in jail. The work and conduct of convict in jail has been satisfactory.

The Ld. Additional Session Judge opposed the premature release in view of nature and gravity of offence. The Police opposed his premature release in its report as well as in the meeting in view of law & order problem and gravity of offence. Home town police has also opposed his premature release in view of possibility of escape. The Chief Probation Officer has recommended his premature release. Home town probation report is awaited inspite of multiple messages, thus presumed not opposed.

After taking into account the overall facts of the case, the satisfactory work and conduct in jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**14. ABID S/O NAZIR----- AGE - 37 Yrs.**

The convict is undergoing life imprisonment in case FIR No.169/2000, U/s-302 IPC, Police Station Seema Puri, for committing murder of a person due to his enmity.

The convict has already undergone an actual sentence of 15 years, 04 months & 22 days excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 06 months & 15 days including the remission earned by him. He has availed parole 01 time and furlough 01 time. Nothing adverse has been reported against him during parole. His work and conduct has been satisfactory in jail. He participated in vocational and spiritual courses held in jail.

The Police opposed his premature release in its report as well as in the meeting in view of gravity of offence and nature of crime. The Chief Probation Officer has recommended his premature release.



After taking into account the overall facts of the case, satisfactory work and conduct in jail, recommendations of Chief Probation Officer, the Board **RECOMMENDS** premature release of the convict.

**15. SAHIL @ ISRAIAL S/O BABUDDIN---- AGE -36 Yrs.**

The convict is undergoing life imprisonment in case FIR No.169/2000, U/s-302 IPC & 25 Arms Act P.S. Seema Puri, for committing murder of a person due to his enmity.

The convict has already undergone an actual sentence of 15 years, 04 months & 22 days excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 04 months & 16 days including the remission earned by him. He has availed parole 06 times and furlough 12 times. Nothing adverse has been reported against him during parole/furlough. He had participated in spiritual courses held in jail.

Presently he is lodged in **SEMI OPEN JAIL** since 28.06.2013 and pursuing work at Safai Punja. His work and conduct has been satisfactory.

The Delhi Police opposed premature release of the convict in its report as well as in the meeting in views of possibility of escape. The home town police report is awaited inspite of multiple messages, thus presumed not opposed. The Chief Probation Officer, Delhi has recommended his premature release. Report from residential Chief Probation officer is awaited, in spite of multiple messages, thus presumed as not opposed.

After taking into account the overall facts of the case and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**16. SAHID @ LAMBU S/O SAKIR ALI---- AGE - 35 Yrs.**

The convict is undergoing life imprisonment in case FIR No.169/2000, U/s-302 IPC & 25 Arms Act, Police Station Seema Puri, Delhi, for committing murder of a man due to his personal enmity.

The convict has already undergone an actual sentence of 15 years, 04 month & 23 day excluding the remission as on 30<sup>th</sup> January 2015. He has undergone a total period of 17 years, 09 month & 23 days including the remission earned by him. He has availed parole 02 times and furlough 04 times. Nothing adverse has been reported against him during parole/furlough. He participated in vocational and spiritual courses held in jail.

He is presently lodged in **SEMI OPEN JAIL** since 12.01.2015 and pursuing work at Tea Court. His work and conduct has been satisfactory in jail and Semi Open Jail.

The local Police opposed premature release of the convict in its report as well in the meeting in view of possibility of committing offence. Report from his home town Police has not been received in spite of multiple messages, thus presumed as not opposed. The Chief Probation Officer, Delhi has recommended his premature release. Social investigation report from his home town has not been received in spite of multiple messages, thus presumed as not opposed.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**17. SANJAY TANWAR S/O RAI SINGH---AGE – 43 Yrs.**

The convict is undergoing life imprisonment in case FIR No.81/2001, U/s-302 IPC, Police Station Naraina, Delhi, for committing murder of his wife over a domestic disputes.

The convict has already undergone an actual sentence of 14 years, 00 month & 10 days excluding the remission as on 30th of November 2015. He has undergone a total period of 18 years, 03 months & 10 days including the remission earned by him. He has availed parole 02 times and furlough 13 times. Nothing adverse has been reported against him during parole/furlough. He had participated in educational, vocational and spiritual courses held in jail.

The convict is presently lodged in **SEMI OPEN JAIL** since 06.11.2015 and pursuing work at **PHQ CANTEEN**. His work and conduct is has been satisfactory in jail and Semi Open Jail.

The Police opposed premature release of the convict in its report as well as in the meeting in view of law & order problem and peace and tranquillity in the area. The Chief Probation Officer, Delhi has recommended premature release of the convict.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Chief Probation Officer, the Board **RECOMMENDS** the premature release of the convict.

**18. MD SULTAN S/O MD SALEEM---AGE – 42 Yrs.**

The convict is undergoing life imprisonment in case FIR No.771/99 & 773/99, U/s-302 /392/397/34 IPC P.S. Sultan Puri, Delhi, for committing robbery and murder of a auto driver.

The convict has already undergone an actual sentence of 16 years, 04 months & 00 days excluding the remission as on 30th of November 2015. He has undergone a total period of 20 years, 03 months & 25 days including the remission earned by him. He has availed parole 02 times and furlough 03 times. Once he surrendered late by 03 days from furlough due to death of his wife. Nothing adverse reported against him during parole /furlough except late surrender. He has participated in educational and vocational course held in jail. His work and conduct in jail has been satisfactory.

The Delhi Police opposed premature release of the convict in its report as well as in the meeting in view of gravity of offence and being dangerous criminal. Police report from his home town is awaited inspite of multiple messages, thus presumed as not opposed. The Chief Probation Officer, Delhi has recommended his case. Report from home town Chief Probation officer is awaited inspite of multiple messages, thus presumed as not opposed.

After taking into account the overall facts of the case, satisfactory work and conduct in jail and recommendations of Chief Probation Officer, Delhi the Board **RECOMMENDS** the premature release of the convict.

**19. SATBIR SINGH S/O RATTAN SINGH---- AGE --39 Yrs.**

The convict is undergoing life imprisonment in case FIR No.31/99, U/s-302/396/34 IPC, Police Station Bara Hindu Rao, Delhi, for committing murder of Rekha Sharma while committing dacoity.

The convict has already undergone an actual sentence of 16 years, 09 month & 23 day excluding the remission as on 30th of November 2015. He has undergone a total period of 20 years, 01 months & 13 days including the remission earned by him. He has availed parole 07 times and furlough 03 times. The convict is undergoing life imprisonment in case FIR No.260/2001 &414/2001 U/S-302 IPC & 25 A. Act P.S. Roop Nagar & Kamla Nagar, Delhi, for committing murder of one Ajay due to his personal grudge.

The convict has already undergone an actual sentence of 14 years, & 15 days excluding the remission as on 30th of November 2015. He has undergone a total period of 16 years, 11 months & 10 days including the remission earned by him. No parole/furlough availed by him. Jail conduct of the convict is not satisfactory in view of his 06 jail punishments.

He has undergone a total period of 22 years, 02 days & 00 days including remission earned by him. He has availed parole 04 times and furlough 05 times. Nothing adverse reported against him during parole/furlough. His work and conduct has been satisfactory in jail.

The Police opposed his premature release in its report as well as in the meeting in view of nature and gravity of offence and strong apprehension of harming victim and witness. Home town police has also opposed his premature release. Probation Officer, Delhi has recommended his premature release. Home town report is awaited in spite of multiple messages, thus presumed not opposed.

After taking into account totality of facts, satisfactory work and conduct in jail and recommendations of Probation Officer, the Board **RECOMMENDS** the premature release of convict.

**5. SUSHIL SHARMA S/O INDERMANI ---AGE--55 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 486/95, U/S-302/201 IPC P.S. Cannaught Place, Delhi for committing murder of his wife due to her strained relations and alleged infidelity.(TANDOOR CASE)

The convict has undergone an actual sentence of 20 Years, 04 days & 05 days excluding remission as on 30th of November 2015. He has undergone a total period of 24 years, 09 days & 24 days including remission earned by him. He has availed parole 03 times and furlough 05 times. Nothing adverse reported against him during parole/furlough. He participated in education, vocational and spiritual programme in jail. His work and conduct has been satisfactory in jail. He is granted regular parole by the DHC till the final decision of previous Board meeting.

The Police opposed his premature release in its report as well as in the meeting in view of nature and gravity of offence. Probation Officer, Delhi has recommended his premature release.

After taking into account totality of facts, gravity of offence, non recommendations of police, the Board **REJECTS** the premature release of convict.

**6. RAJBIR SINGH S/O YAD RAM ---AGE--58 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 418/97, U/S-302 IPC P.S. Malviya Nagar, Delhi for committing murder of his tenant due to grudge against him.

The convict has undergone an actual sentence of 18 Years, 05 days & 03 days excluding remission as on 30th of November 2015. He has undergone a total period of 22 years, 09 days & 29 days including remission earned by him. He has availed parole 02 times. He jumped parole w.e.f. 11.03.2004 to 22.04.2004. His work and conduct has been satisfactory in jail except parole jump. He has participated in vocational and spiritual programme in jail.

The Police opposed his premature release in its report as well as in the the meeting in view of nature and gravity of offence. Home town police has also opposed premature release. Probation Officer, Delhi has not opposed his premature release.

After taking into account totality of facts, satisfactory work and conduct in jail, recommendations of probation officer, the Board **RECOMMENDS** the premature release of convict.

**7. KHALID MEHMOOD S/O MOHD YUSUF ---AGE---41 Yrs. (PAK NATIONAL)**

The convict is undergoing life imprisonment in case FIR No. 79/94, U/S-302(3)3(3)7 5 TADA ACT P.S. Tilak Nagar, Delhi for alleged role in terrorist activities and recovery of arms and ammunition.

The convict has undergone an actual sentence of 21 Years, 08 days & 03 days excluding remission as on 30th of November 2015. He has undergone a total period of 22 years, 10 days & 19 days including remission earned by him. No parole/furlough availed by him. His work and conduct has been satisfactory in jail. He has participated in vocational programme in jail.

The Police not opposed his premature release in its report but opposed in the meeting in view of nature and gravity of offence i.e. terrorist activity in India. Home town police has not opposed his premature release. Probation Officer, Delhi and home town has not opposed his premature release.

After taking into account totality of facts, gravity of offence and non recommendations of police, the Board **REJECTS** the premature release of convict.

**8. AMZAD ALI MUGHAL S/O MOHD ANWER---AGE---56 Yrs. (PAK NATIONAL)**

The convict is undergoing life imprisonment in case FIR No. 79/94, U/S-302(3)3(3)7 5 TADA ACT P.S. Tilak Nagar, Delhi for alleged role in terrorist activities and recovery of arms and ammunition.

The convict has undergone an actual sentence of 21 Years, 08 days & 02 days excluding remission as on 30th of November 2015. He has undergone a total period of 26 years, 10 days & 16 days including remission earned by him. No parole/furlough availed by him. His work and conduct has been satisfactory in jail.

The Police report awaited but opposed in the meeting in view of nature and gravity of offence i.e. terrorist activity in India. Home town police has not opposed his premature release. Probation Officer, Delhi and home town has not opposed his premature release.



After taking into account totality of facts, gravity of offence non recommendations of police, the Board **REJECTS** the premature release of convict.

**09. BHIM SEN S/O MOTI RAM---AGE--60 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 479/2000, U/S-376 IPC P.S. Rajouri Garden, Delhi for committing rape of girl of 06 years of age.

The convict has undergone an actual sentence of 15Years, 06 days & 15 days excluding remission as on 30th of November 2015. He has undergone a total period of 19years, 01 days & 16 days including remission earned by him. No parole/furlough availed by him. His work and conduct has been satisfactory in jail.

The Ld. Addl. Session Judge has opposed the premature release in view of nature and gravity of offence. The Police opposed his premature release in its report as well as in the meeting in view of nature and gravity of offence. Probation Officer, Delhi has recommended his premature release.

After taking into account totality of facts, gravity of offence and non recommendations of police, the Board **REJECTS** the premature release of convict.

**10. RAHUL @ BUDH PRAKASH S/O MAHESH---AGE--31 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 488/2002, U/S-392/397/506/376/324/34 IPC & 25/54/59 ARMS ACT P.S. I.P. Estate, Delhi for committing rape of young girl student of Medical Student of Maulana Azad Medical College and robbed her belongings.

The convict has undergone an actual sentence of 13 Years, & 07 days excluding remission as on 30th of November 2015. He has undergone a total period of 16 years, 10 months & 10 days including remission earned by him. He availed parole 04 times and furlough 06 times. Nothing adverse reported against him during parole/furlough. His work and conduct has been satisfactory in jail.

The Ld. Addl. Session Judge has opposed the premature release in view of nature and gravity of offence. The Police report not received inspite of multiple message, but opposed his

premature release in the meeting in view of nature and gravity of offence. Probation Officer, Delhi has recommended his premature release.

After taking into account totality of facts, gravity of offence and non recommendations of police, the Board **REJECTS** the premature release of convict.

**11. VIRINDER SINGH S/O ALBEL SINGH---AGE--53 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 238/97 U/S-368 IPC P.S. Tuglak Road, Delhi for kidnapping and abduction of boy for ransom.

The convict has undergone an actual sentence of 15Years, & 07 months excluding remission as on 30th of November 2015. He has undergone a total period of 18 years, 08 months & 27 days including remission earned by him. He availed parole 06 times and furlough 06 times. Nothing adverse reported against him during parole/furlough. His work and conduct has been satisfactory in jail. He participated in educational and spiritual courses held in jail.

The Police opposed his premature release in its report as well as in the meeting in view of criminal involvement in multiple cases. Home town police has also opposed his release in view of possible of indulging in similar cases. Probation Officer, both Delhi and home town has recommended his premature release.

After taking into account totality of facts, gravity of offence and non recommendations of police, the Board **REJECTS** the premature release of convict.

**12. RADHA KRISHANAN NAIR S/O DAMODARAN NAIR---AGE--47 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 479/2000 U/S-302 IPC P.S. Defence Colony, Delhi for committing murder of his wife due to some domestic issues.

The convict has undergone an actual sentence of 15 Years, & 04 months & 01 day excluding remission as on 30th of November 2015. He has undergone a total period of 19 years, 02 months & 26 days including remission earned by him. He availed parole 01 time and furlough 01 time. Nothing adverse reported against him during parole/furlough. His work and conduct has been satisfactory in jail. He participated in vocational and spiritual courses held in jail.

The Police has not opposed his premature release in its report but opposed in the meeting in view of nature and gravity of offence. Home town police report awaited inspite of multiple

messages thus, presumed not opposed. Probation Officer, Delhi has recommended and home town probation officer has not recommended his premature release.

After taking into account totality of facts, satisfactory work and conduct in jail, recommendations of probation officer, the Board **RECOMMENDS** the premature release of convict.

Out of 100 cases placed before the Sentence Reviewing Board, 38 cases have been recommended and 62 cases have been rejected.
