

**RECOMMENDATIONS OF THE SENTENCE REVIEW BOARD FOR PREMATURE RELEASE OF LIFE CONVICTS IN THE MEETING HELD UNDER THE CHAIRMANSHIP OF THE HON'BLE HOME MINISTER OF DELHI AT 11:00 AM ON 11.05.2020, AT DELHI SECRETARIAT, NEW DELHI- 110002.**

A meeting of the **Sentence Review Board** (hereinafter referred to as **Board**) was held on 11.05.2020 in the Conference Room, 7<sup>th</sup> Level "A" Wing, Delhi Secretariat under the **CHAIRMANSHIP OF HON'BLE HOME MINISTER, GOVT. OF NCT OF DELHI.**

The meeting of Sentence Review Board was fixed for **11.05.2020 at 11:00 A.M.** in the chamber of the Hon'ble Minister (Home), Delhi to consider the cases for premature release of convicts undergoing Life sentence, who are eligible upto 30.04.2020 (including deferred cases).

A total 37 number of cases of life convicts were placed before the **Board** for its consideration consisting of 34 Fresh cases (including 02 cases of CBI, 02 cases under Rule 1255 of DPR, 2018 and 03 deferred cases). The Board examined each case on its merit on the basis of its facts and circumstances in the light of Delhi Prisons Rules, 2018 and recommendations of concern Authorities.

All the cases put forth before the Board were discussed at length and considered in the light of parameters as mentioned in SRB order 2004 and Delhi Prisons Rules, 2018. Factors like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed (premeditated or in spur of the moment), nature & gravity of crime, whether the convict is casual or habitual offender, his/her antecedents, apprehension by his/her family members, propensity of committing crime again or not, his lodgment, parole/furlough availed and conduct during parole/furlough as well as in Jail, prospects of post release rehabilitation, family responsibilities, possibility of the convict to return as a useful member of the society and his socio-economic condition were also evaluated by the Board and accordingly, its recommendations were given.

It was informed to the Board that the recommendations for premature release are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.

**01. PYARE LAL S/O SH. SUDARSHAN PRASAD — AGE-37 YRS.**

Pyare Lal S/o Sh. Sudarshn Prasad is undergoing life imprisonment in case FIR No. 94/2006, U/S 302/364/394/201/34 IPC P.S. Timar Pur, Delhi for kidnapping, robbing & murder of a truck helper.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 25 days **in actual** and 16 years, 09 months and 25 days **with remission**. He has availed Parole 01 time and Furlough 02 times.

**Recommendation by Police:**

Delhi Police has strongly opposed his premature release in its report. However, The Special Commissioner of Delhi Police (Crime) has **not opposed** in the meeting in view of jail conduct of the convict.

**Recommendation by Social Welfare Department:**

The report of Social Welfare Department, Delhi, has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, **has supported** the premature release of the convict in the meeting. Report from Social Welfare Department, Hometown has not been received.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. satisfactory conduct in jail, nothing adverse reported during parole and furlough, the Board unanimously **RECOMMENDS** premature release of convict Pyare Lal s/o Sh. Sudarshan Prasad.

**02. MAHESH S/O SH. BABU LAL — AGE-36 YRS.**

Mahesh S/o Sh. Babu Lal is undergoing life imprisonment in case FIR No. 94/2006, U/S 302/364/392/394/201/411/34 IPC P.S. Timar Pur, Delhi for kidnapping, robbing & murder of a truck helper.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 25 days **in actual** and 16 years, 03 months and 06 days **with remission**. He has availed only 01 Parole.

**Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. The Special Commissioner of Delhi Police (Crime) has **also opposed** his premature release in the meeting. Report from Hometown has neither recommended nor opposed his premature release.

**Recommendation by Social Welfare Department:**

The reports of Social Welfare Department, Delhi & Hometown are still awaited. However, the Chief Probation Officer, Social Welfare Department, Delhi, has **not recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case, unsatisfactory conduct in jail and registration of a criminal case U/S 224 IPC during incarceration, the Board unanimously **REJECTS** premature release of convict Mahesh s/o Sh. Babu Lal.

**03. AJAY KUMAR S/O SH. SHIV DAYAL — AGE-34 YRS.**

Ajay Kumar S/o Sh. Shiv Dayal is undergoing life imprisonment in case FIR No. 94/2006, U/S 302/364/394/201/34 IPC P.S. Timar Pur, Delhi for kidnapping, robbing & murder of a truck helper.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 24 days **in actual** and 16 years and 02 months **with remission**. He has availed Parole 02 times and Furlough 01 time.

**Recommendation by Police:**

The reports from Delhi Police & Hometown Police have not been received. However, the Special Commissioner of Delhi Police (Crime) **has supported** his premature release in the meeting.

**Recommendation by Social Welfare Department:**

The reports of Social Welfare Department, Delhi & Hometown have not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, has **supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case, no violation during parole and furlough, the Board unanimously **RECOMMENDS** premature release of convict Ajay Kumar S/o Sh. Shiv Dayal.

**04. ASHOK KUMAR KOHLI S/O SH. SHER BAHADUR — AGE-51 YRS.**

Ashok Kumar S/o Sh. Sher Bahadur is undergoing life imprisonment in case FIR No. 654/2005, U/S 302 IPC, P.S. Kalyan Puri, Delhi for murder of a lady.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 22 days **in actual** and 18 years, 18 days **with remission**. He has availed I. Bail 01, Parole 07 times and Furlough 23 times.

**Recommendation by Police:**

The Delhi Police has highly opposed his premature release in its report. The Special Commissioner of Delhi Police (Crime) **has supported** his premature release in the meeting.

**Recommendation by Social Welfare Department:**

The report from Social Welfare Department, Delhi has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, **has recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case as the convict had no previous criminal history, has good conduct in jail as well as during I. Bail/parole/furlough, shown good prospects and aptitude for reform, the Board unanimously **RECOMMENDS** premature release of convict Ashok Kumar Kohli S/o Sh. Sher Bahadur.

**05. CHETAN S/O SH. RAM SWAROOP — AGE-55 YRS.**

Chetan S/o Sh. Ram Swaroop is undergoing life imprisonment in case FIR No. 14/1998, U/S 302/34 IPC & 25 A. ACT, PS. S.P. Badli, Delhi for committing murder of his uncle on some old issues.

**The convict has undergone:**

Imprisonment of 14 years and 26 days **in actual** and 17 years, 09 months and 03 days **with remission**. He has availed Parole 03 times and Furlough 10 times.

**Recommendation by Police:**

The Delhi Police report has not been received. However, the Special Commissioner of Delhi Police (Crime) has **not opposed** his premature release in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi and Hometown reports have not been received. However, the Chief Probation Officer, Social welfare Department, Delhi, **has supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case as the convict has no previous criminal history, he has shown good conduct in jail as well as during parole & furlough etc., the Board unanimously **RECOMMENDS** premature release of convict Chetan S/o Sh. Ram Swaroop.

**06. DALIP KUMAR @ ALBELI S/O SH. HARI CHAND — AGE-58 YRS.**

Dalip Kumar @ Albeli S/o Sh. Hari Chand is undergoing life imprisonment in case FIR No. 314/2006, U/S 302 IPC, P.S. Model Town, Delhi for murder of a person over money dispute.

**The convict has undergone:**

Imprisonment of 14 years and 05 days **in actual** and 17 years, 03 months and 12 days **with remission**. He has availed I. Bail 01 time, Parole 01 time and Furlough 04 times.

**Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report, however, the Special Commissioner of Delhi Police (Crime) has **not opposed** in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has **recommended** premature release of the convict in its report. The Chief Probation Officer, Social welfare Department, Delhi, has **supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case under which the offence was committed i.e. quarrel on issue of refund of borrowed money, satisfactory conduct in jail for more than last 3 years, the Board unanimously **RECOMMENDS** premature release of convict Dalip Kumar @ Albeli S/o Sh. Hari Chand.

**07. GYAN CHAND S/O LATE SH. BRIJ KISHORE — AGE-49 YRS.**

Gyan Chand S/o Late Sh. Brij Kishore is undergoing life imprisonment in case FIR No. 163/2006, U/S 302/34 IPC, P.S. Najagarh, Delhi for murder of his wife.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 24 days **in actual** and 18 years, 01 months and 29 days **with remission**. He has availed Parole 05 times and Furlough 17 times.

**Recommendation by Police:**

Delhi Police report has not been received. The Special Commissioner of Delhi Police (Crime) **has supported** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi report has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, has **recommended** his premature release in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, he has shown good aptitude for reforms, good conduct in jail, no violations during Parole & Furlough, the Board unanimously **RECOMMENDS** premature release of convict Gyan Chand S/o Late Sh. Brij Kishore.

**08. KALLU @ VIJAY KUMAR S/O SH. KAMAL SINGH —AGE-45 YRS.**

Kallu @ Vijay Kumar S/o Sh. Kamal Singh is undergoing life imprisonment in case FIR No. 534/1997, U/S 302/34 IPC, P.S. Gokul Puri, Delhi for committing murder of a person (cousin) on previous issues.

**The convict has undergone:**

Imprisonment of 14 years and 28 days **in actual** and 18 years and 16 days **with remission**. He has availed Parole 07 times and Furlough 20 times.

**Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. The Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi report has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, has **supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, he has shown good aptitude for reforms, family responsibilities, good conduct in jail as well as during Parole & Furlough, the Board unanimously **RECOMMENDS** premature release of convict Kallu @ Vijay Kumar S/o Sh. Kamal Singh.

**09. KAMLA PRASAD S/O SH. BADRI PRASAD — AGE-63 YRS**

Kamla Prasad S/o Sh. Badri Prasad is undergoing life imprisonment in case FIR No. 290/2006, U/S 302 IPC, P.S. Narela, Delhi for murder of his wife by burning.

**The convict has undergone:**

Imprisonment of 14 years **in actual** and 17 years, 06 months and 17 days **with remission**. He has availed Parole 05 times and Furlough 17 times.

**Recommendation by Police:**

The Delhi Police report has not been received. However, the Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi report has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi, has **recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, he has shown good aptitude for reforms, family responsibilities, good conduct in jail, no violations during Parole & Furlough, the Board unanimously **RECOMMENDS** premature release of convict Kamla Prasad S/o Sh. Badri Prasad.

**10. MANOJ KUMAR S/O SH. VIJAY SINGH — AGE-35 YRS.**

Manoj Kumar S/o Sh. Vijay Singh is undergoing life imprisonment in case FIR No. 346/2005, U/S 302/364/364-A/201/120-B/34 IPC, P.S. Nangloi, Delhi for kidnapping & murder of a boy for ransom.

**The convict has undergone:**

Imprisonment of 14 years, 01 month and 04 days **in actual** and 15 years, 09 months and 17 days **with remission**. He has availed Parole 03 times and Furlough 01 time.

**Recommendation by Police:**

The Delhi Police report has strongly opposed his premature release. The Special Commissioner of Delhi Police (Crime) has **opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi report has not been received. The Chief Probation Officer, Social Welfare Department, Delhi, has also **not supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case, the convict being involved in a heinous crime i.e. kidnapping and murder of a boy for ransom, having criminal history and un-satisfactory conduct in jail as well as during Furlough, the Board unanimously **REJECTS** premature release of convict Manoj Kumar S/o Sh. Vijay Singh.

**11. MEHBOOB AHMED S/O SH. MAQSOOD AHMED — AGE-57 YRS.**

Mehboob Ahmed S/o Sh. Maqsood Ahmed is undergoing life imprisonment in case FIR No. 527/2005, U/S 302 IPC, P.S. Khajoori Khas, Delhi for murder of his step daughter.

**The convict has undergone:**

Imprisonment of 14 years, 02 months and 13 days **in actual** and 17 years, 04 months and 21 days **with remission**. He has availed I. Bail 02 times, Parole 05 times and Furlough 17 times.

**Recommendation by Police:**

The Delhi Police has neither recommended nor opposed in its report for his premature release. However the Special Commissioner of Delhi Police (Crime) **opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has not been received. The Chief Probation Officer, Social Welfare Department, Delhi, has **not supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case that the convict is involved in a heinous crime i.e. murder of his step daughter, having previous criminal history, non-recommendation by police and welfare Authorities etc., the Board unanimously **REJECTS** premature release of convict Mehboob Ahmed S/o Sh. Maqsood Ahmed.

**12. RADHEY SHYAM S/O SH. RAMDIN — AGE-37 YRS.**

Radhey Shyam S/o Sh Ramdin is undergoing life imprisonment in case FIR No. 34/2006, U/S 302 IPC, P.S. Tilak Nagar, Delhi for murder of his wife.

**The convict has undergone:**

Imprisonment of 14 years, 02 months and 22 days **in actual** and 17 years, 02 months and 17 days **with remission**. He has availed Parole 03 times and Furlough 07 times.

**Recommendation by Police:**

The Delhi Police has **highly opposed** for his premature release in its report. Hometown police report has not been received. The Special Commissioner of Delhi Police (Crime) has also **opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

Reports from the Social Welfare Department, Delhi as well as Hometown **have not been received**. The Chief Probation Officer, Social Welfare Department, Delhi, has **not supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case under which the offence was committed, un-satisfactory conduct in jail, the Board unanimously **REJECTS** premature release of convict Radhey Shyam S/o Sh Ramdin.

**13. RAKESH S/O SH. RAMESH CHAND — AGE-48 YRS.**

Rakesh S/o Sh. Ramesh Chand is undergoing life imprisonment in case FIR No. 231/1995, U/S 302/307/34 IPC, P.S. Sadar Bazar, Delhi for murder of a person during quarrel.

**The convict has undergone:**

Imprisonment of 14 years **in actual** and 18 years, 03 months and 06 days **with remission**. He has availed Parole 06 times and Furlough 26 times.

**Recommendation by Police:**

The Delhi Police report has not been received. The Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi, report has not been received. The Chief Probation Officer, Social Welfare Department, Delhi has **recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, satisfactory conduct in jail as well as during Parole and Furlough, shown good aptitude for reforms, his family responsibilities etc., the Board unanimously **RECOMMENDS** premature release of convict Rakesh S/o Sh. Ramesh Chand.

**14. RAMESH KUMAR S/O SH. RAM KUMAR — AGE-42 YRS.**

Ramesh Kumar S/o Sh. Ram Kumar is undergoing life imprisonment in case FIR No. 169/2006, U/S 302/307 IPC, P.S. Vikas Puri, Delhi for murder of his sister-in-law by setting the jhuggi on fire.

**The convict has undergone:**

Imprisonment of 14 years and 01 day **in actual** and 17 years and 22 days **with remission**. He has availed Parole 07 times and Furlough 16 times.

**Recommendation by Police:**

The Delhi Police has not recommended his premature release in its report. The Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi, report has not been received. However the Chief Probation Officer, Social Welfare Department, Delhi has **recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, satisfactory jail conduct as well as during Parole and Furlough, shown good aptitude for reforms, his family responsibilities etc., the Board unanimously **RECOMMENDS** premature release of convict Ramesh Kumar S/o Sh. Ram Kumar.

**15. REHAN @ GANDHI S/O SH. RIYASAT — AGE-35 YRS.**

Rehan @ Gandhi S/o Sh. Riyasat is undergoing life imprisonment in case FIR No. 183/2006, U/S 302 IPC, P.S. Khajuri Khas, Delhi for committing murder of a known person for revenge.

**The convict has undergone:**

Imprisonment of 14 years and 01 day **in actual** and 16 years, 10 months and 08 days **with remission**. He has availed Parole 04 times and Furlough 11 times.

**Recommendation by Police:**

The Delhi Police has neither recommended nor opposed his premature release in its report. The Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi, has not been received. The Chief Probation Officer, Social Welfare Department, Delhi has **recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict has no previous criminal history, satisfactory conduct in jail for last more than 06 years, nothing adverse during Parole and Furlough, his family responsibilities etc., the Board unanimously **RECOMMENDS** premature release of convict Rehan @ Gandhi S/o Sh. Riyasat.

**16. VIRENDER SINGH @ PODHA @ TICKET S/O SH. TAHAR SINGH — AGE-59 YRS.**

Virender Singh @ Podha @ Ticket S/o Sh. Tahar Singh is undergoing life imprisonment in case FIR No. 15/2006, U/S 302 IPC, P.S. M.S. Park, Delhi for murder of his friend.

**The convict has undergone:**

Imprisonment of 14 years, 03 months and 01 days **in actual** and 17 years, 09 months and 16 days **with remission**. He has never availed any I. Bail, Parole or Furlough.

**Recommendation by Police:**

Both Delhi Police and Hometown police have opposed his premature release in their reports. The Special Commissioner of Delhi Police (Crime) has also **opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

Reports from Social Welfare Department, Delhi has not been received. The Chief Probation Officer, Social Welfare Department, Delhi, has **not supported** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case, the manner under which the offence was committed, the convict having previous criminal history, un-satisfactory jail conduct, the Board unanimously **REJECTS** premature release of convict Virender Singh @ Podha @ Ticket S/o Sh. Tahar Singh.

**17. SAIDUL @ AFZAL @ SHAHID S/O SH. ABDUL LATIF — AGE-47 YRS. (BANGLADESH NATIONAL)**

**35. SIDDHARTHA VASHISHTHA S/O SH. VINOD SHARMA — AGE-45 YRS.**

Siddhartha Vashishtha S/o Sh. Vinod Sharma is undergoing life imprisonment in case FIR No. 287/1999, U/S 302/201/120B IPC & 27 A. ACT, P.S. Mehrauli, Delhi for murder of a lady during sudden altercation.

**The convict has undergone:**

Imprisonment of 16 years, 11 months and 24 days **in actual** and 23 years, 04 months and 22 days **with remission**. He has availed Parole 12 times and Furlough 24 times.

**Recommendation by Police:**

As per the report of Delhi Police, premature release of the convict may be decided on merits. The Special Commissioner of Delhi Police (Crime) has **not opposed** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has **recommended** premature release of the convict. The Chief Probation Officer, Social Welfare Department, Delhi, has also **recommended** the premature release of the convict in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the convict having no previous criminal history, satisfactory jail conduct, no violation during Parole/furlough, lodgment in open jail, the Board unanimously **RECOMMENDS** premature release of convict Siddhartha Vashishtha S/o Sh. Vinod Sharma.

**36. UTTAM KUMAR S/O LATE SH. HAZARI LAL — AGE-53 YRS.**

Uttam Kumar S/o Late Sh. Hazari Lal is undergoing life imprisonment in case FIR No. 235/1999, U/S 302 IPC, P.S. Adarsh Nagar, Delhi for murder of a girl, in the house where he was giving tuition.

**The convict has undergone:**

Imprisonment of 20 years, 11 months and 10 days **in actual** and 26 years, 10 days **with remission**. He has availed parole 02 times and Furlough 13 times. The judgment of the Trial court was also placed before the Board, as per the observation of the Ld. trial judge.

**Recommendation by Police:**

The Delhi Police has strongly opposed his premature release in its report. However, the Special Commissioner of Delhi Police (Crime) **supported** to his premature release in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi, has **recommended** his premature release in its report. The Chief Probation Officer, Social Welfare Department, Delhi also **recommended** the premature release of the convict.

**Conclusion:**

After taking into account all the facts and circumstances of the case, throughout satisfactory conduct of the convict during incarceration, no violation during parole/furlough and lodgement in semi open jail, his long incarceration of over 20 years in actual, the Board unanimously **RECOMMENDS** premature release of convict Uttam Kumar S/o Late Sh. Hazari Lal.

**37. KIRAN @ BABLI W/O SH. JAGMOHAN — AGE-71 YRS**

Kiran @ Babli W/o Sh. Jagmohan is undergoing life imprisonment in case FIR No. 80/2010, U/S 302/34 IPC, P.S. Burari, Delhi for murder of her daughter-in-law by putting her on fire.

**The convict has undergone:**

Imprisonment of 10 years, 18 days **in actual** and 12 years, 11 months and 14 days **with remission**. She has availed Parole 02 times and Furlough 03 times.

**Recommendation by Police:**

Delhi Police has neither recommended nor opposed her premature release in its report. However, the Special Commissioner of Delhi Police (Crime) has **not recommended** the premature release of the convict in the meeting.

**Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi report has not been received. However, the Chief Probation Officer, Social Welfare Department, Delhi has **not supported** her premature release in the meeting.

**Conclusion:**

After taking into account all the facts and circumstances of the case, heinousness and perversity of the crime, circumstances under which the offence was committed, non-recommendation by Police & Social Welfare Department, the Board unanimously **REJECTS** premature release of convict Kiran @ Babli W/o Sh. -Jagmohan at this stage.

Thus, as discussed above out of 37 cases placed before the Sentence Review Board, 22 cases (including 02 cases of CBI & 01 case of terminally ill category) have been **recommended** for premature release, and 15 cases have been **rejected**.

The cases investigated by CBI (Case Nos. 26 & 27) recommended by the Board are subject to consultation with Central Government (MHA), in view of Section 435 of Cr.P.C., 1973.

The case of terminally ill convict (Case No. 32) recommended by the Board shall be processed according to Rule 1255 of DPR, 2018 for getting the assent of Hon'ble President of India.
