**OFFICE ORDER**

The promotion of the above mentioned officials is subject to the outcome of SLP(C) No. 30621/2011, 6915/2014 & SLP (C) No. 031288/2017 and other connected cases before the Hon'ble Supreme Court.

The officials promoted may exercise option for fixation of pay in terms of FR 22 within one month from the date of promotion or appointment as Head Warders/Head Matrons/Staff Car Drivers. However, if the official who have already been granted financial up-gradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme shall not be entitled for any fixation benefits now.

Their inter-se-seniority on promotion shall be same as their relative seniority in the lower grade from which they are promoted.

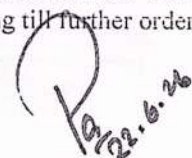
The promotion is subject to the condition that the Head of the Office concerned must ensure that no disciplinary proceedings/criminal proceedings were pending or no penalty was in operation against the promotee officials **on the date of their notional promotion** before relieving them to take up their new assignment on promotion in the light of instructions contained in DoPT O.M. No.2201 1/4/91-Esu(A) dated 14/09/1992 and other related OMs issued from time to time.

The above said conditions related to vigilance clearance & status of penalty shall invariably be mentioned in their relieving order as well. Further. An undertaking may be obtained from the official regarding no vigilance case or any penalty is pending against the official **on date of notional promotion**. If the official is not clear from vigilance angle or under currency of penalty on the date of notional promotion or has resigned/expired etc., the same may be brought to the notice of Superintendent-I (PHQ) immediately.

In the case of Staff Car Driver vigilance clearance and status of penalty may be verified on the **date of actual promotion/date of joining**.

Consequent upon their promotion to the post of Head Warders/Head Matrons/Staff Car Drivers the above Officials shall continue to work physically at their present place of posting till further orders.
