OFFICE MEMORANDUM

Sub: Strengthening of administration- Periodical Review under FR 56(j) and Rule 48 of CCS (Pension) Rules, 1972 [now, revised as Rule 42 of CCS (Pension) Rules, 2021]: Composition of Representation Committee.

In pursuance of DoP&T OMs issued from time to time on the subject, a Representation Committee with the following composition has been constituted in GNCTD, for considering the representations received from Government servants in respect of whom order/notice of compulsory/premature retirement has been issued under the provisions of FR 56(j)/FR 56(l) and Rule 48 of CCS (Pension) Rules, 1972 [now, revised as Rule 42 of CCS (Pension) Rules, 2021]:-

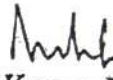
1. Sh. Prashant Goyal, IAS (AGMUT: 1993), Additional Chief Secretary (Food & Civil Supplies).
2. Sh. D. Varma, IAS (AGMUT: 2011), Member, DUSIB.
3. JS/DS level officer to be nominated by the Cadre Controlling Department concerned.
2. The Representation Committee will consider the representations of all cadre and ex-cadre employees of GNCTD who were compulsorily retired under FR 56(j)/FR 56(l) and Rule 48 of CCS (Pension) Rules, 1972 [now, revised as Rule 42 of CCS (Pension) Rules, 2021].
3. As per DoP&T instructions dated 28.08.2020, the concerned Government servant may submit a representation against the order of premature retirement within three weeks from the date of service of such notice/order.
4. On receipt of a representation from the employee who has been compulsorily/prematurely retired under FR 56(j)/FR 56(l) and Rule 48 of CCS (Pension) Rules, 1972 [now, revised as Rule 42 of CCS (Pension) Rules, 2021], the concerned Cadre Authorities shall examine whether it contains any new fact or any new aspect of a fact already known but not taken into account at the time of issuing the notice/order of premature retirement. This examination shall be completed within two weeks from the date of receipt of the representation. Thereafter, the case shall be placed before the Representation Committee for consideration.
5. The Representation Committee shall make its recommendations within two weeks from the date of receipt of the reference from the Cadre Authorities concerned. The

Appropriate/Appointing Authority shall pass its orders within two weeks from the date of receipt of the recommendations of the Representation Committee.

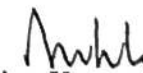
