- 6) Preparation of Statistical Reports and Conduct of Large-Scale Surveys/Censuses to support evidence-based planning and policy-making.
- 7) Monthly, Quarterly and yearly vacancy position of all posts sanctioned in Delhi Prison Department.
- 8) Various statistical reports to difference agencies like NHRC, NCRB, NISD etc.
- 9) Statistical Data related to the Grievance Portal i.e. PGMS, CPGRAM and LG
- 10) The Planning and Statistical Branch, PHQ is nominated as Nodal Branch for various grievances platforms (PGMS, CPGRAM and LG Listening post). The Branch In-Charge will be the Nodal Officer and will manage the platforms with technical support from IT Branch, PHQ.

The branch will be headed by Assistant Director (Plg./Stat.) and will report/work under the supervision of SCJ-II (PHQ).
