जैसा कि विदित है कि जनगणना 2027 दो चरणों में आयोजित की जाएगी। पहला चरण-मकानसूचीकरण एवं मकानों की गणना, 1 अप्रैल, 2026 से 30 सितंबर, 2026 के बीच देश के सभी राज्य/संघ राज्य क्षेत्रों में संबंधित राज्य/संघ राज्य क्षेत्र द्वारा चयनित 30 दिनों की अवधि में संपन्न किया जाएगा। इस संबंध में अवधि तथा प्रश्रावली हेतु अधिसूचना पूर्व में ही जारी की जा चुकी है, जिसे राज्य/संघ राज्य क्षेत्रों द्वारा पुनः प्रकाशित करते हुए मकानसूचीकरण एवं मकानों की गणना की अवधि का उल्लेख किया गया है। राज्य/संघ राज्य क्षेत्र द्वारा संभावित अवधि अनुलग्नक-1 में दी गई है। दूसरा चरण- जनसंख्या गणना फरवरी 2027 में आयोजित की जाएगी, जिसके लिए पृथक अधिसूचना यथासमय जारी की जाएगी।

2. डिजिटल इंडिया पहलों के प्रति सरकार की प्रतिबद्धता के अनुरूप, जनगणना 2027 में डेटा के संग्रहण और प्रसार की गुणवत्ता, दक्षता तथा समयबद्धता को सुदृढ़ करने के उद्देश्य से डिजिटल प्रौद्योगिकी का व्यापक उपयोग किया जाएगा। इस उद्देश्य को पूर्ण के लिए प्रगणकों द्वारा डेटा संकलन के लिए एक समर्पित मोबाइल अनुप्रयोग (HLO Application) का उपयोग किया जाएगा। इसके अतिरिक्त, आम नागरिकों के लिए स्व-गणना (Self-Enumeration - SE) की सुविधा एक समर्पित वेब पोर्टल (<https://se.census.gov.in>) के माध्यम से उपलब्ध कराई जाएगी। यह पोर्टल मकानसूचीकरण एवं मकानों की गणना (HLO) के लिए प्रगणकों द्वारा घर-घर जाकर किए जाने वाले डेटा संकलन के प्रारंभ होने से ठीक पूर्व 15 दिनों की अवधि के लिए आम जनता के लिए खुला रहेगा।

3. स्व-गणना में सहभागिता एक सुरक्षित एवं सरल माध्यम प्रदान करती है, जिसके माध्यम से परिवार अपनी सुविधा के अनुसार परिवार संबंधी विवरण उपलब्ध करा सकते हैं। यह वेब पोर्टल अंग्रेज़ी, हिंदी तथा 14 क्षेत्रीय भाषाओं में उपलब्ध है। परिवार का कोई भी एक सदस्य लगभग 15-20 मिनट में स्व-गणना की प्रक्रिया पूर्ण करते हुए परिवार संबंधी विवरण दर्ज कर सकता है तथा स्व-गणना पहचान संख्या (SE ID) अपने मोबाइल/ई-मेल पर प्राप्त कर सकता है। प्रगणक के परिवार के भ्रमण के दौरान, स्व-गणना के विवरण की पुष्टि एवं अंतिम प्रस्तुतिकरण के लिए SE ID प्रगणक के साथ साझा करना आवश्यक होगा।

It has been requested to encourage all officials in all Government Departments, attached offices and all other organizations to Self-Enumerate during the State/UT specific notified period of 15 days.

2. As you are aware that Phase-I of Census 2027, i.e., Houselisting and Housing Census (HLO) shall take place from 16<sup>th</sup> May, 2026 to 14<sup>th</sup> June, 2026 and the option of self-enumeration shall be operational from 1<sup>st</sup> May, 2026 to 15<sup>th</sup> May, 2026 in Municipal Corporation of Delhi (MCD) area. Further, the Houselisting Operations of the Census of India 2027 in area falling under New Delhi Municipal Council (NDMC) and Delhi Cantonment Board shall take place from 16<sup>th</sup> April, 2026 to 15<sup>th</sup> May, 2026 and the option of self-enumeration shall be operational from 1<sup>st</sup> April, 2026 to 15<sup>th</sup> April, 2026.

3. It is, therefore, requested to issue necessary instructions to all officials of Government of NCT of Delhi, attached offices, Local Bodies and all other organizations to Self-Enumerate during specific notified period of 15 days i.e. from 1<sup>st</sup> April, 2026 to 15<sup>th</sup> April, 2026 in area falling under New Delhi Municipal Council (NDMC) and Delhi Cantonment Board and from 1<sup>st</sup> May, 2026 to 15<sup>th</sup> May, 2026 in Municipal Corporation of Delhi (MCD).

**Sub: Special Intensive Revision-2026: Mapping of Electors-regarding.**

Madam/Sir,

I am directed to refer to the subject cited above and to inform that as per instructions of the Election Commission of India, Special Intensive Revision(SIR) of electoral rolls is being carried out throughout India. In NCT of Delhi also, preparatory exercises for the upcoming SIR are being done. As per instructions of the ECI, mapping of electoral of electoral roll-2025 is being done vis-à-vis electoral rolls of last SIR i.e. 2002. For this purpose BLOs are visiting House to House in their allotted part for obtaining elector's details pertaining to year 2002. Special camps/Meetings with RWAs/political parties are also being held in order to increase mapping percentage in Delhi.

2. For ease of public in searching their name in electoral rolls-2002, PDF of ER-2002 has been uploaded on the website of CEO, Delhi. Also facility to search name through their Voter I Card (EPIC) & details has been provided on the website of CEO, Delhi. Links for the same are given as under:-

3. In case a person is 40 years of age and permanently staying in Delhi before 2002, he/she can check his/her name in the voter list of 2002 through aforesaid links and note down their details (relative name, State Name, AC Name, AC Number, Part No, Sr No.) as appearing in the voter list of 2002.

4. And in case they have come from other State and settled in Delhi after 2002, their name will not appear in 2002 voter list of Delhi but will appear in the voter list of last SIR held in their native State from where they have come. They can obtain their details from the link: <https://voters.eci.gov.in/> as appearing in the voter list of 2002/2003/2005 (year of last SIR held in that particular State, as the case may be). This information has to be shared with the BLO of their area when he/she visit your house during ongoing H2H during Pre-SIR period and also during distribution and collection of Enumeration form during SIR period.

5. In this regard, I am directed to get this information disseminated to all employees of GNCTD / Autonomous bodies through their HODs for checking their names in the electoral rolls-2002 and sharing the same with their BLOs visiting their homes.
