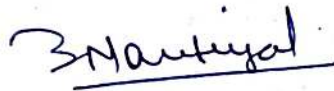

Sub: Circulation of "Compensation to Victims (Interim Relief) Scheme, 2026"-reg.

Madam /Sir,

In the year 2024, India reported approximately 4.7 lakh road accidents, resulting in around 1.7 lakh deaths and 2.3 lakh cases of grievous hurt. The consequences of such accidents extend beyond loss of life and injuries to sudden loss of livelihood, prolonged incapacitation and severe financial distress for victims and their families.

2. Recognizing the need for immediate financial relief to claimants praying for compensation in such situations, pending the determination of claim for compensation by the Claims Tribunal under the provisions of Chapter XII, the Motor Vehicles (Amendment) Act, 2019 introduced Section 164A in the Motor Vehicles Act, 1988 empowering the Central Government to frame a scheme for the provision of interim relief to claimants seeking or praying compensation under Chapter XI of the Act.

3. Further, the Hon'ble Supreme Court, through various judgments, has emphasised the necessity of providing timely financial support to victims of the Road Accidents or to their dependents. The Hon'ble Court, vide its order dated 28.04.2025 in IA No. 76249 of 2024 in Writ Petition (C) No. 295 of 2012, titled "S. Rajaseekaran vs. Union of India & Ors.", directed the Central Government to frame an appropriate scheme under Section 164A of the Act to provide interim financial assistance to accident victims.

4. In exercise of the power conferred under Section 164A of the Act, the scheme for interim relief has been framed. The Scheme document titled "Compensation to Victims (Interim Relief) Scheme, 2026" is enclosed as an annexure. You are requested to circulate the contents of this communication among all concerned officers/officials within your organization/department for information and necessary action.

5. This issues with the approval of the Competent Authority.
