2. The Grant of higher pay scale is subject to the undertaking that in the event of over payment, which may be detected at a larger stage the same will be recovered from their pay.
3. The concerned HOO/Superintendents are requested to verify/check the service particulars of above said officers with regard to date of appointment etc as mentioned above are correct and also to ensure that all the conditions prescribed above have been fulfilled and complied with. Discrepancy, if any, be brought to notice of this office and the orders in respect of such officers may not be implemented till clarification from this office.
4. The concerned Head of office/Superintendent are requested to ensure, before issuing final orders, that the official is eligible for grant of financial up-gradation under ACP/MACP and clear from Vigilance angle on or before the date of eligibility before releasing the grant of financial up-gradation under ACP/MACP scheme. In case of any discrepancy, the same may be intimated to the undersigned immediately.

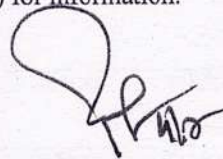
