The promotion of the above mentioned Matrons as per details mentioned against their individual names to the post of Head Matron on Regular Basis subject to outcome of SLP(C) No. 30621/2011 6915/2014 & SLP (C) No. 031288/2017 and other connected cases before the Hon'ble Supreme Court.

The officials promoted may exercise option for fixation of pay in terms of FR 22 within one month from the date of promotion or appointment as Head Matron. However, if the official who have already been granted financial up-gradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.

Their inter-se-seniority on promotion shall be same as their relative seniority in the lower grade from which they are promoted.

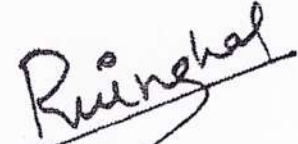
Consequent upon their promotion to the post of Head Matron the above Officials shall continue to work physically at their present place of posting till further orders.



The Head of Office concerned should ensure that before issuing final order/taken on strength order/relieving order, it may be verified that no disciplinary proceeding is pending or any penalty is in operation against the above mentioned officials. If the official is not clear from vigilance angle or any currency of penalty is there as on the date or has resigned/expired etc., the same may be brought to the notice of Superintendent-I (PHQ) immediately.

The benefits of promotion will be admissible with effect from the actual date of joining of the official to the post of Head Matron.

This issues with approval of the Competent Authority.



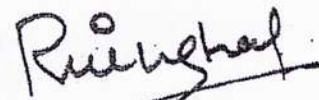
