**ORDER**

(iii) The applicants shall be entitled to consequential benefits in accordance with the relevant rules and instructions on the subject;"

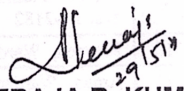

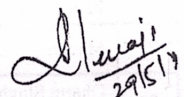
