QUALIFICATION :-

For Sr. Residents:-

The minimum qualification for the post of Sr. Resident in any specialty will be a postgraduate degree or a Diploma in a concerned specialty from recognized university/institution.

If candidates having post graduate Degree or a diploma are not available in any particular specialty then candidates who have 02 years post MBBS Experience with at least 01 year in concerned Speciality from a Govt./Delhi Govt. panel Hospital will be considered for the selection.
