* S No # 3 shall be deported to his native country (Nation) immediately upon his release, in accordance with law and the applicable procedure.

The recommendations of the Board are subject to the certain conditions to be followed strictly by respective convicts, as mentioned below:

Conditions	Applicable to convicts
(i) The convict shall not enter the NCT of Delhi for a period of one year from the date of his release from jail, except with prior intimation to the concerned police authorities for cogent reason.	Condition No. (i) & (ii) shall be applicable for convict mentioned at S No. 1,2,4,7, 10, 12,14,19,20, 21, 22,& 26.
(ii) The convict shall report to the SHO of his native police station during the first week of every month for a period of one year from the date of his release from jail.	Condition No. (ii), shall be applicable for convict mentioned at S No. 5,6,8,9,11,13,15,16, 17, 18, 23, 24 & 25
(iii) The convict shall be deported to his native country (Nation)	Condition No. (iii), shall be applicable for convict mentioned at Item No. 3

If any of the above mentioned convicts violates Delhi Prisons Rules with regard to Furlough/Parole granted by the Competent Authority or by any Court of Law, he/she shall be treated in accordance with rules for remission/premature release.

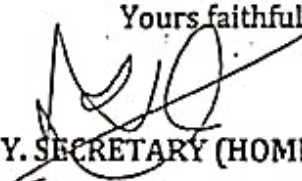
