

Appellant Ms. Ritu Dahiya D/o Sh. Dayaram Dahiya is not present for hearing. Sh. Vivek Kohli, SO, Esstt. Branch (PHQ) is present for hearing on behalf of PIO PHQ and Sh. Ajay Dalal, RMO, Central Jail Hospital, Tihar, New Delhi is also present for hearing.

Case heard. Through the appeal, the appellant has stated that the PIOs have provided incomplete, misleading or false information. The replies of PIO PHQ and PIO/RMO, CJH, Tihar are available in the record. During the course of hearing, the representative of the PIO PHQ has stated that there are total 40 posts of Counsellor sanctioned in Delhi Prison Department. All the 40 posts are lying vacant and the encadrement of these posts are with Social Welfare Department. However, the said application has already been transferred to concerned PIO i.e. PIO, Department of Social Welfare, GLNS Complex, Delhi Gate for further necessary action. The appellant has also confirmed through email dated 24/03/2022 that the department has provided the information wherein she is satisfied with the information and no further information is required. In view of the above submissions, no further direction is to be required.

Case is accordingly disposed off. If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
