Case heard. Through the appeal, the appellant has stated that the reply of PIO CJ-1, 3, 4, 8/9 and 16 are not received as well as reply of PIO PHQ is not received after deposit of addl. Fees of Rs. 22/-. The APIO PHQ is stating in the hearing that the reply was sent to the appellant on 29/11/2021 but the same was returned by Indian Post Department without delivery. The same is handed over to the appellant during the course of hearing and the appellant is satisfied with the reply of PIO PHQ. Further, the PIO CJ-1, 3, 4, 8/9 and 16 are directed to send the reply again to the appellant within seven days.

Case disposed off. If the applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
