
Case heard. Through the appeal, the Appellant has stated that the reply with regard to the information sought at S. No. 1 (a) of this application dated 04/02/2022 is not satisfactory as per the provisions under RTI Act 2005. The appellant has however, cited reasons for his 'non-satisfaction' with the reply of the SPIO.

During the hearing, the representative of PIO PHQ has stated that the appellant has sought the copy of reply filed before the Hon'ble Court of Sh. Ajay Kumar Kuhar, ASJ/Special Judge (PC Act), Rouse Avenue Court, New Delhi by Prison Authority against the application of UTP Sukesh Chandershekhar S/o Vijayan Chandrashekhar. The case is still pending adjudication and providing the requested information to the Appellant would impede the process of investigation or apprehension or prosecution of offenders. Hence, the disclosure of requested information is exempt under section 8 (1) (h) of the RTI Act 2005.

I have carefully considered the submission of the Appellant made in his appeal dated 04/03/2022 and PIOs order dated 22/02/2022 and oral submission made by the representative of the PIO (PHQ). I, therefore, do not find any reason to interface with the reply given by the PIO as the PIO has correctly denied to provide the requested information by invoking the provision of section 8 (1) (h) of the RTI Act 2005. No further action is required.

Case is accordingly disposed off.

If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
