Appellant Sh. Sunil Kumar, Ex. Supdt. is not present being jail inmate. He has however requested for hearing through video conferencing which could not be finalised. Sh. Ghanshyam-AS is present for hearing on behalf of PIO CJ-1, Sh. Mohit Bansal-AS is presently for hearing on behalf of PIO CJ-4 and Sh. Jitender Patel-AS is presently for hearing on behalf of PIO CJ-10

Case heard. The Appellant vide his application dated 14/01/2022 has asked for medical records of UTP Sukesh Chandrashekhar S/o Vijayan Chandrashekhar. The application, after transfer from CJ-10 to CJ-4 to CJ-1, has been replied by SPIO CJ-1 where the UTP is at present lodged. It is to note here that Medical Records of an inmate in Delhi Prisons moves with the inmate's lodgements in a jail.


Since, the information sought are "Third Party Information" hence the PIO CJ-1 invoked section 11 of the RTI Act 2005 and sought submission of the third party (in this case JTP Sukesh Chandrashekhar S/o Vijayan Chandrashekhar). Based on the written submission of third party, the SPIO CJ-1 has, vide his communication dated 23/03/2022, denied to provide the requested information to the appellant.

I have gone through the record available on file, including the written submission of the third party. The information sought relate to medical records of UTP Sukesh Chandrashekhar, which are personnel information of an individual the disclosure which has no relation to any public activity or interest, and revelation of which can cause unwarranted invasion of the privacy of the individual.

Therefore in my opinion, the SPIO CJ-1 has rightly denied the requested information to the Appellant.

Case is accordingly disposed off.

If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
