

Ravi Kumar, HW-1334 from CJ-10, Sh. Sachin Rana, AS from CJ-11, Sh. Anand Prakash, H.W.-1136 from CJ-12, Sh. Ash Mohd. H.W. -803 from CJ-13, Sh. Vikas, AS from CJ-14, Sh. Case heard. Through the appeal, the appellant has stated that the PIO CJ-1, 3 and 16 have not provided the information within the time limit. He has also stated that replies of other PIOs in respect to the working hours/days are mismatched.

During the course of hearing, the representatives of the PIO CJ-1, 3 and 16 are stated that the replies have been provided the reply to the appellant. Further, all representative of the PIOs are clarified that the working number of days of inmate in a month may be differ according to the requirement of work or presence of the inmate at workplace. The replies of all the PIOs perused and found to be satisfactory except PIO CJ-1. The PIO CJ-1 is directed to provide appropriate information to the appellant for query no. 4.

Case disposed off. If the applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
