Appellant Sh. Sunil Kumar, Ex. Supdt. is not present for hearing being jail inmate. Sh. -Jitender Patel, AS is present for hearing on behalf of PIO CJ-10. Sh. Amresh Kumar Goel, Dy. Supdt./APIO (PHQ) is present for hearing on behalf of PIO PHQ.

Case heard. Through the appeal, the Appellant has stated that the reply with regard to the information sought at S. No. 1 (a) & 1 (b) of this application dated 04/04/2022 is not satisfactory as per the provisions under RTI Act 2005. The appellant has however, cited reasons for his 'non-satisfaction' with the reply of the SPIOs.

During the hearing, the representative of PIO CJ-10 vide his communication dated 18/05/2022 has stated that the information asked by the appellant cannot be traced despite of best effort. Hence, the appellant informed accordingly vide reply dated 02/04/2022 and 19/04/2022.


It has also been noticed that the appellant has already filed 1st Appeal before the undersigned on similar issue wherein the undersigned has already been order to PIO CJ-10 to trace the file and furnish the requested information as per RTI Act.

In the present matter, the appellant has filed a fresh application on similar issue providing the File No. 003609704 which was accessible to the appellant vide previous order dated 25/03/2022 and asked the information again as per RTI Act.

Since, the matter has already been heard in first appeal by the undersigned and order passed but now the appellant want to hear his grievance through another appeal. RTI Act, 2005 is not a grievance redressal forum. For the redressal of grievance, the Appellant is advised to approach the appropriate Public Authority. No further action is required in the present matter with this authority.

Case is accordingly disposed off.

If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Mumirka, New Delhi-67.
