Appellant Sh. Pankaj Kumar is not present for hearing. Sh. Ghanshyam Das, AS from CJ-1, Sh. Chetram Meena, HW from CJ-2, Sh. Deepak Mann, AS from CJ-3 and Sh. Rohit Mann, AS from CJ-4 are present from hearing on behalf of their PIOs.

Case heard. Through the appeal, the appellant has stated that the PIOs have not provided the satisfactory reply. The replies of PIOs are as under:-

Reply of:-

PIO CJ-1- Information is exempted under section 8 (1)(g) of RTI Act 2005.

PIO CJ-2- Information cannot be provided in view of Section 8(1) (j) of RTI Act 2005.


PIO CJ-3- As per given particulars given by the petitioner, the said accused is not traceable in this jail.

PIO CJ-4- As per record Kartar Singh s/o Sh. Tej Ram was not lodged in this jail in the year 1986.

During the appeal, the representative of the PIOs has stated that the person whose information was asked in the application is not traceable, however, the PIO CJ-1 has denied to provide the information in view of section 8 (1) (g) of the RTI Act and PIO CJ-2 has denied to provide the information being 3rd Party information.

Since, the information asked by the applicant pertains to third Party and it has also been observed that the person whose information was asked by the applicant is not traceable with given particulars. Hence, the replies given by the PIOs found to be satisfactory. No further action is required.

Case is accordingly disposed off. If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
