
Case heard. Through the appeal, the Appellant has stated that the reply of PIO CJ-10 dated 05/05/2022 is unsatisfactory as the desired information i.e. requisite MoMs & Letter sent to Police Authorities were sent/issued under the sign of the Appellant only and in no way endanger the life, safety, security of any person or identify the source of information or assistance given in confidence for law enforcement or security purposes.

The PIO CJ-10 vide rejoinder dated 03/06/2022 has again submitted that the information sought by the appellant is related to the person/post who is directly involve to maintain safety/security/maintenance/discipline of Jail sharing of which could endanger the life or physical safety of any person security point of Jail or identify the source of information or assistance given in confidence for law enforcement or security purposed, hence cannot be disclosed as per section 8 (1) (g) of RTI Act 2005.

Further, the PIO CJ-10 has also describe the section 91 of Code of Criminal Procedure, 1973, in respect of the Criminal Case pending, the Petition/Appellant herein has remedies before the respective for to seek summoning of the relevant records.

I have gone through the materials placed on record and hold that while the requested information at S. No (a) of the application 07/04/2022 of the Appellant does fall under the exemption provision of the section 8 (1) (g) of the RTI Act 2005, however information sought at S. No. (b) and (c) of the application dated 07/04/2022 of the Appellant/Applicant does not fall under the exemption provision of Section 8(1) (g) of the RTI Act 2005. Hence, these may be provided by the PIO to the Applicant within seven day of receipt of this order subject to the provisions of section 8 and 10 of the RTI Act 2005.

The case is accordingly disposed off. If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
