Case heard. Through the appeal, the Appellant has stated that she wants the list of the inmates who are differently-abled and senior citizens. She also requested to further proceed the RTI application to Rohini Jail Complex and Mandoli Prisons Complex.

During the course of hearing of 1^{st} Appeal, it has been stated by Sh. Amresh Kumar Goel, APIO (PHQ) that the application of Ms. Shiwangini was received at Prisons Head Quarter on 30/04/2022 through online portal and the same has been forwarded to all PIOs of Central Jail-1 to 16 for further necessary disposal and reply to the appellant on Point No-3 and 5 (part) from PHQ level.

On perusal of the records available in file, all the PIOs have been provided most of the information to the appellant, however, information on one or two queries like number of Prisoners who are differently abled, number of prisoners who are senior citizens, number of prisoners released at the time of COVID etc. were not provided by some of the PIOs. Hence, all PIOs are directed to review their replies and provide the information on above mentioned queries also.

Moreover, the request of the Appellant in respect to list of prisoners cannot be provided in view of section 8 (1) (g) of the RTI Act 2005.

The case is accordingly disposed off. If applicant is not satisfied with this direction, he/she may file second appeal before the Hon'ble CIC, Baba Gang Nath Marg, Munirka, New Delhi-67.
