Minimum Academic/professional Qualification for appointment of Sr. Residents/Jr. Residents (MBBS& DENTAL)

For Sr. Residents:-

- 1. Post graduate Degree/Diploma from recognized university/institution.
- In case of non-availability of P.G degree/ diploma, the candidates having MBBS degree with minimum 02 years work experience in Govt. Hospital (out of which one year should be in the speciality concerned) may be considered.

For Jr. Residents (MBBS):-

- 1. MBBS from recognized university/institution.
- 2. Internship completion certificate, internship not more than 02 years old as on date of Interview.

For Jr. Residents (DENTAL):-

BDS degree from recognized university/ institution with internship completion certificate. Registration with Delhi Dental Council is compulsory. Candidates who have completed internship earlier than 02 years on the date of interview shall not be eligible.

AGE LIMIT:

FOR FRESH CANDIDATES:-

For Sr. Residents: - 37 years for General, 40 years for OBC [Non-creamy layer belonging to Delhi only] and 42 years for SC/ST candidates as on date of interview.

For Jr. Residents (MBBS & DENTAL): - 30 years for General category 33 years for OBC [Noncreamy layer belonging to Delhi only] and 35 years for SC/ST candidates as on date of interview.

CANDIDATES UNDER RELAX NORMS

In case of non-availability of candidates, for the post of Sr. Residents and Jr. Residents (MBBS), as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi with the following relaxation.

Sr. Residents:-

- 01. Upper age limit for eligibility under relaxation will be 40 years.
- 02. Senior Residents who have completed Three year of Senior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Senior Residents are available. There would be no extension for any senior resident beyond one year appointed under this relaxed Provisions.

Jr. Residents (MBBS)

01. Upper age limit for eligibility under relaxation will be 40 years.

02. Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as

Junior Resident, if fresh graduate are not available.

03. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any junior resident beyond one year appointed under this relaxed provisions.

TENURE OF RESIDENCY:-

For Sr. Residents, on regular basis

Sr.; Residents will be initially appointed for a period of one year which shall be extended for a further period of one years followed by another one year, on the written request of concerned Sr. Resident and only on satisfactory work and conduct report from the respective Incharge. If a candidate has done Senior Residency from any Govt./Govt aided institute, but total duration done is less than three years , then he/she is eligible for appointment for the rest of the tenure so as to complete three years tenure of Senior Residency. However, under $\underline{\mathbf{No}}$ circumstances, total duration of Sr. Residency will NOT exceed three years, including the tenure done elsewhere.

Sr. Residents/Jr. Residents MBBS/Dental (against Specialist/GDMOs/Dentist post), on adhoc basis:-

Initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Specialists is made by the government, the tenure can be further extended for a further period of 89 days (with one day compulsory break) time to time for a maximum period of 03 years in case of Sr. Residents and One year in case of Jr. Resident (MBBS & Dental) OR till regular appointment of Specialists is made by the Government under any scheme or proposal OR till fresh selection process is carried out whichever is earlier.

For Jr. Residents (MBBS): on regular basis

ON REGULAR BASIS: - Initially appointed for a period of Six (06) months and the same can be extended for a further period of Six (06) months subject to satisfactory work and conduct report and performance. Total duration of Jr. Residency will not be more than One (01) year from the date of joining. If a candidate has done Junior Residency from any Govt./Govt aided institute, but total duration done is less than One year, then he/she is eligible for appointment for the rest of the tenure so as to complete one year tenure of Junior Residency. However, under No circumstances, total duration of Jr. Residency will NOT exceed one year, including the tenure done elsewhere.

EMOLUMENTS:

For Sr. Residents: - As per 7th CPC pay matrix level 11, Pay Rs. 67700/- plus usual allowances as admissible under the rules.

For Jr. Residents (MBBS & Dental):- As per 7th CPC pay matrix level 10, Pay Rs. 56100/- plus usual allowances as admissible under the rules.

GENERAL TERMS AND CONDITIONS/REQUIREMENTS:-

- Number of posts advertised is provisional and subject to change according to vacancies without any notice.
- 2. Category-wise wait listed candidates will be prepared for filling up the posts of Sr. Residents/Jr. Residents, on regular basis against the sanctioned posts of Sr. Residents /Jr. Residents and on adhoc basis against the sanctioned posts of Specialists/GDMOs likely to be created or arise/vacant in future. The panel shall remain valid for 06 months from the date of declaration of result OR till fresh selection process is carried out, whichever is earlier.
- 3. Registration with Delhi Medical Council/Delhi Dental Council is compulsory as on date of interview. If No DMC/DDC certificate available, candidate will not be allowed for interview.
- 4. In case of non availability of SC, ST and OBC candidates are not available for the posts , the seats shall be filled up from general category on adhoc basis and vice versa.
- 5. The decision of selection board will be final and binding and no representation will be entertained in this regard.
- 6. All appointment shall be subject to medical fitness and verification of certificates of education qualification/age/caste/submission of valid DMC/DDC post graduates registration certificate.
- 7. No TA/DA will be paid for participating in selection process.
- 8. Candidates applied under the OBC category, must have valid OBC certificate (non-creamy layer) issued in 2019-2020 at the time of document verification / interview, failing which candidate will not be allow for interview.
- Candidates applied under EWS category, must have valid EWS certificate at the time of document verification/interview, failing which candidate will not be allow for interview.
- 10. Selected candidates who accept the offer of appointment and join the Hospital will not be given NOC of any kind, for any purpose what so ever (passport, visa, applying for job elsewhere etc.).


