The details regarding educational qualification, emoluments, age limit, terms and conditions etc, in r/o Sr. Residents and Jr. Residents [MBBS] are as under:-

Minimum Academic/professional Qualification for appointment of Sr. Residents/Jr. Residents (MBBS), required as per R.Rs

For Sr. Residents:-

1. Post graduate Degree/Diploma from recognized university/institution
2. In case of non-availability of P.G degree/ diploma, the candidates having MBBS degree with minimum 02 years work experience in Govt. Hospital (out of which one year should be in the speciality concerned) may be concerned.

For Jr. Residents:-

1. MBBS from recognized university/institution
2. Internship completion certificate, not more than 02 years old as on date of interview.

AGE LIMIT:

For Sr. Residents :- For Sr. Residents:- 37 years, 03 years relaxable for OBC candidates [belonging to Delhi only] and 05 years to SC/ST candidates as on the date of interview.

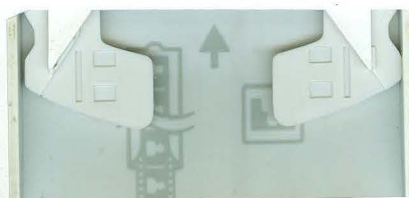
For Jr. Residents(MBBS): - 30 years for General category candidates and 03 years relaxable for OBC candidates [belonging to Delhi only] and 05 years to SC/ST candidates on the date of interview.

Further in case of non-availability of candidates, for the post of Sr. Residents and Jr. Residents (MBBS), as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi with the following relaxation.

Sr. Residents:-

1. Upper age limit for eligibility under relaxation will be 40 years.
2. Senior Residents who have completed Three year of Senior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Senior Residents are available. There would be no extension for any Senior resident beyond one year appointed under this relaxed Provisions.

Jr. Residents (MBBS)

1. Upper age limit for eligibility under relaxation will be 40 years.
2. Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Resident, if fresh graduate are not available.
3. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any junior resident beyond one year appointed under this relaxed Provisions.

TENURE OF RESIDENCY:-

SR. RESIDENTS:-

Initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment is made by the government, the tenure can be further extended, subject to satisfactory work and conduct report, for a further period of 89 days **(with compulsory one day break)** time to time for a maximum period of 03 years from the date of joining OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier.

JR. RESIDENTS (MBBS):-

Initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment is made by the government, the tenure can be further extended, subject to satisfactory work and conduct report, for a further period of 89 days **(with compulsory one day break)** time to time for a maximum period of 01 year from the date of joining OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier.

EMOLUMENTS:

For Sr. Residents: - As per 7th CPC pay matrix level 11, Pay Rs. 67700/- plus usual allowances as admissible under the rules.

For Jr. Residents (MBBS):- As per 7th CPC pay matrix level 10, Pay Rs. 56100/- plus usual allowances as admissible under the rules.

Other eligibility norms/General Conditions/Requirements:-

1. Registration with Delhi Medical Council is compulsory as on date of interview
2. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change in any stage.
3. Appointment shall be subject to medical fitness and verification of educational certificates.
4. Candidates applied under the OBC category, must have valid OBC certificate, issued from the Competent Authority of GNCT of Delhi.
5. No TA/DA will be paid for appearing in the interview.
6. In case of non availability of SC, ST and OBC candidates, as the case may be, the posts shall be filled for 89 days on adhoc basis from General Category Candidates and vice versa.

7. Panel of wait listed candidates will be prepared and if any vacancies arising in future, the same will be filled from the panel. The Panel shall be valid for 06 months from date of result of the interview OR till fresh selection process is carried out, whichever is earlier.

Time and place for registration and interview:-

The interested and eligible Candidates are required to report on 26.06.2019 (for Sr. Residents posts) and on 27.06.2019 (for Jr. Residents posts) between 10:00 AM to 11:00 AM for registration for the walk-in-interview at **Prison Head Quarter, Near Lajwanti Garden Chowk , Janak Puri, New Delhi-110058.**

01. 10th/Matric/secondary pass certificate.
02. 12th/Senior Secondary/10+02 pass certificate.
03. MBBS certificate alongwith Marksheets of each year.
03. Internship certificate.
04. Post graduate Degree/Diploma alongwith mark sheet in case for applying for the posts of Sr. Residents.
05. Caste certificate (in case of applying under reserve category)
06. Attempt Certificate.
07. DMC registration.
08. Aadhaar card and a proof of permanent address.
