Residents and Jr. Residents [MBBS and Dental] are as under:-

Qualification for Sr. Residents:- P.G Degree/Diploma/DNB from a recognized University/Institution in respective speciality and candidate must not have completed 03 years Senior Residency in any recognized institution including regular and adhoc period. In the event of non-availability of PG degree/diploma holder, candidate having MBBS degree with minimum 02 years work experience in Govt. Hospital [out of which at least one year should be in the speciality concerned] may be considered. Registration of PG/Diploma/DNB in speciality with **Delhi Medical Council is compulsory** 

#### QUALIFICATION FOR JR. RESIDENTS (MBBS):-

MBBS from recognized university/institution with internship completion certificate. Registration with Delhi Medical Council is compulsory. Candidates who have completed internship earlier than 02 years on the date of interview shall not be eligible. However, they may apply under relax norms of GOI's residency scheme.

#### Jr. Residents [DENTAL]:-

Qualification: - BDS degree from recognized university/ institution with internship completion certificate. Registration with Delhi Dental Council is compulsory. Candidates who have completed internship earlier than 02 years on the date of interview shall not be eligible. However, they may apply under relax norms of GOI's residency scheme.

#### TENURE OF SR. RESIDENTS & JR. RESIDENTS (MBBS/DENTAL)

Initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment is made by the government, the tenure can be further extended for a further period of 89 days, after giving one day break, time to time maximum upto three years in case of Sr. Residents and One year in case of Jr. Residents (which will be counted from the date of joining of the resident Doctor) OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. The extension is subject to satisfactory work and conduct report of the concerned Resident Doctor.

#### **EMOLUMENTS:**

For Sr. Residents:- As per 7<sup>th</sup> CPC pay matrix level 11, Pay Rs. 67700 plus allowances as admissible under the rules.

For Jr. Residents (MBBS & Dental):- As per 7<sup>th</sup> CPC pay matrix level 10, Pay Rs. 56100 plus allowances as admissible under the rules.

#### AGE LIMIT:

For Sr. Residents: - 40 years for General category candidate and 43 years relaxable for OBC category candidates on the date of interview. OBC certificate alongwith creamy layer must be issued by the GOVT. of NCT of Delhi only. OBC certificate issued from other state/union territory will not be considered.

For Jr. Residents (MBBS):- 30 years for General category candidate, 33 years for OBC category candidate and 35 years for SC/ST candidates as on the date of interview. OBC certificate alongwith creamy layer must be issued by the GOVT. of NCT of Delhi only. OBC certificate issued from other state/union territory will not be considered.

For Jr. Residents (Dental):- 30 years for General category candidate, 33 years for OBC category candidate. OBC certificate alongwith creamy layer must be issued by the GOVT. of NCT of Delhi only. OBC certificate issued from other state/union territory will not be considered.

Further in case of non-availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi with the following relaxation.

#### For Sr. Residents:-

- 1. In case of non-availability of fresh candidates for the post of Sr. Residents, Candidates who have completed 03 years of Residency as Senior Residents may be allowed to appear in the interview.
- 2. Separate merit list for a fresh candidates and for other i.e. those who have already completed three years of Senior Residency would be prepared.
- 3. Firstly, the list containing the name of fresh candidates would be exhausted for appointment as Sr. Resident and the second list would be used only after that. There would be no extension for any senior resident beyond one year appointed under above mentioned relaxed provisions.

#### For Jr. Residents

- Upper age limit for eligibility under relaxation will be 40 years.
  - 2. Post Graduate doctors who are interested to serve as Junior Residents will be Allowed to join as Junior Resident, if fresh graduate are not available.
  - Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any junior resident beyond one year appointed under this relaxed provisions.

#### Other General Conditions/Requirements:

- 1. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change.
- 2. Appointment shall be subject to medical fitness and verification of educational certificates.
- 3. No TA/DA will be paid for appearing in the interview.
- 4. In case of non availability of SC,ST and OBC candidates for SRs OR JRs as the case may be, the posts shall be filled from General Category Candidates and vice versa.
- 5. Panel of wait listed candidates will be prepared for filling the post of SR/JR for vacancies arising in future. The Panel shall be valid for 06 months or till fresh selection process is carried out, whichever is earlier.
