- (a) (i) Holding analogous post on regular basis in the parent cadre/ department; or
- (ii) With three years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs.5000-8000 or equivalent in the parent cadre/department: or
- (iii) With six years service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs.4500-7000 or equivalent in the parent Cadre/department: and
- (b) Possessing the following educational qualification and experience:-
- (I) Degree in Law from a recognized university or equivalent.
- (II) Two years experience as a legal practitioner or two years experience in legal work in a Govt. deptt. or autonomous bodies/public sector undertakings.
