1. The crucial date for determining the age limit shall be the closing date for receipt of applications from candidates except for the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of J&K State, Lahaul & Spiti Distt. And Pangl Sub Division of Himachal Pradesh, Andaman Nikobar Islands and Lakshadweep).
2. The age limit for direct recruitment will be relaxable i.e. in the case of Scheduled Castes / Tribes candidates and other special categories of persons in accordance with the general orders issued from time to time by the Central Govt.
3. Nothing in these rules shall affect reservations and other concessions required to be provided for Scheduled Castes & Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Govt. from time to time in this regard.
4. No male candidate who has more than one wife living or no female candidate who has married a person already having a wife living shall be eligible for appointment in case direct recruitment provided that the administrator, Delhi may after being satisfied that there are special grounds for doing so, exempt any such candidate from the operation of this rules.
5. where the administrator is of the opinion that it is necessary or expedient so to do, he may, by order for reasons to be recorded in writing relax any of the provisions of these rules with respect to a class or category of persons / posts.
