The registration time for the candidates will be 10:00 A.M to 11:00 A.M. No candidate will be allowed for registration/interview reported after 11:00 A.M.

OBC with creamy layer and EWS certificate must be issued within one year from the date of interview by Competent Authority of GNCT Delhi Only. Other state OBC and EWS will not be considered.

The details regarding educational qualification, emoluments, age limit, terms and conditions etc, in r/o Sr. Residents and Jr. Residents [MBBS] are as under:-

Minimum Academic/professional Qualification :-

For Sr. Residents:-

- 1. Post graduate Degree/Diploma from recognized university/institution
- 2. In case of non-availability of P.G degree/ diploma, the candidates having MBBS degree with minimum 02 years of work experience in Govt. Hospital out of which one year should be in the speciality concerned may be considered for selection.

For Jr. Residents (MBBS):-

- 1. MBBS from recognized university/institution.
- 2. Internship completion certificate, internship not more than 02 years old as on date of interview i.e on 20.05.2022.

AGE LIMIT:

For Sr. Residents: - 45 years for General, 48 years for OBC [belonging to Delhi only] and 50 years for SC/ST candidates as on date of interview.

For Jr. Residents(MBBS): - 30 years for General category 33 years for OBC [belonging to Delhi only] and 35 years for SC candidates as on date of interview.

Further in case of non-availability of candidates, for the post of Sr. Residents and Jr. Residents (MBBS), as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996/2045 Dated 10.06.2011, issued by H&FW Department, GNCT of Delhi, with the following relaxation.

Sr. Residents:-

1. Senior Residents who have completed Three year of Senior Residency may be allowed to again appear for interview for selection and will be offered residency only <u>if</u> no fresh Senior Residents are available. There would be no extension for any senior resident beyond one year appointed under this relaxed Provision.

Jr. Residents (MBBS):-

- 1. Upper age limit for eligibility under relaxation will be 40 years.
- 2. Post Graduate doctors who are interested to serve as Junior Residents will be allowed to join as Junior Resident, if fresh graduate are not available.
- 3. Junior Residents who have completed one year of Junior Residency may be allowed to again appear for interview for selection and will be offered residency only if no fresh Junior Residents are available. There would be no extension for any junior resident beyond one year appointed under this relaxed provisions.

TENURE OF RESIDENCY:-

For Sr. Residents

<u>ON ADHOC BASIS</u>: - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Sr. Residents is made by the government, the tenure can be further extended for a further period of 89 days (with one day compulsory break) time to time for a maximum period of 03 years OR till regular appointment of Sr. Residents is made by the Government under any scheme or proposal, whichever is earlier.

For Jr. Residents (MBBS):-

<u>ON ADHOC BASIS</u>: - initially appointed for a period of 89 days OR till regular appointment is made by the Government under any scheme or proposal, whichever is earlier. In case of no regular appointment of Jr. Residents (MBBS) is made by the government, the tenure can be further extended for a further period of 89 days (with one day compulsory break) time to time for a maximum period of One year (which will be count from the date of joining of the candidate) OR till regular appointment of Jr. Resident (MBBS) is made by the Government under any scheme or proposal, whichever is earlier.

Note: - if any candidate has served/worked as a Sr. /Jr. Resident, either on regular basis OR on adhoc basis, in any Govt. Hospital/Institution earlier, the residency period will be deducted/adjusted from/in the tenure of selected Sr. /Jr. Resident.

EMOLUMENTS:

For Sr. Residents: - As per 7th CPC pay matrix level 11, Pay Rs. 67700/- plus usual New Delhi-11006/ allowances as admissible under the rules.

For Jr. Residents (MBBS):- As per 7th CPC pay matrix level 10, Pay Rs. 56100/- plus usual allowances as admissible under the rules.

OTHERS ELIGIBLITY NORMS/GENERAL CONDITIONS/REQUIREMENTS ARE AS UNDER:-

- 01. Registration with Delhi Medical Council/Acknowledgement for the same is mandatory as on date of interview.
- 02. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change in any stage.
- 03. Appointment shall be subject to medical fitness and verification of educational Certificates.
- 04. No TA/DA will be paid for appearing in the interview.
- 05. In case of non availability of SC and OBC candidates, the posts shall be filled from General Category Candidates and vice versa.
- 06. The selected candidate can be posted in any Jail of Delhi Prisons as per requirement i.e in Tihar, Rohini and Mandoli.
- 07. Panel of wait listed candidates will be prepared and if any vacancies arising in future, the same will be filled from the panel. The Panel shall be valid for 06 months from date of publication of result of the interview OR till fresh selection process is carried out, whichever is earlier.
- 08. If any information submitted/provided by the candidate found fake / incorrect at any level, the candidature is liable to be cancelled.

- 07. EWS certificate in case of applying under EWS category.
- 08. Attempt Certificate.
- 09. DMC registration.
- 10. Aadhaar card and a proof of permanent address.
