**RECOMMENDATIONS OF THE SENTENCE REVIEWING BOARD FOR
PREMATURE RELEASE OF LIFE CONVICTS IN THE MEETING HELD UNDER THE
CHAIRMANSHIP OF THE HON'BLE HOME MINISTER OF DELHI AT 11:00 AM ON
01.09.16, AT DELHI SECRETARIAT, NEW DELHI- 110002.**

A meeting of the **Sentence Reviewing Board** (hereinafter referred to as **Board**) was held on **01ST of SEPTEMBER 2016** in the Conference Room, 7th Level "A" Wing, Delhi Secretariat under the **CHAIRMANSHIP OF HON'BLE HOME MINISTER, GOVT. OF NCT OF DELHI.**

On **01ST of SEPTEMBER 2016 at 11:00 A.M.**, the cases of **93 convicts (29 Fresh cases and 64 those cases which were rejected in the previous meetings)** in terms of **SRB Guidelines, 2004** and **Hon'ble Supreme Court order dated 22.03.2010 (State of Haryana Vs. Jagdish)** and **Hon'ble Supreme Court order dated 02.12.2015** were taken



up by the **Board** for recommending premature release on merits. The cases have been examined in the light of respective Court's Orders, SRB Guidelines and are fit & eligible to be placed before Sentence Reviewing Board and nothing has been concealed. Such recommendations for premature releases are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.

Cases were discussed and considered in the light of parameters like conduct of the prisoner during confinement in jail and parole/furlough, his/her age, the circumstances under which the crime was committed, nature & gravity of crime, his/her antecedents, prospects of rehabilitation, family responsibilities etc. Recommendations of the Jail, the Chief Probation Officer, and the Police were also taken into consideration while reviewing each case for premature release. It was also considered by the Board whether the convict has lost his potential for committing crime or not. The possibility of reclaiming the convict as a useful member of the society and his socio-economic condition were also evaluated by the Board.

FRESH CASES

1. DARSHANA W/O ROOP LAL---AGE-60 YRS (Female)

Convict Darshana w/o Roop Lal is undergoing life imprisonment in case FIR No. 215/02, U/S 302/34 IPC, P.S. Uttam Nagar, Delhi for committing murder of her daughter who was carrying unwed pregnancy of nineteen weeks.

Convict has undergone an actual sentence of 14 years, 02 months & 08 days excluding remission as on 30th of June 2016. She has undergone a total period of 18 years, 03 months and 03 days including remission earned by her. She has availed parole 04 times and furlough 04 times.

The Delhi Police has not opposed her premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended her premature release in its report as well as in the meeting. She has undertaken Stitching and cooking work in jail and her conduct had also been good in jail as well as on parole/furlough.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Darshana w/o Roop Lal.















2. SHAMA PRAVEEN W/O SHAMIM AHMED---AGE-42 YRS (Female)

Convict Shama Parveen w/o Shamim Ahmed is undergoing life imprisonment in case FIR No. 51/02, U/S 302/201/120B/34 IPC, P.S. Nand Nagri, Delhi for committing murder of her husband due to her extra marital affair.

Convict has undergone an actual sentence of 14 years, 02 months & 15 days excluding remission as on 30th of June 2016. She has undergone a total period of 16 years, 08 months and 10 days including remission earned by her. She has availed interim bail 01 time, parole 04 times and furlough 05 times.

The Delhi Police has not opposed her premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended her premature release in its report as well as in the meeting. She has undertaken Stitching and cooking work in jail and her conduct had also been good in jail as well as on parole/furlough.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Shama Parveen w/o Shamim Ahmed.

3. TOHID RAJA @ GUDDU S/O BAKAR RAJA---AGE-41 YRS

Convict Tohid Raja @ Guddu s/o Bakar Raja is undergoing life imprisonment in case FIR No. 51/02, U/S 302/201/120B/34 IPC, P.S. Nand Nagri, Delhi for committing murder of husband of Shama Parveen due to extra marital affair with her.

Convict has undergone an actual sentence of 14 years, 01 month & 18 days excluding remission as on 30th of June 2016. He has undergone a total period of 16 years, 06 months and 24 days including remission earned by him. He has availed interim bail 02 times, parole 01 time and furlough 01 time.

The Police (Delhi and home town) has opposed his premature release in its reports as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting. He has undertaken Carpentry work in jail factory and his conduct had also been good in jail as well as on parole/furlough.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Tohid Raja @ Guddu s/o Bakar Raja.



4. ANIL @ BUTA S/O HUKUM SINGH---AGE---35 YRS

Convict Anil @ Buta s/o Hukum Singh is undergoing life imprisonment in case FIR No. 136/02, U/S 302/34 IPC, P.S. Alipur, Delhi for committing murder of a person in a personal grudge.

Convict has undergone an actual sentence of 14 years, 00 month & 21 days excluding remission as on 30th of June 2016. He has undergone a total period of 15 years, 04 months and 03 days including remission earned by him. He has availed interim bail 01 time and parole 02 times. The convict is also convicted for 09 years imprisonment in case FIR No. 118/2011, U/s 307/386/332/34 IPC, PS Subzi Mandi. His overall jail conduct is also not satisfactory as multiple jail punishments are recorded in his name.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release. The members of the Board were not convinced for his premature release.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Anil @ Buta s/o Hukum Singh.

5. ANIL S/O RAM KISHAN @ RAM KISHORE---AGE---35 YRS

Convict Anil s/o Ram Kishan @ Ram Kishore is undergoing life imprisonment in case FIR No. 136/02, U/S 302/34 IPC, P.S. Alipur, Delhi for committing murder of a person in a personal grudge.

Convict has undergone an actual sentence of 14 years, 01 month & 12 days excluding remission as on 30th of June 2016. He has undergone a total period of 15 years, 09 months and 14 days including remission earned by him. He has availed parole 03 times and furlough 09 times. Convict is lodged in Semi Open Jail as his conduct in jail and during parole/furlough has been satisfactory. He has learnt Bakery work in Tihar Baking School.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting.

Convict Gulab Singh @ Hathi s/o Raj Singh is undergoing life imprisonment in case FIR No. 136/02, U/S 302/34 IPC, P.S. Alipur, Delhi for committing murder of a person in a personal grudge.

Convict has undergone an actual sentence of 14 years, 01 month & 21 days excluding remission as on 30th of June 2016. He has undergone a total period of 16 years, 00 months and 18 days including remission earned by him. He has availed parole 02 times and furlough 08 times. Convict is lodged in Semi Open Jail as his conduct in jail and during parole/furlough has been satisfactory. He has learnt Carpentry work in Jail Factory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Gulab Singh @ Hathi s/o Raj Singh.

7. PRAVEEN S/O RAMESH CHAND---AGE---33 YRS

Convict Praveen s/o Ramesh Chand is undergoing life imprisonment in case FIR No. 136/02, U/S 302/34 IPC, P.S. Alipur, Delhi for committing murder of a person in a personal grudge.

Convict has undergone an actual sentence of 14 years, 01 month & 13 days excluding remission as on 30th of June 2016. He has undergone a total period of 15 years, 11 months and 06 days including remission earned by him. He has availed parole 01 time and furlough 05 times. Convict is presently lodged in Semi Open Jail as his conduct in jail and during parole/furlough has been satisfactory. He has learnt Carpentry work in Jail Factory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting.









After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Praveen s/o Ramesh Chand.

8. BALJEET S/O PASHUPATI---AGE---36 YRS

Convict Baljeet s/o Pashupati is undergoing life imprisonment in case FIR No. 87/02, U/S 302 IPC, P.S. O.I.A, Delhi for committing murder of a person in a personal grudge.

Convict has undergone an actual sentence of 14 years, 00 month & 00 days excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 05 months and 12 days including remission earned by him. He has availed parole 03 times and furlough 05 times. Convict is lodged in Semi Open Jail as his conduct in jail and during parole/furlough has been satisfactory. He has learnt Typing and cooking in Jail.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Baljeet s/o Pashupati.

9. CHAMAN LAL S/O RAM PRASAD---AGE---47 YRS

Convict Chaman Lal s/o Ram Prasad is undergoing life imprisonment in case FIR No. 580/91, U/S 302/307 IPC, P.S. Trilok Puri, Delhi for committing murder of a lady over a trivial issue.

Convict has undergone an actual sentence of 14 years, 01 month & 29 days excluding remission as on 30th of June 2016. He has undergone a total period of 16 years, 06 months and 24 days including remission earned by him. He has availed parole 02 times and furlough 14 times. Convict is lodged in Semi Open Jail as his conduct in jail and during parole/furlough has been satisfactory. He has learnt cooking in Jail.

The Police (Delhi and home town) has opposed his premature release in its reports as well as in the meeting. The Probation Officer, Delhi has recommended his premature release. Lt. ASJ opposed the release of the convict in view of nature of crime, but the other members



stressed upon the release of the convict in view of his unblemished jail conduct and during parole/furlough availed 16 times.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Chaman Lal s/o Ram Prasad.

10. DINESH TIWARI S/O RAM NATH---AGE---41 YRS

Convict Dinesh Tiwari s/o Ram Nath is undergoing life imprisonment in case FIR No. 580/95, U/S 302/394/397/34 IPC, P.S. Seelam Pur, Delhi for committing murder of a person during dacoity. The case is taken up in terms of order of Hon'ble Supreme Court of India dated 22.03.2010 in case of Jagdish Versus State of Haryana.

Convict has undergone an actual sentence of 15 years, 02 month & 01 day excluding remission as on 30th of June 2016. He has undergone a total period of 19 years, 00 months and 13 days including remission earned by him. He has availed parole 04 times and furlough 06 times. His conduct in jail as well as during parole/furlough is satisfactory. He has learnt Carpentry work in jail. He has been booked in another case FIR No. 20/2010, U/s 394/397 IPC, PS Mandir Marg which is pending.

The Delhi Police opposed his premature release in its report as well as in the meeting in view of murder committed during dacoity. However, the home town police not opposed the premature release. The Probation Officer, Delhi and home town has recommended his premature release in its reports. The members of the Board were not convinced for his premature release.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Dinesh Tiwari s/o Ram Nath.

11. GULAB @ GURU S/O BENI RAM---AGE---36 YRS

Convict Gulab @ Guru s/o Beni Ram is undergoing life imprisonment in case FIR No. 131/02, U/S 302/34 IPC, P.S. Badar Pur, Delhi for committing murder of a person over a trivial issue.

Convict has undergone an actual sentence of 14 years, 02 month & 12 days excluding remission as on 30th of June 2016. He has undergone a total period of 16 years, 04 months

and 28 days including remission earned by him. He has availed parole 04 times and furlough 09 times. He did not surrender after parole/furlough on due date i.e. on 01.03.2014 and later arrested on 12.03.2014. He has learnt Carpentry work in the jail.

The Delhi Police has not opposed his premature release in its report but opposed in the meeting. The Probation Officer, Delhi has recommended his premature release in its report. The members of the Board were not convinced for his premature release in view of not surrender in time from parole/furlough and later arrested by the police.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Gulab @ Guru s/o Beni Ram.

12. IBRAHIM S/O YUSUF---AGE---39 YRS

Convict Ibrahim s/o Yusuf is undergoing life imprisonment in case FIR No. 200/02, U/S 302/392 IPC, P.S. Sultan Puri, Delhi for committing murder of a person during robbery.

Convict has undergone an actual sentence of 14 years, 03 months & 29 days excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 02 months and 14 days including remission earned by him. He has availed parole 05 times and furlough 03 times. He learnt Horticulture and Bakery work in jail. His conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict.

13. JAVED AHMED KHAN S/O SAFI KHAN---AGE---50 YRS

Convict Javed Ahmed Khan s/o Safi Khan is undergoing life imprisonment in case FIR No. 517/96 & 287/96, U/S 302/307/120B/124/212 IPC & 3/4/5 Exp. Act & 25 Arms Act, P.S. Lajpat Nagar & H.N. Din respectively, Delhi for involvement in Bomb Blast at Lajpat Nagar, Central Market, Delhi. He has also been awarded life sentence in case FIR No. 148/1996, U/S 117/176/302/307 IPC, PS Mahawa, Distt. Dausa, Rajasthan.

Convict has undergone an actual sentence of 19 years, 10 months & 22 days excluding remission as on 30th of June 2016. He has undergone a total period of 20 years, 07 months and 02 days including remission earned by him. He has not been granted any parole/furlough. His jail conduct is also not satisfactory in view of multiple jail punishments. He did not learn any work in jail.

The Delhi Police opposed his premature release. The release has been recommended in the Social Investigation Report. None of the members of the Board was in favour of his premature release in view of gravity of crime committed which was against the national harmony and integration of society at large.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Javed Ahmed Khan s/o Safi Khan.

14. KALIM AHMED S/O ANSAR ANSARI---AGE---36 YRS

Convict Kalim Ahmed s/o Ansar Ansari is undergoing life imprisonment in case FIR No. 156/02, U/S 364A/120B IPC, P.S. Seelam Pur, Delhi for kidnapping a child for ransom.

Convict has undergone an actual sentence of 14 years, 01 month & 26 days excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 06 months and 16 days including remission earned by him. He has availed parole 02 times and furlough 06 times. He has learnt Bakery work in Tihar Baking School. His conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release. Ld. ASJ opposed the release of the convict in view of nature of crime, but the other members stressed upon the release of convict in view of his unblemished conduct in jail and during parole/furlough availed 08 times and no murder took place.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Kalim Ahmed s/o Ansar Ansari.

Convict has undergone an actual sentence of 14 years, 00 months & 02 days excluding remission as on 30th of June 2016. He has undergone a total period of 18 years, 09 months and 12 days including remission earned by him. He has availed parole 04 times and furlough 01 time. He has learnt Bakery work in Tihar Baking School. His conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Kishan @ Babli s/o Dayal Singh.


16. LAXMI PRASAD S/O TOLA RAM---AGE-49 YRS

Convict Laxmi Prasad s/o Tola Ram is undergoing life imprisonment in case FIR No. 350/92, U/S 302 IPC, P.S. Kalkaji, Delhi for committing murder of a person in personal dispute.

Convict has undergone an actual sentence of 14 years, 00 months & 24 days excluding remission as on 30th of June 2016. He has undergone a total period of 16 years, 09 months and 29 days including remission earned by him. He has availed parole 02 times and furlough 03 times. He has learnt PWD work in jail. His conduct in jail as well as parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The home town police not opposed his premature release in its report. The Probation Officer, Delhi has recommended his premature release.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Laxmi Prasad s/o Tola Ram.



17. MAHIPAL S/O DOONGAR---AGE---51 YRS

Convict Mahipal s/o Doongar is undergoing life imprisonment in case FIR No. 694/96, U/S 364A/34 IPC, P.S. Seelam Pur, Delhi for kidnapping a child for ransom.

Convict has undergone an actual sentence of 14 years, 01 month & 25 days excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 06 months and 26 days including remission earned by him. He has availed parole 04 times and furlough 06 times. He has learnt Carpentry work in jail. His conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release. Ld. ASJ opposed the release of the convict in view of nature of crime, but the other members stressed upon the release of the convict in view of his unblemished conduct in jail and during parole/furlough availed 10 times and no murder took place. Moreover, Mahipal was the accomplice of main accused Naresh Pal who had conspired the kidnapping.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Mahipal s/o Doongar.

18. MAHENDER S/O RAM SNEHI---AGE---32 YRS

Convict Mahender s/o Ram Snehi is undergoing life imprisonment in case FIR No. 143/02, U/S 302/34 IPC, P.S. Nand Nagri, Delhi for committing murder of a person over trivial issue.

Convict has undergone an actual sentence of 14 years, 02 months & 12 days excluding remission as on 30th of June 2016. He has undergone a total period of 18 years, 03 months and 07 days including remission earned by him. He has availed parole 02 times and furlough 14 times. He has learnt cooking work in jail. His conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Mahender s/o Ram Snehi.

19. MAKSOOD ALI S/O KHERULLA SHEIKH---AGE---49 YRS

Convict Maksood Ali s/o Kherulla is undergoing life imprisonment in case FIR No. 149/02, U/S 302 IPC, P.S. Welcome, Delhi for committing murder of his wife over strained relation.

Convict has undergone an actual sentence of 14 years, 00 months & 27 days excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 05 months and 17 days including remission earned by him. He has been convicted in another case of Kotdwar, Uttrakhand. He has availed parole 02 times only. He has learnt Carpentry work in the jail. His overall conduct in jail is unsatisfactory. However, nothing adverse reported during paroles.

The Police (Delhi and home town) opposed his premature release in its reports as well as in the meeting. The Probation Officer, Delhi has recommended his premature release. The members of the Board were not in favour of his premature release and opined to watch the conduct for some more time.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Maksood Ali s/o Kherulla.

20. PREM RAJ S/O KHAIRATI LAL---AGE---54 YRS

Convict Prem Raj s/o Khairati Lal is undergoing life imprisonment in case FIR No. 320/91, U/S 302/307/323 IPC, P.S. Ambedkar Nagar, Delhi for committing murder of a person over trivial issue.

Convict has undergone an actual sentence of 14 years, 02 months & 01 day excluding remission as on 30th of June 2016. He has undergone a total period of 17 years, 02 months and 01 day including remission earned by him. He has availed parole and furlough more than 20 times. He has learnt Carpentry work in the jail. He is lodged in Semi Open Jail and his conduct in jail as well as during parole/furlough is satisfactory.

The Delhi Police opposed his premature release in its report as well as in the meeting. The Probation Officer, Delhi has recommended his premature release.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Prem Raj s/o Khairati Lal.

21. RAJAN KHARBANDA S/O BABU RAM---AGE---56 YRS







Convict has undergone an actual sentence of 17 Years, 02 months & 09 days excluding remission as on 30th of June 2016. He has undergone a total period of 20 years, 06 days & 04 days including remission earned by him. He has availed parole 01 time and furlough 06 times. Nothing adverse reported against him during parole/furlough. His overall conduct has been satisfactory in jail. He has learnt typing and computer operations in jail. His judgment was considered by the Board.

The Police opposed his premature release in its report as well as in the meeting. Probation Officer, Delhi has recommended his premature release. The members of the Board were not convinced for his premature release in view of judgment of the Ld. Trial Court regarding the brutality of murder committed and observations of the Hon'ble Court.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Uttam Kumar s/o Hazari Lal.

Nothing adverse reported against him during parole/furlough. His overall conduct in jail is satisfactory. He has learnt Legal Aid Cell work in jail.

The Delhi Police opposed premature release of the convict in its report as well as in the meeting. Home town police has also opposed his premature release. The Chief Probation Officer, Delhi has recommended his case for premature release of the convict. The members of the Board were not convinced for his premature release in view of nature and gravity of crime committed by him i.e. kidnapping of a boy aged 12 years for ransom and his murder.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of the convict Vijay s/o Hari Narayan.

91. MOHD. YUNUS S/O HAZI MUSLIM----AGE-39 Yrs

Convict Mohd. Yunus s/o Hazi Muslim is undergoing life imprisonment in case FIR No. 115/2001, U/S-376 IPC P.S. Jahangir Puri, Delhi for committing rape of girl aged 10 years.

Convict has undergone an actual sentence of 15 Years, 04 months & 11 days excluding remission as on 30th of June 2016. He has undergone a total period of 19 years, 09 months & 05 days including remission earned by him. He has availed parole 03 times and furlough 01 time. His overall conduct has been satisfactory in jail. He has learnt weaving work in jail.

The Police opposed his premature release in its report as well as in the meeting. Probation Officer has recommended his premature release. The members of the Board were not convinced for his premature release in view of nature of crime and he has not yet lost his potential to commit such crime.

After taking into account all the facts and circumstances of the case, the Board REJECTS premature release of convict Mohd. Yunus s/o Hazi Muslim.

92. RAKESH SAROHA S/O RAGHUBIR SINGH---AGE---42 Yrs

Convict Rakesh Saroha s/o Raghbir Singh is undergoing life imprisonment in case FIR No. RC No. SIB/2001-E-0004, U/s 120B r/w 364A IPC P.S. CBI/SPE/SIV/VIII/N. Delhi for kidnapping of a man namely Thekkat Siddique for ransom.

Convict has undergone an actual sentence of 15 Years, 03 months & 06 days excluding remission as on 30th of June 2016. He has undergone a total period of 19 years, 01 month & 01 days including remission earned by him. He has availed parole 04 times and furlough 05 times. His overall conduct has been satisfactory in jail. He has learnt Bakery work in Tihar Bakery School.

His case was considered and recommended by the SRB in the meeting held on 06.01.2016, but declined by the Ministry of Home Affairs, Government of India in view of opposed by CII, Delhi Police and Ld. ASJ.

The Police opposed his premature release in its report as well as in the meeting. Home Govt. Police has not opposed his premature release. Probation Officer has recommended his premature release. The members of the Board were of view that his conduct should be watched for some more time and fresh reports to be called in due course.



Home town Probation Officer has not opposed his premature release. The members of the Board were of view that his conduct should be watched for some more time and fresh reports to be called in due course.


After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Kartik Subramaniam s/o S. Krishnan.

Out of 93 cases placed before the Sentence Reviewing Board, 30 cases have been recommended and 63 cases have been rejected.
