# RECOMMENDATIONS OF THE SENTENCE REVIEWING BOARD FOR PREMATURE RELEASE OF LIFE CONVICTS IN THE MEETING HELD UNDER THE CHAIRMANSHIP OF THE HON'BLE HOME MINISTER OF DELHI AT 02:00PM ON 06.09.17, AT DELHI SECRETARIAT, NEW DELHI- 110002.

On **6<sup>TH</sup>of SEPTEMBER 2017 at 02:00 P.M.**, the National Capital Territory of Delhi Sentence Reviewing Board' met for deciding the cases of premature releases of convictsundergoing Life sentence convicted by the Courts of Competent jurisdiction in Delhi, constitute by the orders of the Lt. Governor of NCT of Delhi vide Order No.F.18/5/94-Home(G)/3819 dated 16.07.2004.

In all 127 cases of life convicts were placed before the SRB for the kind consideration. These 127 cases included 40 fresh cases, 62 rejected cases of earlier SRB meeting held on 01.09.2016 and 02 rejected cases investigated by CBI and also 23 rejected cases (including 01 case investigated by CBI) of earlier SRB meeting held on 09.02.2017. The Board examined each case on merits in light of reports received from the Police and Probation officer as well as recommendations of the Jail authorities. Some cases covered under Supreme Court decisions in State of Haryana Vs. Jagdish which were cases prior to the said order were also taken up. The cases were taken up in light of UOI vs V. Sriharan @ Murgan & 0rs (dated 02.12.2015) for recommending premature release of life convicts. All recommendations for premature releases are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.

All the cases were discussed and considered in the light of parameters like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed (premeditated or spur of the moment), nature & gravity of crime, habitual offender or otherwise, his/her antecedents, propensity for committing crime or not, parole/furlough availed, prospects of rehabilitation post release, family responsibilities, The possibility of reclaiming the convict as a useful member of society and his socio-economic condition were also evaluated by the Board.

### 1. ABDUL @ ABDULLA S/O SH. TAMIZUDDIN---AGE-33 YRS

**Sentence:** Abdul @ Abdulla s/o Sh. Tamizuddin is undergoing life imprisonment in case FIR No. 346/2003, U/S 302/394/34 IPC, P.S. Malviya Nagar, Delhi for committing murder of a lady during robbery.

**Sentence undergone excluding remission**: 14 years, 01 month and 09 days.

## Propensity for committing crime: NIL

Has recommended premature release in view of optimistic prospects of rehabilitation and the fact that convict is willing to take care of his family. He learnt weaving work in jail. His conduct in jail and during parole/furlough has been satisfactory. He has shown good aptitude for reforms.

The members of the Board were not convinced for his premature release in view of 1) Nature of crime committed 2) Actual custody period undergone 3) Police has opposed his premature release.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Abdul @ Abdulla s/o Sh. Tamizuddin.

## 2. ALAM S/O SH. SHAHID---AGE-34 YRS

**Sentence:** Alam s/o Shahid is undergoing life imprisonment in case FIR No. 161/2003, U/S 302/34 IPC, P.S. Gokul Puri, Delhi for committing murder of a person on minor issue.

**Sentence undergone including remission**: 14 years, 01 month and 25 days.

Sentence undergone including remission: 16 years, 07 months and 03 days

**Releases on Parole / Furlough:** Parole 00 times and Furlough 12 times.

## Propensity for committing crime: NIL

**Police Report:** The Delhi Police has **not opposed** his premature release in its report.

#### **Probation officer's Report:**

The report of the Probation Officer of Delhi is still waited. His conduct in jail is not satisfactory as he was punished by the Jail Superintendent on 19.01.2017 for using mobile phone inside jail.

The members of the Board were not convinced for his premature release in view of 1) Nature of crime committed 2) Actual period undergone 3) unsatisfactory jail conduct 4) Police has opposed his premature release.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Alam s/o Shahid.

## 3. BHUPINDER SINGH S/O SH. PREM SINGH---AGE-38 YRS

**Sentence:** Bhupinder Singh s/o Prem Singh is undergoing life imprisonment in case FIR No. 288/2003, U/S 394/302 IPC& 27 Arms Act, P.S. Rajouri Garden, Delhi for committing murder of a person during robbery.

**Sentence undergone excluding remission**: 14 years, 02 months and 11 days.

**Sentence undergone including remission**: 16 years, 04 months and 29 days **Releases on Parole / Furlough**: Parole 05 times and Furlough02 times.

**Propensity for committing crime:** Possibility cannot be ruled out.

Police Report: The Delhi Police has opposed his premature release in its report.

#### Probation officer's Report:

The Probation officer has **recommended** premature release in view of optimistic prospects of rehabilitation and convict willing to take care of his family. He learnt Carpentry, Cleaning and Cooking in jail. His conduct in jail and during parole/ Furlough has been satisfactory. However, his conduct in jail is not satisfactory as he has been punished in jail 21 times for breaching jail rules.

The members of the Board were not convinced for his premature release in view of 1) Nature of crime committed 2) Actual period undergone 3) Unsatisfactory jail conduct 4) Police has opposed his premature release. After taking into account all the facts and circumstances of the case, the Board **<u>REJECTS</u>** premature release of convict Bhupinder Singh s/o Sh. Prem Singh.

## 4. BIJENDER S/O SH. NATHU SINGH---AGE---45 YRS

**Sentence:** Bijender s/o Sh. Nathu Singh is undergoing life imprisonment in case FIR No. 226/2000, U/S 302 IPC& 27 Arms Act, P.S. Gandhi Nagar, Delhi for committing murder of his wife in quarrel over doubt of infidelity.

Sentence undergone excluding remission: 14 years, 04 months and 03 days.

**Sentence undergone including remission**: 18 years, 06 months and 23 days **Releases on Parole / Furlough:** I. Bail-01, Parole 03 and Furlough14 times.

## Propensity for committing crime: NIL

**Police Report:** The Delhi Police has **opposed** his premature release without giving any cogent reason.

## Probation officer's Report:

The probation officer has **recommended** his premature release in its report as well as in the meeting. He has learnt Cooking work in jail. His conduct in jail and during parole/furlough has been satisfactory. Moreover, he is presently lodged in Semi Open Jail.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Bijender s/o Sh. Nathu Singh.

## 5. CHAND SINGH S/O SH. RAM SINGH---AGE---41 YRS

**Sentence:** Chand Singh s/o Ram Singh is undergoing life imprisonment in case FIR No. 18/2003, U/S 302 IPC, P.S. J.P. Kalan, Delhi for committing murder of his wife due to strained relations.

Sentence undergone excluding remission: 14 years, 04 months and 03 days.

**Sentence undergone including remission**: 18 years, 01 month and 10 days **Releases on Parole / Furlough**: Parole 07 times and Furlough16 times.

#### Propensity for committing crime: NIL

**Police Report:** The Delhi Police **not recommended** his premature release in its report.

#### Probation officer's Report:

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude for reforms. He has learnt Stitching and Cooking work in jail. His conduct in jail and during parole/ Furlough has been satisfactory. Convict is HIV+ positive. There is no complaint against the convict. Moreover, he is presently lodged in Semi Open Jail.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Chand Singh s/o Sh. Ram Singh.

## 6. DINESH KUMAR S/O SH. GANGA PRASAD---AGE---41 YRS

**Sentence undergone excluding remission**: 14 years, 05 months and 26 days.

**Sentence undergone including remission**: 18 years, 04 months and 19 days **Releases on Parole / Furlough**: Parole 01 time and Furlough12 times.

#### Propensity for committing crime: NIL

**Police Report:** The Delhi Police in its report has stated that the case may be decided on merits.

Sentence undergone excluding remission: 14 years, 03 months and00 days.

**Sentence undergone including remission**: 17 years, 04 months and 09 days **Releases on Parole / Furlough**: Parole 01 time and Furlough02 times.

#### Propensity for committing crime: NIL

**Police Report:** The Delhi Police **opposed** his premature release in its report.

#### Probation officer's Report:

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting. ## 8. <u>JITENDER @ JITU S/O SH. BALWANT SINGH---AGE---35 YRS</u>

**Sentence:** Jitender @ Jitu s/o Sh. Balwant Singh is undergoing life imprisonment in case FIR No. 684/2002, U/S 302/34 IPC, P.S. Tilak Nagar, Delhi for committing murder of a person to take revenge of earlier fight.

Sentence undergone excluding remission: 14 years, 03 months and 14 days.

**Sentence undergone including remission**: 17 years, 00 months and 17 days **Releases on Parole / Furlough**: I.Bail 01, Parole 01 times and Furlough 00 times.

**Sentence undergone excluding remission**: 14 years, 04 months and 19 days.

**Sentence undergone including remission**: 17 years, 03 months and 12 days **Releases on Parole / Furlough**: Parole 08 times and Furlough 18 times.

On **6<sup>TH</sup>of SEPTEMBER 2017 at 02:00 P.M.**, the National Capital Territory of Delhi Sentence Reviewing Board' met for deciding the cases of premature releases of convictsundergoing Life sentence convicted by the Courts of Competent jurisdiction in Delhi, constitute by the orders of the Lt. Governor of NCT of Delhi vide Order No.F.18/5/94-Home(G)/3819 dated 16.07.2004.

In all 127 cases of life convicts were placed before the SRB for the kind consideration. These 127 cases included 03 cases investigated by Central agency. The Board examined each case on merits in light of reports received from the Police and Probation officer as well as recommendations of the Jail authorities. Some cases covered under Supreme Court decisions in State of Haryana Vs. Jagdish which were cases prior to the said order were also taken up. The cases were taken up in light of UOI vs V. Sriharan @ Murgan & Ors (dated 02.12.2015) for recommending premature release of life convicts. All recommendations for premature releases are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.

All the cases were discussed and considered in the light of parameters like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed (premeditated or spur of the moment), nature & gravity of crime, habitual offender or otherwise, his/her antecedents, propensity for committing crime or not, parole/furlough availed, prospects of rehabilitation post release, family responsibilities, The possibility of reclaiming the convict as a useful member of society and his socio-economic condition were also evaluated by the Board.
