ON 09.02.17, AT DELHI SECRETARIAT, NEW DELHI- 110002.**

On **9<sup>TH</sup> of FEBRUARY 2017 at 04:00 P.M.**, 'the National Capital Territory of Delhi Sentence Reviewing Board' met for deciding the cases of premature releases of convicts

undergoing Life sentence convicted by the Courts of Competent jurisdiction in Delhi, constitute by the orders of the Lt. Governor of NCT of Delhi vide Order No.F.18/5/94-Home(G)/3819 dated 16.07.2004.

In all 62 cases of life convicts were placed before the SRB for the kind consideration. These 62 cases included 32 fresh cases, 14 rejected cases of earlier SRB meeting held on 04.05.2016 and also 16 cases of terminally ill convicts along with old age convicts covered under Para 3.4 of the SRB order. The Board examined each case on merits in light of reports received from the Police and Probation officer as well as recommendations of the Jail authorities. Some cases covered under Supreme court decisions in State of Haryana Vs. Jagdish which were cases prior to the said order were also taken up. The cases were taken up in light of UOI vs V. Sriharan @ Murgan & Ors (dated 02.12.2015) for recommending premature release of life convicts. All recommendations for premature releases are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.

All the cases were discussed and considered in the light of parameters like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed (premeditated or spur of the moment), nature & gravity of crime, habitual offender or otherwise, his/her antecedents, potential for committing crime or not, parole/furlough availed, prospects of rehabilitation post release, family responsibilities, the possibility of reclaiming the convict as a useful member of society and his socio-economic condition were also evaluated by the Board.

#### **A. FRESH CASES**

##### **1. AJAY SINGH @ AJAY KUMAR S/O SH. BHISHAM RAJ---AGE-45 YRS**

**Sentence:** Ajay Singh @ Ajay Kumar s/o Sh. Bisham Raj is undergoing life imprisonment in case FIR No. 243/2002, U/S 302/201 IPC, P.S. Vasant Vihar, Delhi for committing murder of his wife due to strained relations.

**Sentence undergone excluding remission:** : 14 years, 04 months and 10 days.

**Sentence undergone including remission** : 19 years, 02 months and 09 days

**Releases on Parole / Furlough:** Parole 02 times and Furlough 19 times.

**Police Report:**

The Delhi Police has **opposed** his premature release without giving any cogent reason, despite the fact that he was released from jail on 21 occasions and Convict does not have any past criminal record.

**Probation officer's Report:**

**Has recommended** premature release in view of optimistic prospects of rehabilitation and the fact that convict is willing to take care of his family. He learnt office assistant work and cooking in jail and has also participated in Yoga, Meditation and other jail activities. His conduct in jail and during parole/furlough has been satisfactory. He has shown good aptitude for reforms.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Ajay Singh @ Ajay Kumar s/o Sh. Bhasham Raj.

**2. AKHLAQ @ BHURA S/O SH. GAFFUR---AGE-36 YRS**

**Sentence:** Akhlaq @ Bhura s/o Gaffur is undergoing life imprisonment in case FIR No. 663/2002, U/S 302/307 IPC, P.S. Nangloi, Delhi for committing murder of a person over a trivial issue.

**Sentence undergone including remission:** : 14 years, 04 months and 14 days.

**Sentence undergone including remission** : 18 years, 08 months and 16 days

**Releases on Parole / Furlough:** Parole 02 times and Furlough 10 times.

**Police Report:**

The Delhi Police has opposed his premature release on the alibi of disturbing peace in the **society without any cogent reason, despite the fact that he was released from jail on 12 occasions. Convict does not have any past criminal record.**

**Probation officer's Report:**

The Probation Officers of Delhi and home state have **recommended** his case for premature release as they were very optimistic for his rehabilitation and nil recidivism. Further, the convict has also learnt bakery and carpentry work in jail and also participated in Yoga, Meditation and other jail activities. His conduct in jail and during Parole/ Furlough has been satisfactory. He has shown aptitude for reforms.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Akhlaq @ Bhura s/o Gaffur.

**3. AKBAR ALI @ JAVED S/O SH. RIYASAT ALI---AGE-51 YRS**

The case is taken up in terms of order of Hon'ble Supreme Court of India dated 22.03.2010 in case of Jagdish Versus State of Haryana

**Sentence I:** Akbar Ali @ Javed s/o Sh. Riyasat Ali is undergoing life imprisonment in case FIR No. 91/1993, U/S 302/392/397/34 IPC, P.S. Vikas Puri, Delhi for committing **Robbery with murder** by firing along with accomplices.

**Sentence II.** He has been also convicted in case FIR No. 146/2010, U/s 304/323/34 IPC, PS Hari Nagar for period already undergone.

**Sentence undergone excluding remission:** : 14 years, 03 months and 1 days.

**Sentence undergone including remission** : 17 years, 00 months and 03 days

**Releases on Parole / Furlough** : Parole 02 times and Furlough 01 times.

**Police Report:**

The Delhi Police has **opposed his premature release.**

**Probation officer's Report:**

**Has recommended premature release** in view of optimistic prospects of rehabilitation and convict willing to take care of his family. He learnt carpentry trade in jail and has also participated in Yoga, Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory. He has shown aptitude for reforms.

The members of the Board were not convinced for his premature release in view of the nature of crime as the **murder was committed during the act of looting** and his **conviction in multiple cases** including case U/s 304/323/34 of IPC while in jail.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Akbar Ali @ Javed s/o Sh. Riyasat Ali.

**4. AJIT SINGH @ JIT S/O SH. KARTAR SINGH---AGE---49 YRS**

**Sentence I:** Ajit Singh @ Jit s/o Sh. Kartar Singh is undergoing life imprisonment in case FIR No. 451/2002, U/S 302/323 IPC, P.S. Badarpur, Delhi for committing murder of his wife by assault, as she used to stop him from drinking.

**Sentence II:** He has been convicted in another case FIR No. 119/2002, U/s 341/323/34 IPC, PS Badar Pur for 03 Years with fine (sentence completed).

**Sentence undergone excluding remission:** : 14 years,01 months and 20 days.

**Sentence undergone including remission:** : 18 years, 00 months and 19 days

**Releases on Parole / Furlough:** Parole 2 times and Furlough 6 times.

**Police Report:**

The Delhi Police has opposed his premature release in the meeting, Moreover the Jt. C.P. pointed out that the **convict Ajit Singh is having another case vide FIR No. 85/1996, U/s 376 IPC at PS Kalkaji.** while the home town report was not received despite multiple wireless messages.

**Probation officer's Report:**

**Has recommended** his premature release in its report as well as in the meeting. He has undertaken Carpentry and Welding work in jail factory and also participated in Yoga and Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory.

The members of the Board were not convinced for his premature release in view of gravity of the offence committed by him and **conviction in multiple cases.**

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Ajit Singh @ Jit s/o Sh. Kartar Singh.

**5. BRIJ PAL @ KARATE S/O SH. MANNU---AGE---44 YRS**

**Sentence:** Brij Pal @ Karate s/o Mannu is undergoing life imprisonment in case FIR No.224/1993, U/S 302/307/34 IPC, P.S. Vivek Vihar, Delhi for committing murder of a person by stabbing a person along with his accomplices in personal grudge.

**Sentence undergone excluding remission:** :14years, 00 months and 07 days.

**Sentence undergone including remission :** 15 years, 10 months and 01 days

**Releases on Parole / Furlough :** Parole 3 times and Furlough 6 times.

**Police Report:**

The Delhi Police **opposed** his premature release in its report as well as in the meeting without any justified reason; despite the fact that he was released from jail on 9 occasions also there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude for reforms. He has learnt Bakery and carpentry work in jail factory also participated in Yoga, Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory. Convict is HIV+ positive. There is no complaint against the convict except 01 punishment dated 06.06.12 for recovery of tobacco.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Brij Pal @ Karate s/o Sh. Mannu.

**6. CHAMAN LAL S/O SH. DUNDA RAM---AGE---34 YRS**

**Sentence:** Chaman Lal s/o Sh. Dunda Ram is undergoing life imprisonment in case FIR No. 566/2002, U/S 302/307/449/506 Part-II IPC, P.S. Jahangir Puri, Delhi for

committing murder of his brother-in-law (wife's brother) by stabbing him for interfering in his family affairs.

**Sentence undergone excluding remission** : 14 years, 04 months and 03 days.

**Sentence undergone including remission** : 18 years, 03 months and 19 days

**Releases on Parole / Furlough** : Parole 1 times and Furlough 16 times.

**Police Report:**

The Delhi Police **opposed** his premature release in its report as well as in the meeting without any justified reasons; despite the fact that he was released from jail on 17 occasions also there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude for reforms. He has learnt Carpentry work in Jail Factory and also participated in Yoga, Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Chaman Lal s/o Sh. Dunda Ram.

**7. DHARAM SINGH S/O SH. YAD RAM---AGE---42 YRS**

**Sentence:** Dharam Singh s/o Sh. Yad Ram is undergoing life imprisonment in case FIR No. 460/2001, U/S 302/364A/120B/34 IPC, P.S. Prashant Vihar, Delhi for committing kidnapping of twin male children aged about 4 ½ years along with their cab driver for ransom and murder of the cab driver.

**Sentence undergone excluding remission** : 15 years, 03 months and 10 days.

**Sentence undergone including remission** : 18 years, 10 months and 05 days

**Releases on Parole / Furlough** : Parole 7 times and Furlough 7 times.

**Police Report:**



The Delhi Police **opposed** his premature release in its report as well as in the meeting.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting. He has learnt Carpentry work in Jail Factory and also participated in yoga, Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory.

The members of the Board were not convinced for his premature release in view of nature and gravity of the offence committed by him. **(Kidnapping of 2 children along with driver for ransom and murder of driver)**

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Dharam Singh s/o Yad Ram.

**8. JAIPAL S/O SH. UMRAO SINGH---AGE---41 YRS**

**Sentence:** Jai Pal Singh s/o Sh. Umrao Singh is undergoing life imprisonment in case FIR No. 460/2001, U/S 302/364A/120B/34 IPC, P.S. Prashant Vihar, Delhi for committing kidnapping of twin male children aged about 4 ½ years along with their cab driver for ransom and murder of the cab driver.

**Sentence undergone excluding remission:** : 15 years, 03 months and 11 days.

**Sentence undergone including remission:** : 18 years, 08 months and 27 days

**Releases on Parole / Furlough** : Parole 7 times and Furlough 6 times.

**Police Report:**

The Delhi Police opposed his premature release in its report as well as in the meeting.

**Probation officer's Report:**

The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting. He has learnt Carpentry work in Jail Factory and also

participated in yoga, Meditation and other jail activities. His conduct in jail and during parole/ Furlough has been satisfactory.

The members of the Board were not convinced for his premature release in view of nature and gravity of the offence committed by him. **(Kidnapping of 2 children along with driver for ransom and murder of driver)**

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Jai Pal Singh s/o Umrao Singh.

**9. MADAN SINGH @ BABLOO S/O SH. GOPAL SINGH---AGE---42 YRS**

**Sentence:** Madan Singh @ Babloo s/o Gopal Singh is undergoing life imprisonment in case FIR No. 460/2001, U/S 302/364A/120B/34 IPC, P.S. Prashant Vihar, Delhi for committing kidnapping of twin male children aged about 4 ½ years along with their cab driver for ransom and murder of the cab driver.

**Sentence undergone excluding remission:** : 15 years, 03 months and 11 days.

**Sentence undergone including remission:** : 18 years, 10 months and 01 days

**Releases on Parole / Furlough:** Parole 7 times and Furlough 8 times.

**Police Report:**

The Delhi Police **opposed** his premature release in its report as well as in the meeting.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting. He has learnt Bakery work and Paper unit in Jail Factory and also participated in yoga, Meditation and other jail activities. His conduct in jail and during parole/furlough has been satisfactory.

The members of the Board were not convinced for his premature release in view of nature and gravity of the offence committed by him. **(Kidnapping of 2 children along with driver for ransom and murder of driver)**

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Madan Singh @ Babloo s/o Gopal Singh

**10. FURKAN S/O MD. ANWAR---AGE---40 YRS**

**Sentence:** Furkan s/o Md. Anwar is undergoing life imprisonment in case FIR No. 948/1998, U/S 302/307/34 IPC, P.S. Janakpuri, Delhi for committing murder of a person along with accomplices with sharp edged weapon over trivial dispute.

**Sentence undergone excluding remission:** : 14 years, 04 months .

**Sentence undergone including remission:** : 18 years, 03 months and 01 days

**Releases on Parole / Furlough:** Parole 2 times and Furlough 5 times.

**Police Report:**

The Delhi Police as well as home town Police **opposed** his premature release in its report as well as in the meeting without any justified reason; however there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude for reforms. He is **presently lodged in Semi Open Jail** and his conduct in jail/Semi Open Jail as well as during parole/furlough is satisfactory. He has learnt weaving work at jail factory and store management and also participated in Yoga, Meditation and other jail activities.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Furkan s/o Md. Anwar.

**11. JAGRAM S/O SH. SUMMA---AGE---45 YRS**

**Sentence:** Jagram s/o Sh. Summa is undergoing life imprisonment in case FIR No. 147/1995, U/S 302/201/34 IPC, P.S. Seema Puri, Delhi for committing murder of his brother due to illicit relation with wife of brother (Bhabhi).

**Sentence undergone excluding remission:** :14 years, 01 months and 27 days.

**Sentence undergone including remission:** : 17 years, 05 months and 24 days

**Releases on Parole / Furlough:** No parole, 1 Furlough granted but not

availed. Further, as per record, He has availed 01 Interim Bail and jumped interim bail from 20.08.99 and re-arrested after 07 years 05 months & 11 days.

**Police Report:**

The Delhi Police has **opposed** his premature release without justified reasons.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report. He has learnt Bakery and worked at Jail Kitchen and also participated in Yoga, Meditation and other jail activities.

The members of the Board were not convinced for his premature release in view of history of **interim bail jump for a period more than 07 years.**

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Jagram s/o Sh. Summa.

**12. KISHAN LAL S/O SH. KALI CHARAN---AGE---61 YRS**

**Sentence:** Convict Kishan Lal s/o Sh. Kali Charan is undergoing life imprisonment in case FIR No. 85/1996, U/S 302 IPC, P.S. Kalkaji, Delhi for committing murder of a person with iron pipe and knife in grudge over trivial dispute.

**Sentence undergone excluding remission:** : 14 years, 02 months and 27 days

**Sentence undergone including remission:** : 16 years, 11 months and 22 days

**Releases on Parole / Furlough** : Parole 3 times and Furlough 17 times.

**Police Report:**

The Delhi Police has not given any comments in its report for his premature release, however **opposed** in the meeting ; despite the fact that he was released from jail on 20 occasions, also there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has recommended his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude

for reforms. He has learnt cleaning and sanitation work in jail and also participated in Yoga, Meditation and other jail activities. His conduct in jail as well as during parole/furlough is satisfactory. **He is presently lodged in Semi Open Jail.**

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Kishan Lal s/o Sh. Kali Charan.

**13. LAXMI NARAYAN S/O SH. KARTAR SINGH---AGE---54 YRS**

**Sentence:** Laxmi Narayan s/o Sh. Kartar Singh is undergoing life imprisonment in case FIR No.1005/2002, U/S 302/324 IPC, P.S. Nangloi, Delhi for murder of his wife by assault, as convict was a habitual gambler and was having a running dispute with his wife.

**Sentence undergone excluding remission:** 14 years, 01 months and 12 days

**Sentence undergone including remission :** 18 years, 4 months and 06 days

**Releases on Parole / Furlough :** Parole 1 times and Furlough 3 times.

**Police Report:**

The Delhi Police **opposed** his premature release in its report and also in the meeting without any justified reasons; despite the fact that he was released from jail on 4 occasions also there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release in its report as well as in the meeting and he has to take care of his family. He has shown aptitude for reforms. He learnt tailoring work in the jail factory. His conduct during parole/furlough is satisfactory. He also participated in Yoga, Meditation and other jail activities. Though his overall conduct is satisfactory in jail but he was punished on 13.06.12 for misbehaving with the Senior Medical officer at Jail dispensary.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Laxmi Narayan s/o Sh. Kartar Singh

**14. LAL BABU S/O KHAKNU RAM-----AGE---44 YRS**

**Sentence:** Lal Babu s/o Khaknu Ram is undergoing life imprisonment in case FIR No. 94/1991, U/S 457/302/307/392 & 460 r/w 34 IPC, P.S. Naraina, Delhi for **Robbery with Murder** by stabbing and assault with hammer.

**Sentence undergone excluding remission:** 14 years, 04 months and 09 days

**Sentence undergone including remission :** 16 years, 04 months and 04 days

**Releases on Parole / Furlough :** Parole 3 times and Furlough 3 times.

**Police Report:**

The Delhi Police has **not recommended** his premature release in its report as well as in the meeting.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release. He has worked at paper unit at jail factory. His conduct in jail as well as during parole/furlough is satisfactory except 01 day late surrender from furlough. He also participated in Yoga, Meditation and other jail activities.

The members of the Board were not convinced for his premature release in view of nature and gravity of the offence i.e. **robbery and murder** committed by him.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Lal Babu s/o Sh. Khaknu Ram.

**15. MANJU W/O SUNIL----- AGE---41 YRS**

**Sentence:** Manju w/o Sunil is undergoing life imprisonment in case FIR No. 403/02, U/S 302/34 IPC, P.S. Hauz Khas, Delhi for committing murder by set on fire her husband with the help of her brother as the couple had personal disputes.

**Sentence undergone excluding remission:** 14 years, 6 months and 00 days

**Sentence undergone including remission :** 17 years, 7 months and 25 days

**Releases on Parole / Furlough:** Parole 5 times and Furlough 9 times.

**Police Report:**

The Delhi Police as well as home town Police has **not opposed her premature release** in its report, however opposed in the meeting, despite the fact that he was released from jail on 14 occasions. It is pertinent to mention here that there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi as well as home town has **recommended** her premature release and she has to take care of her family. She has shown aptitude for reforms. She has learnt Weaving and Crèche work in jail. His conduct in jail as well as during parole/furlough is satisfactory except 01 punishment dated 02.05.14 for recovery of Nose Pin.

After taking into account all the facts and circumstances of the case, the Board **RECOMMENDS** premature release of convict Manju w/o Sunil.

**Sentence:** Babu Lal s/o Sh. Balwant is undergoing life imprisonment in case FIR No. 210/1987, U/S-302/364/201/120B IPC, P.S. Sultanpuri, for committing

**kidnapping and murder of a girl child** in a superstition that a barren woman get a child.

**Sentence undergone excluding remission**: 18 years, 04 months and 28 days.

**Sentence undergone including remission** : 23 years, 11 months and 03 days

**Sentence undergone excluding remission**: 16 years, 1 months and 13 days.

**Sentence:** Md. Tayyab Alam s/o Md. Sageer is undergoing life imprisonment in case FIR No. 786/2000, u/s 302/364/34 IPC, P.S.-Uttam Nagar Delhi for Kidnapping and Murder of a Driver of Travel Agency to grab the Van they hired.

**Sentence undergone excluding remission**: 15 years, 1 months and 28 days.

**Sentence undergone including remission**: 19 years, 1 months and 10 days

**Releases on Parole / Furlough** : Parole 1 times and Furlough 6 times.

**Police Report:**

The Delhi Police **opposed** premature release of the convict in its report as well as in the meeting

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release. He has learnt tailoring and shoe making in jail. He also participated in Yoga, Meditation and other jail activities. His conduct in jail as well as during parole/furlough is satisfactory. The members of the Board were not convinced for release of the convict in view of nature and gravity of crime committed by him.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of the convict Md. Tayyab Alam s/o Md. Sageer.

**41. MD. KHALID S/O MD. AJIZ ---AGE – 45 Yrs.**

**Sentence:** Md. Khalid s/o Md. Ajiz is undergoing life imprisonment in case FIR No. 910/2000, U/S-302 /34 IPC, Police Station Sultan Puri, Delhi, for committing murder by firing due to personal enmity.

**Sentence II:** He is also sentenced to life imprisonment in case ST No. 172/99, U/s 364/302/149/201 IPC, PS Bahadurgarh, Ghaziabad, UP (on Bail).

**Sentence undergone excluding remission:** 16 years, 2 months and 12 days.

**Sentence undergone including remission :** 19 years, 8 months and 21 days

**42. PANKAJ BISWAS S/O SH. SUNIL BISWAS ----AGE – 38 Yrs.**

**Sentence I:** Pankaj Biswas s/o Sunil Biswas is undergoing life imprisonment in case FIR No. 133/2000, u/s 302/450/34 IPC P.S. Chitranjan Park for committing **Murder along with his accomplices while committing dacoity** armed with sword and knives

**Sentence II:** Life sentence in FIR No. 347/2000 u/s 302/449/396/34 IPC P.S.- Chitranjan Park, for committing **Murder of two persons while committing dacoity armed with sword and knives.**

**Sentence undergone excluding remission:** 16 years, 01 months and 13 days

**Sentence undergone including remission:** 21 years, 01 months and 15 days

**Releases on Parole / Furlough** : Parole 1 times and Furlough 1 times.

**Police Report:**

The Delhi Police **opposed** premature release of the convict in its report as well as in the meeting without any justified reason. However, the Home town Police has not opposed him premature release in its report.

**Probation officer's Report:**

The Probation Officer, Delhi and home town have **recommended** his premature release. He has learnt cooking Carpentry, Jute Bag making, Electrician work and Plumber work in jail. His work and conduct has been satisfactory in jail.

The members of the Board were not convinced for his premature release in view crime committed by him and his involvement in multiple cases of dacoity and murder.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of the convict Pankaj Biswas s/o Sh. Sunil Biswas.

**43. RAMESH @ RAMESHI @ VINOD S/O SH. MANGAL SINGH--AGE44 Yrs.**

**Sentence:** Ramesh @ Rameshi @ Vinod s/o Sh. Mangal Singh is undergoing life imprisonment in case FIR No. 698/97, U/S-302/34 IPC P.S. Model Town, Delhi for committing Murder of a person over Money dispute developed while gambling.

**Sentence undergone excluding remission:** 15 years, 08 months and 02 days

**Sentence undergone including remission :** 16 years, 03 months and 06 days

**Releases on Parole / Furlough** : He was granted only 2 paroles and on one occasion he **surrendered late by three days.**

**Police Report:**

The Police **opposed** his premature release in its report as well as in the meeting without any justified reason.

**Probation officer's Report:**

The Probation Officer, Delhi has **not recommended his premature release. His work and conduct is not satisfactory in jail due to 22 jail Punishments.**

The members of the Board were not convinced for his premature release in view of his **unsatisfactory jail conduct** as well as the fact that he has not shown attitude towards reform ( **22 jail punishments**).

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Ramesh @ Rameshi @ Vinod s/o Sh. Mangal Singh.

**44. RAVI KUMAR GHAI S/O KEWAL KRISHAN GHAI----AGE- 46 Yrs.**

**Sentence:** Ravi Kumar Ghai s/o Sh. Kewal Krishan Ghai Singh is undergoing life imprisonment in case FIR No. 591/2001, U/S 302 IPC, P.S. Patel Nagar for committing **murder of a girl student** by pushing from the roof of the building who used to come to him for tuition.

**Releases on Parole / Furlough** : Parole 1 times and Furlough 5 times.

**Police Report:**

The Delhi Police did **not recommended** his premature release in its report and has also opposed his release in the meeting; however there is no previous criminal history of the convict.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release as he has to take care of his family. He has shown aptitude for reforms. His conduct is satisfactory in jail. He has worked office assistant and helped in IGNOU Centre of the jail in educating prisoners. He also participated in Yoga, Meditation and other jail activities.

After taking into account all the facts and circumstances of the case, the board **RECOMMENDS** premature release of this convict Ravi Kumar Ghai s/o Sh. Kewal Krishan Ghai.

**45. SATENDER SINGH S/O SH. PARMANAND ---- AGE- 42 Yrs.**

**Sentence:** Satender Singh s/o Sh. Parmandand is undergoing life imprisonment in case FIR No. 247/2003 , U/S-376(2)(g)/366/394 IPC, P.S.-Chanakya Puri, Delhi for committing **Rape** along with his accomplices a young girl and robbed her in Budha Jayanti Park.

**Sentence undergone excluding remission:** : 13 years, 2 months and 3 days.

**Sentence undergone including remission** : 15 years, 6 months and 00 days

**Releases on Parole / Furlough** : Parole 2 times and Furlough 8 times.

**Police Report:**

The Delhi Police **opposed** premature release of the convict in its report as well as in the meeting without any justified reason. The report of Home town Police has not been received despite several requests.

**Probation officer's Report:**

The Chief Probation Officer Delhi **recommended** his premature release. His conduct is satisfactory in jail. He has learnt shoe making in jail. He also participated in Yoga, Meditation and other jail activities.

The members of the Board were not convinced for his premature release in view gravity of the offence committed by him and considering that he might have not lost his potential to commit rape.

After taking into account all the facts and circumstances of the case, board **REJECTS** premature release of the convict Satender Singh s/o Sh. Parmandand.

**46. SHYAM NARAIN S/O SH. TABALI RAM-----AGE- 42 ---Yrs**

**Sentence:** Shyam Narain s/o Sh. Tabali Ram is undergoing life imprisonment in case FIR No. 524/2003, U/S-376(2)(F) IPC, P.S. Kalyanpuri, Delhi for committing **rape a girl child aged 7 ½ years.**

**Sentence undergone excluding remission:** 13 years, 1 months and 21 days.

**Sentence undergone including remission :** 16 years, 11 months and 13 days

**Releases on Parole / Furlough :** Parole 4 times and no Furloughs

**Police Report:**

The Delhi Police has The Delhi Police has **opposed** his premature release in its report as well as in the meeting without any justified reason. The home town Police has **not recommended** his premature release in its report.

**Probation officer's Report:**

The Probation Officer, Delhi has **recommended** his premature release. However The Probation officer of **home town has not recommended** his premature release in its report. He has learnt bakery work in jail. He also participated in Yoga, Meditation and other jail activities.

The members of the Board were not convinced for his premature release in view of nature and gravity of the offence committed by him and considering that he might have not lost his potential to commit rape.

After taking into account all the facts and circumstances of the case, the Board **REJECTS** premature release of convict Shyam Narain s/o Sh. Tabali Ram.


