A meeting of the **Sentence Review Board** (hereinafter referred to as **Board**) was held on 27<sup>th</sup> August 2021, in the Conference Room, 6<sup>th</sup> Level "A" Wing, Delhi Sachivalaya, New Delhi under the **CHAIRMANSHIP OF HON'BLE HOME MINISTER, GOVT. OF NCT OF DELHI**.

The Sentence Review Board met on 27.08.2021 at 03:00 PM to consider the 39 number of cases of life convicts (37 fresh cases and 02 CBI cases to be placed in the present meeting). In pursuance to the instructions/directions of Hon'ble Lieutenant Governor conveyed by Home Department GNCT of Delhi vide reference no. F.15/102/2003/HG/P-IV/1865 dated 12.08.2021, 02 recommended CBI cases by SRB in its last meeting dated 25.06.2021, are again to be placed in the present meeting along with changed facts and circumstances which merit their re-consideration by MHA.

All the cases put forth before the Board were discussed at length and considered in the light of parameters as mentioned in Delhi Prison Rules, 2018 and / or other relevant orders/laws pertaining to the premature release. Factors like conduct of the prisoner during confinement, his/her age, the circumstances under which the crime was committed (premeditated or in spur of the moment), nature & gravity of crime, perversity and brutality of the offence committed by the convict, whether the convict is casual or habitual offender, his/her antecedents, apprehension expressed by his/her family members, propensity of committing crime again or not, his lodgment, number of parole/furlough availed and conduct during parole/furlough as well as in Jail, prospects of post release rehabilitation, possibility of the convict to return as a useful member of the society and his socioeconomic condition etc. were also considered by the Board and accordingly its recommendations were given.

# The Board was informed about the following:-

- (I) That the recommendations by the Board for premature release of the convicts are subject to the approval of Hon'ble Lieutenant Governor, Govt. of National Capital Territory of Delhi.
- (II) Cases falling under Section 435 Cr.P.C. are subject to the consultation with Central Government (MHA), Govt. of India (e.g. CBI cases etc.), if any. The recommended case (s) by the Board, where consultation under Section 435 Cr.P.C. of MHA is required, will be forwarded separately by Home Department, GNCT of Delhi, first to MHA, Govt. of India for their necessary concurrence/consultation before placing these cases to the Hon'ble Lieutenant Governor for its approval.
- (III) That the custody period i.e. undergone portion of sentence in all cases placed before the Board has been computed as on 31.07.2021.

Guddi W/o Sh. Ram Chander is undergoing life imprisonment in case FIR No. 124/2007, U/S 302/201 IPC, P.S. Kanjhawala, Delhi for murdering her husband.

#### The convict has undergone:

Imprisonment of 14 years, 20 days **in actual** and 16 years, 03 months & 04 days **with remission**. She has availed Parole 03 times and Furlough 01 time.

#### **Recommendation by Police:**

The Delhi Police has **strongly opposed** her premature release in its report. Hometown Police has also **not recommended** her premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that her case may be recommended for premature release subject to the recommendation of the concerned district probation officer. Social Welfare Department, Hometown has also recommended her premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case, the convict having no previous criminal history, satisfactory jail conduct for last 5 years, no adverse report during parole/furlough availed, showing reformative attitude etc., the Board unanimously **RECOMMENDS** premature release of convict Guddi W/o Sh. Ram Chander.

# <u>06. KANWAR SINGH @ HADUMAN S/O SH. BIRJU SINGH — AGE-41 YRS.</u>

Kanwar Singh @ Haduman S/o Sh. Birju Singh is undergoing life imprisonment in case FIR No. 395/2007, U/S 302/201/34 IPC, P.S. Punjabi Bagh, Delhi for murder of a person/husband of his co-convict.

# The convict has undergone:

Imprisonment of 14 years, 01 month & 27 days **in actual** and 14 years, 11 months & 28 days **with remission**. He has availed Parole 02 times.

#### **Recommendation by Police:**

The Delhi Police has **strongly opposed** his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted in its report that his case may be considered for premature release.

# **Conclusion:**

After taking into account all the facts and circumstances of the case, the manner in which the offence was committed, perversity, gravity & heinousness of the crime, possibility of committing crime again, the Board unanimously **REJECTS** premature release of convict Kanwar Singh @ Haduman S/o Sh. Birju Singh at this stage.

# <u>07. MEERA DEVI S/O SH. RAJ KUMAR — AGE- 44 YRS.</u>

Meera Devi W/o Raj Kumar is undergoing life imprisonment in case FIR No. 395/2007, U/S 302/201/34 IPC, P.S. Punjabi Bagh, Delhi for murdering her husband.

#### The convict has undergone:

Imprisonment of 14 years, 01 month & 28 days **in actual** and 14 years, 11 months & 14 days **with remission**. She has availed Parole 02 times.

#### **Recommendation by Police:**

The Delhi Police has neither recommended nor opposed her premature release in its report. Hometown Police has **not recommended** her premature release in its report.

#### **Recommendation by Social Welfare Department:**

Report from Social Welfare Department, Delhi has not been received. However, Social Welfare Department, Hometown has **not recommended** her premature release in its report.

#### **Conclusion:**

Imprisonment of 14 years, 25 days **in actual** and 17 years, 02 months & 29 days **with remission**. He has availed Parole 07 times and Furlough 11 times.

#### **Recommendation by Police:**

The Delhi Police has opposed his premature release in its report.

# **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case may be recommended for premature release in its report.

#### 33. CHETAN S/O SH. BHOJI RAM — AGE-41 YRS.

Chetan S/o Sh. Bhoji Ram is undergoing life imprisonment in case FIR No. 571/1997, U/S 376(2)(G)/34 IPC, P.S. Kalyan Puri, Delhi for committing gang rape with a 25 years woman.

#### The convict has undergone:

Imprisonment of 11 years, 06 months & 13 days **in actual** and 14 years, 07 months & 04 days **with remission**. He has availed Parole 04 times and Furlough 13 times.

#### **Recommendation by Police:**

The Delhi Police has **highly opposed** his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that his case is fit for premature release in its report.

#### **Conclusion:**

After taking into account all the facts of the case and circumstances under which the crime was committed i.e. gang rape with a Nepal national lady, gravity and perversity of the crime, high objection by police, possibility of committing crime again etc., the Board unanimously **REJECTS** premature release of convict Chetan S/o Sh. Bhoji Ram at this stage.

#### 34. HARI SINGH S/O SH. GANESHI LAL — AGE-65 YRS.

Hari Singh S/o Sh. Ganeshi Lal is undergoing life imprisonment in case FIR No. 07/1993, U/S 186/353/365/506 (II) IPC & 4 Anti Hijacking Act, P.S. Palam Airport, Delhi for hijacking flight of Indian Airlines.

#### The convict has undergone:

Imprisonment of 13 years, 05 months and 08 days **in actual** and 17 years, 01 month and 10 days **with remission**. He has availed I. Bail 01 time, Parole 10 times and Furlough 14 times.

#### **Recommendation by Police:**

Report from the Delhi Police has not been received. Hometown Police has neither recommended nor opposed his premature release in its report. However, the Special Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that he may be granted benefit of premature release in its report. Report from the Social Welfare Department, Hometown has not been received. However, the Chief Probation Officer, Delhi did not support his premature release in the meeting.

#### **Conclusion:**

After taking into account all the facts of the case and circumstances, the manner in which the crime was committed, gruesome act of hijacking of an Indian Airlines flight, taking the flight to Pakistan and then to Amritsar, gravity of the offence etc., the Board unanimously **REJECTS** premature release of convict Hari Singh S/o Sh. Ganeshi Lal at this stage.

#### 35. MUKESH KUMAR S/O SH. SANWARMAL — AGE-38 YRS.

Mukesh Kumar S/o Sh. Sanwarmal is undergoing life imprisonment in case FIR No. 180/2009, U/S 498A/304B IPC, P.S. Sangam Vihar, Delhi for dowry death.

#### The convict has undergone:

Imprisonment of 12 years, 03 months & 19 days **in actual** and 14 years, 07 months and 06 days **with remission**. He has availed Parole 06 times and Furlough 16 times.

#### **Recommendation by Police:**

Report from the Delhi Police has not been received. However, the Special Commissioner of Delhi Police (Crime) has **opposed** his premature release in the meeting.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has neither recommended nor opposed his premature release in its report. However, the Chief Probation Officer did **not support** his premature release in the meeting.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the manner in which the offence was committed, perversity and inhuman treatment with the victim/deceased which compelled her to end her life etc., the Board unanimously **REJECTS** premature release of convict Mukesh Kumar S/o Sh. Sanwarmal at this stage.

## 36. RAJIV KUMAR SINGHAL S/O SH. HARIHAR SINGH — AGE-55 YRS.

Rajiv Kumar Singhal S/o Sh. Harihar Singh is undergoing life imprisonment in case FIR No. 341/1996, U/S 304-B/498-A IPC, P.S. Kalyan Puri, Delhi for dowry death.

#### The convict has undergone:

Imprisonment of 11 years, 07 months & 04 days **in actual** and 14 years, 03 months & 13 days **with remission**. He has availed Parole 03 times and Furlough 02 times.

#### **Recommendation by Police:**

The Delhi Police has **highly opposed** his premature release in its report. Hometown Police report has not been received.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has neither recommended nor opposed his premature release in its report. Report from the Social Welfare Department, Hometown, has not been received.

#### **Conclusion:**

After taking into account all the facts and circumstances of the case i.e. the manner in which the offence was committed, perversity and inhuman treatment with the victim/deceased which compelled her to end her life etc., the Board unanimously **REJECTS** premature release of convict Rajiv Kumar Singhal S/o Sh. Harihar Singh at this stage.

# FRESH CASE COVERED UNDER THE STATE OF HARYANA V/s JAGDISH (Case No. 37)

## 37. RAMA SHANKAR S/O SH. BHAGWATI PRASAD @ BHABHOOTI — AGE-46 YRS.

Rama Shankar S/o Sh. Bhagwati Prasad @ Bhabhooti is undergoing life imprisonment in case FIR No. 697/1997, U/S 302/498-A/34 IPC, P.S. Nangloi, Delhi for murdering his wife for demand of dowry.

#### The convict has undergone:

Imprisonment of 14 years, 01 month and 08 days **in actual** and 18 years, 11 months and 09 days **with remission**. He has availed Parole 06 times and Furlough 17 times.

#### **Recommendation by Police:**

The Delhi Police has **strongly opposed** his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that the convict may be granted premature release in its report.

#### **Conclusion:**

After taking into account all the facts and circumstances under which the crime was committed i.e. murder of his wife for demand of dowry, gravity and perversity of the crime, strong objection by police etc., the Board unanimously **REJECTS** the premature release of convict Rama Shankar S/o Sh. Bhagwati Prasad @ Bhabhooti at this stage.

# CASES OF LAST MEETING DATED 25.06.2021 WHICH WERE DIRECTED TO BE PLACED IN THE NEXT MEETING BY HON'BLE L.G. COVERED UNDER RULE 1251 OF DELHI PRISON RULES, 2018 (INVESTIGATED BY C.B.I.)

## 38. KARTIK SUBRAMANIAM S/O SH. SUBBAIR KRISHNAN — AGE-45 YRS.

Kartik Subramaniam S/o Subbair Krishnan is undergoing life imprisonment in case RC No. SIB/2001-E-0004, SC No. 1/2001, U/S 120-B r/w 364-A & 364-A r/w 120-B IPC, P.S. CBI/SPE/SIU-VIII/New Delhi, CBI Vs Rakesh Saraha & Others, for kidnapping of a person for ransom.

#### The convict has undergone:

Imprisonment of 20 years, 12 days **in actual** and 27 years, 11 days **with remission.** He has availed I.Bail 04 times, Parole 15 times and Furlough 14 times.

#### **Recommendation by Police:**

The Police/CBI has opposed his premature release in its report. However, Hometown Police has **no objection** to his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that the convict may be **granted premature release** in its report. The Social Welfare Department, Hometown has neither recommended nor opposed his premature release in its report.

#### **Conclusion:**

The present case of the convict Kartik Subramaniam S/o Subbair Krishnan has been placed before this Board seven times (excluding present Board) since 06.01.2016, out of which his case has been recommended for premature release 04 times by the Board. Every time, thereafter, the case was forwarded to the MHA, Govt. of India, it being a case investigated by CBI, in view of section

435 of Cr.P.C., 1973. Each time MHA has conveyed the decision that the Competent Authority has not accorded concurrence of Central Government u/s 435 Cr.P.C. for premature release of the convict. In the last meeting dated 25.06.2021 also the case of convict was recommended by the Board, on which the Hon'ble Lieutenant Governor has directed to place the case again in the next meeting i.e. the present meeting of the Board along with changed facts and circumstances which merit his reconsideration by MHA. Accordingly all the relevant facts and circumstances of the case are once again examined and the Board observed the following about this case:

'consistent satisfactory jail conduct, having shown good aptitude for reforms, his lodgment in semi open jail, academic performance in prison, satisfactory work performance as Sahayak/Sewadar in Bakery unit of Jail Factory, no adverse report of misusing the interim bail/parole/furlough/emergency parole till date, longevity of incarceration being now more than 20 years of actual sentence and 27 years including remission.'

In view of the above observations, specially noting the fact that the actual sentence undergone is more than 20 years now, with consistent good conduct inside as well as outside the prison, the Board once again unanimously **RECOMMENDS** premature release of convict Kartik Subramaniam S/o Subbair Krishnan subject to consultation with Central Government (CBI/MHA), in view of section 435 of Cr.P.C., 1973, being CBI case.

That the present case will be forwarded separately by Home Department, Govt. of NCT of Delhi, first to MHA, Govt. of India for their necessary concurrence/consultation before placing the case before the Hon'ble Lieutenant Governor.

#### 39. RAKESH SARAHA S/O SH. RAGHUBIR SINGH — AGE-45 YRS.

Rakesh Saraha S/o Sh. Raghubir Singh is undergoing life imprisonment in case RC No. SIB/2001-E-0004, SC No. 1/2001, U/S 120-B r/w 364-A & 364-A r/w 120-B IPC, P.S. CBI/SPE/SIU-VIII/New Delhi, CBI Vs. Rakesh Saraha & Others, for kidnapping of a person for ransom.

#### The convict has undergone:

Imprisonment of 20 years, 04 months & 05 days **in actual** and 26 years, 01 day **with remission.** He has availed Parole 10 times and Furlough 16 times.

#### **Recommendation by Police:**

The Police/CBI has opposed his premature release in its report. The Hometown Police has not recommended his premature release in its report.

#### **Recommendation by Social Welfare Department:**

The Social Welfare Department, Delhi has submitted that the convict may be **granted premature release** in its report. Report from the Social Welfare Department, Hometown has not been received.

#### **Conclusion:**

The present case of the convict Rakesh Saraha S/o Sh. Raghubir Singh has been placed before this Board seven times (excluding present Board) since 06.01.2016, out of which his case has been recommended for premature release 04 times by the Board. Every time, thereafter, the case was forwarded to the MHA, Govt. of India, it being a case investigated by CBI, in view of section 435 of Cr.P.C., 1973. Each time MHA has conveyed the decision that the Competent Authority has not accorded concurrence of Central Government u/s 435 Cr.P.C. for premature release of the convict. In the last meeting dated 25.06.2021 also the case of convict was recommended by the Board, on which the

Hon'ble Lieutenant Governor has directed to place the case again in the next meeting i.e. the present meeting of the Board along with changed facts and circumstances which merit his reconsideration by MHA. Accordingly all the relevant facts and circumstances of the case are once again examined and the Board observed the following about this case:

'consistent satisfactory jail conduct, having shown good aptitude for reforms, satisfactory work performance as Sahayak/Sewadar in Bakery unit of Jail Factory, no adverse report of misusing the parole/furlough/emergency parole till date, longevity of incarceration being now more than 20 years of actual sentence and 26 years including remission.'

In view of the above observations, specially noting the fact that the actual sentence undergone is more than 20 years now, with consistent good conduct inside as well as outside the prison, the Board once again unanimously **RECOMMENDS** premature release of convict Rakesh Saraha S/o Sh. Raghubir Singh **subject to consultation with Central Government (CBI/MHA), in view of section 435 of Cr.P.C., 1973, being CBI case.** 

That the present case will be forwarded separately by Home Department, Govt. of NCT of Delhi, first to MHA, Govt. of India for their necessary concurrence/consultation before placing the case before the Hon'ble Lieutenant Governor.

Thus, as discussed above, out of the 39 cases (37 fresh cases and 02 reconsideration cases) placed before the Sentence Review Board, 14 cases including **02** CBI cases have been **recommended** for premature release and 25 cases have been rejected. The 02 CBI cases recommended by the Board will be forwarded separately by Home Department, Govt. of NCT of Delhi, first to MHA, Govt. of India for their necessary concurrence/consultation before placing the said cases to the Hon'ble Lieutenant Governor.
