Parole/Furlough Guidelines Amendment 2014

The Lt. Governor of GNCT of Delhi has approved the following amendments in guidelines to be followed in the matter of Parole/Furlough. These amendments will take place with immediate effect.

- i.) Para 9.4- The Word "if there is no other family member to take care of spouse" may be treated as deleted.
- ii.) Para 11-5- The following may be added in the existing Para:-

"In Emergent Circumstances Parole may be considered even if minimum period of six months has not lapsed from the date of termination of previous parole. The "Emergent Circumstances" will include delivery of a child by the wife of the convict, death of a family member, marriage of children, terminal illness of family member and natural calamities."

This issues with the approval of Competent Authority.




