ORDER

In suppression of all previous orders regarding lodgment of prisoners in Tihar Jails and District Jail Rohini, the Competent Authority is pleased to order the following lodgments of prisoners (other than High Security prisoners, Special Security prisoners and such other prisoners where lodgment is fixed by a general or special order in this regard) in Delhi Prisons in terms of Rule 3 of Delhi Prisons (transfer of Prisoners, labour and Jail industry, food, clothing and sanitation) Rules, 1988:-

Jail No.1	All prisoners whose name start with alphabet 'S' & 'Y' and Blood Relation. All detenues except NSA.
Jail No.2	All convicts sentenced to 10 years and above. All detenues under NSA, PSA and Civil prisoners.
Jail No.3	All prisoners whose name start with alphabet B, V, C, D, E, F & G
Jail No.4	All prisoners whose name start with alphabet A, & 'R'
Jail No.5	All convicts sentenced less than 10 years
Jail No.6	All female prisoners
Jail No.7	All adolescent prisoners whose age group is 18 to 20 years. Such prisoners shall be shifted to their respective jails as per this schedule of lodgement on completion of 21 years of age.
Jail No.8/9	All prisoners whose name start with J & Z and I, M & N.
District Jail, Rohini	All prisoners whose name start with alphabet H, I, K, Q, O, P, T, U & W.

2. While determining the name alphabet of a person for lodgment such prefixes like Kumar, Mohd., Abdul, Sayyed etc. shall not be taken into account.

3. This order shall come into force w.e.f. 25.12.2014 in respect of lodgments. The inter jail shifting should be done under the escort of DAP.

All Jail Superintendents are hereby directed to comply with the above instructions scrupulously and without fail.
