ORDER

This order will dispose of appeal dated 18.02.2014 of Sh. Kanodia Om Prakash. Brief facts of the case are as follows:-

On 30.08.2013, Kanodia Om Prakash filed an application under RTI Act before PIO, CJ-4 seeking following information:-

- 1. Whether the inmate Raj Kumar has been assign the duties of beating the fellow inmates, fracturing their hands, breaking their heads and extort money from them even since he is lodged in Central Jail No.4. Further, how much money does he pay to Asstt. Supdt., Sh. Mahender.
- 2. Copy of his complete punishment record from 17.09.2012.
- Copy of his complete MLC record.
- 4. How many times Kanodia Om Prakash was beaten and name of the person and his complete punishment record who assaulted Kanodia.
- 5. How many inmates suffered injuries in the form of fracture and injuries to head and also regarding the instance of submerging in the water by inmate Raj Kumar? Give complete record.
- 6. How may inmates were found involved in the possession of narcotics like Charas, Ganja and Tobacco and what action was taken against them by the Administration.
- 7. How much milk is bought by Delhi Prison, at what rate and name of the supplier? Give the Complete Record.
- 8. How much milk is supplied to Central Jail No.4? Under which rule/provision 300 ml. of milk instead of 400 ml. is provided to an inmate.

PIO, CJ-4 did not supply information to the applicant within the prescribed time limit even after his repeated request. Applicant filed an appeal before 1st Appellate Authority against non receipt of reply. Comments were called from PIO, CJ-4 on the appeal, but PIO, CJ-4 sent reply to the applicant directly vide letter dated 19.03.2014 after the due date.

Further, it is noticed that information has been supplied by PIO after filing of appeal. For information at SI. no.3 of application, same should have been transferred to PIO, CJ-3, but PIO, CJ-4 failed to do so. He is now directed to obtain the same from PIO, CJ-3 and provide to the appellant within seven working days.

PIO, CJ-4 is further directed to be more careful in future for timely supply of information and transfer of application on time.

Sh. Kanodia Om Prakash, is further informed that this order can be appealed under the clause 19(3) (1) of Right to Information Act within ninety days from the date of receipt of this letter before Central Information Commission, Old J.N.U. Campus, Block-IV, 5th Floor, New Delhi.
