ORDER

In exercise of the powers conferred by section 432 of the Code of Criminal Procedure, 1973(2 of 1974) read with the Government of India, Ministry of Home Affairs, New Delhi Notification No. U-11011/2/74-UTL(i) dated the 20th March, 1974, the Lt. Governor of the National Capital Territory of Delhi is pleased to remit the un-expired portion of the Sentence of the following **25 (twenty five)** convicts on the recommendations of the Sentence Reviewing Board in its meeting held on 26.07.2018, subject to the condition that they shall execute personal bond in the sum of Rs.10,000/- (Rupees Ten Thousand only) to the satisfaction of the concerned Jail Superintendent Delhi for keeping good behaviour and maintaining peace during the unexpired portion of their sentence i.e. up to the period mentioned against each :-
