Further, the promotion order in respect of Sh. Anil Kumar Upreti, HW- 589 (Srty. No. 277) shall be issued after 16.06.2020 subject to Vigilance Clearance on the day of issue of order.

Their inter-se-seniority on promotion shall be the same as their relative seniority in the lower grade from which they are promoted.

The officials promoted may exercise option for fixation of pay in terms of FR 22 I (a) (i) within one month from the date of joining as Head Warder. However, the officials who have already been granted financial upgradation under Assured Career Progression Scheme/ Modified Assured Career Progression Scheme are not entitled for any fixation benefits now.




