**Terms & Condition**

1. **Bid Security:** Each interested party shall have to deposit interest free **Bid Security** (Earnest Money Deposit : **EMD** as per following schedule in the form of account payees demand draft or fixed deposit receipt or bank guarantee drawn on any scheduled bank in favour of the “**DDO Central Jail Tihar**” before start of the auction/sale process:-

3. **Refund of Bid Security :** The Bid Security received from unsuccessful bidder will be refunded after completion of auction procedure and latest on or before the 30<sup>th</sup> day after the award of contract.

4. **Physical checking of the sample of the items** : The samples of the auction items can be inspected at the Central Jail Factory, Central Jail No.2, Tihar, New Delhi-110064 on **06/08/2018** between 11.00am to 4.00pm.
5. **Validity of contract/term**: The validity of the Auction Contract awarded to the successful bidder shall be for **one year from the date of award of contract**, which can be extended for three months on deserving cases at the sole discretion of the D.G. (Prison) on the same rate, terms and conditions.
6. The goods shall be sold by auction on **"as is where is"** basis.
7. The quantity prescribed in the auction documents is tentative and can be increased/decreased upto 50% of the actual quantity as demanded by Prison Department, depending upon necessity/requirement. The lifting of the item(s) will have to be made strictly as per the schedule given in lifting order issued from time to time by the prison department.
8. **Taxes and Statutory Obligation**: The qualified bidder/contractor will have to pay the taxes (Sales Tax/ DVAT/GST/Excise etc.) as applicable in the State and comply with the terms, rules and regulations as imposed for statutory obligation in the State/Country.
9. The qualified bidder/contractor will have to arrange transport and labour himself and expenses involved in this process will be borne by him/them. The contractor will ensure entry of commercial vehicle/ truck deputed for lifting of material from Central Jail Factory, CJ-2 well before 3.00pm on any working day. Such vehicle will not be permitted entry after 3.00pm.
10. **Performance Security Deposits**: The qualified bidder/contractor will have to deposit performance security **@25%** of the total value of the item(s) in the form of Fixed Deposit Receipt or Bank Guarantee from any scheduled bank in drawn in favour of the **"DDO Central Jail Tihar"** within one week from the issuance of letter of award of contract, failing which the Bid Security/E.M.D. of the party/bidder shall be forfeited without giving the intimation/notice. The performance security should remain valid for a period of **ninety-days** beyond the date of completion of all contractual obligations. Performance security money will be released by the banker strictly subject to NOC issued by the Prison Department after successful completion of all the contractual obligations by the bidder/contractor. The performance security money shall remain with the Jail authorities till completion of the contract or till extended term. The bidder shall not be entitled for any interest from the Jail Department for the said Performance Security Deposits.
11. The Bid/Performance Security will be forfeited if qualified bidder/contractor becomes the defaulter or fails to comply with contractual obligations/terms & conditions. In case the highest qualified bidder/contractor is not in a position to lift full or part of the quantity of the auction material as per lifting order issued by Delhi Prison Department, the remaining quantity as far as possible will be ordered to the next responsive bidder at the rates & terms and conditions offered by highest bidder. The prison administration shall obtain the written consent of the next higher responsive bidder to lift the item at the approved rates/terms of the highest bidder at the time of finalization of tender.
12. The qualified bidder/contractor will have to deposit the total **sale proceeds in advance** in the form of account payee's demand draft drawn by any scheduled bank before lifting the material from Jail Factory, CJ-2, Tihar.
13. The successful bidder shall begin lifting of material from Jail Factory and will be bound to complete the lifting of minimum items within the prescribed time of issuance of lifting order. If the contractor fails to lift the material from Jail Factory as per terms and conditions, a **penalty @2.5%** of the value of the item involved in delay lifting per week subject to maximum duration of 10 weeks shall be levied for the period till the material is lifted by the successful bidder. The Jail Department reserves the right for cancellation of contract in case of violation of this term beyond the penalty limits. Further, the action will be initiated for **re-sale of the goods** in question in the open market at the risk and cost of the defaulter.

14. That the qualified contractor will ensure that none of his employee including driver, cleaner, helper etc. carry any prohibited articles/items like fire-arms, explosives, explosive substances, sharp edged weapons, tobacco, biri, cigarettes, drugs, narcotic substances, liquor, currency notes of any country, gold or diamond-jewelry, mobile phone, batteries, mobile phone charger, sim-card, memory-card, pen-drive, unauthorized CD/DVD. In case any such item is caught, the concerned person will be held responsible and will be handed over to local police for prosecution. This act will entail cancellation of contract, forfeiture of security deposits and also would be black-listed or debarred.
15. The DG (Prisons) reserves the right to accept/ reject or cancel any bid without assigning any reasons thereof.
16. In case of dispute, not resolved amicably, shall be referred to the arbitrator appointed by the DG (P). The decision of DG (Prisons) shall be final and binding upon the party(s).
17. All disputes shall be subject to Jurisdiction of Delhi Courts
